## Fifty-seventh Legislative Assembly

Bismarck, March 30, 2001

The House convened at 12:30 p.m., with Speaker Bernstein presiding.

The prayer was offered by Pastor Wilfred Hanson, Vice-Pastor at Trinity Lutheran in Turtle Lake.

The roll was called and all members were present except Representatives Nelson and Nicholas.

A quorum was declared by the Speaker.

**POINT OF PERSONAL PRIVILEGE**

**REP. CLEARY:** Mr. Speaker: I rise on a point of personal privilege and request that my remarks be printed in the Journal.

**REQUEST**

**REP. CLEARY REQUESTED** that her remarks be printed in the Journal, which request was granted.

March is Women's History Month. As we near the end of the month I would like to call your attention to the fact that this is the 82nd anniversary of the passing of the 19th Amendment giving women the right to vote. Many in the massive grassroots movement for women suffrage are remembered by name -- Susan B. Anthony, Victoria Woodhull, Lucretia Mott, Elizabeth Cady Stanton and Sojourner Truth, but most are not. Yet it was the determination of tens of thousands of ordinary women that finally led to the ratification of the 19th Amendment.

Minnie Craig and Nellie Daugherty led the way for women in the ND Legislature. Minnie Craig became the first woman speaker of the House in 1933 -- she was the first woman speaker in any state. In 1923, Nellie Daugherty introduced the first bill by a woman. It was the first bill to address drunken driving. Many of us remember Brynhild Haugland and her 52 years of service in the House of Representatives. Agnes Geelan was the first woman Senator in 1950, and 50 years after Minnie Craig, Tish Kelly was elected Speaker of the House. Brynhild Haugland commented "A woman Speaker every 50 years isn't too much to expect."

Very slowly we've made progress in electing more women to the Legislature in ND. Let us pause a moment to remember all those who have worked for rights, equality and justice, especially those early women who fought so hard for the right of women to vote. And let us never take this lightly.

Tomorrow, March 31, marks the 196th anniversary of the first letter to be posted from North Dakota. On that day, as today, the weather was warming, the ice on the Missouri was breaking up and the keelboat was preparing to return to St. Louis. Meriwether Lewis wrote one last letter to his mother from a site a few miles north of here.

He wrote: "I must request of you before I conclude this letter, to send my brother John Markes to the college at Williamsburg as soon as it shall be thought that his education as been sufficiently advanced to fit him for that school; for you may rest assured that as you regard his future prosperity you had better make any sacrifice of his property than suffer his education to be neglected or remain incomplete."

We, here in this place as Lewis in his, have education on our mind. In the coming days we will make fundamental decisions that will determine if a new generation of our brightest and best will become teachers or leave for greener fields.

We will decide if our colleges and universities educate well-rounded individuals capable of advancing the human condition in a liberal democracy or become trade schools for white collar workers.

We, here in our time as Lewis in his, face an uncertain future. The boat that would take us back has left and we have no choice but to go forward into an unknowable future, armed with courage, curiosity, and intelligence. We, like Lewis will carry with us the best scientific knowledge and instruments of our day. We will see wonders we could not have imagined and face dangers that could destroy us.

Along the way, we will learn to rely on people who are strange to us, with different color skin ... different customs and cultures. From each other we will learn not merely to survive but to grow and prosper.

Mr. Speaker, Members of the Assembly. The weather is warming, the ice is breaking up and we are restless to be on our way. But before we go, let us here, in our time remember the importance of education. Let us here in our time embark on our Voyage of Discovery.

- Increases the total annual ethanol incentive payments that may be paid to an ethanol plant that produced 15 million gallons or more in the previous fiscal year and to a new ethanol plant from a total of \$400,000 to a total of \$500,000.
- Reduces the total annual ethanol incentive payments that may be paid to an ethanol plant that has production capacity of fewer than 15 million gallons from \$850,000 to \$750,000.
- Removes the provision that ethanol produced in North Dakota must be sold in North Dakota to qualify for an ethanol incentive payment.
- Removes provisions added by the Senate that in order to be eligible for ethanol incentives during the 2001-03 biennium, an ethanol plant must notify the Agricultural Products Utilization Commission by October 1, 2001, of the plant's intention to request ethanol incentives during the 2001-03 biennium.

This amendment makes the following additional funding changes to the Senate version:

- Removes \$100,000 from the general fund provided for the Economic Development Foundation.
- Removes \$40,000 from the general fund added to the Economic Development Division for marketing.
- Removes \$50,000 from the general fund added to the Economic Development Division for grants.
- Restores the \$40,000 from the general fund removed from the Community Services Division relating to renaissance zone program administration.
- Restores \$191,287, of which \$130,703 is from the general fund and 2 FTE positions to the Economic Development and Finance Division that were transferred to the Workforce Development Division.
- Removes \$50,000 from the general fund added for operating expenses of the Workforce Development Division.

- Removes \$25,000 from the general fund added for equipment of the Workforce Development Division.
- Removes \$675,000 from the general fund added for grants of the Workforce Development Division.

- The section providing that the Legislative Council monitor the establishment of the Department of Commerce during the 2001-02 interim.
