REMARKS OF CARRIE HABERSTROH, MISS NORTH DAKOTA

Thank you Mr. President and members of the Senate. I would also like to thank Senator Heitkamp for inviting me here today. It is truly an honor to speak to you and it has been an incredible honor to represent the great state of North Dakota. I have enjoyed the opportunity to return to North Dakota and to travel throughout, speaking to many schools and community organizations.

I speak about Alzheimer's disease and also about my experiences growing up, in a speech entitled "A Will and A Way." As a girl I was overweight, quiet, and very introverted, but I managed to turn that around. I became very active in different organizations and athletics. I worked hard to achieve my five-year goal of winning the state discus title. My activities and achievements opened the door to Harvard and other Ivy League schools--opportunities I had

never dreamed of. So I encourage kids to reach for their dreams and avoid putting limits on what they can achieve.

I have really enjoyed my education at Harvard. I have learned a lot. But the person I am, my ideals, morals, and my work ethic are still very much a product of this state.

I am also an accurate representative being half German, a quarter Swedish, and a quarter Norwegian. I had the wonderful opportunity to visit Norway as an Ambassador this summer on a two-month exchange program there. It was really an incredible learning experience. So traveling abroad and meeting students from all over the world has really helped me to realize how fortunate I am to have grown up in this state. I am really impressed with students around the state as well. During my speeches, I ask the kids--what would you like to be when you grow up? I get this wide range of answers--from microbiologists, paleontologists, farmers, and meat cutters. I said, "A butcher?" "No, a meat cutter." I remember one preschool boy last week said he wanted to be a power ranger. The kid next to him slugged him and said there are no power rangers in North Dakota. There aren't any power rangers in North Dakota, but this state is full of many heroes--in the school systems, in our communities, and there are many right here in this room.

I have realized one really unique aspect of this state is the North Dakota networking, and how no matter where I travel people know people from my hometown that are relatives. I even experienced this at the Miss America Pageant in Atlantic City, New Jersey. I was in the Boardwalk Parade and I was wearing a costume that was supposed to represent my state. So I wore a white fake fur jacket and white fur-topped boots and there was a giant thermometer on the side reading about 40 below. All along this six-mile parade route it was crowded with people, and every so often I would hear a person yell--"Fargo" or "Bismarck" or "Minot." I would look and wave at them and there was this gleam in their eyes like--I know someone there, I've been there. I thought to myself later, I bet Miss Florida doesn't ride this parade and hear "Miami" and turn and wave, but that is something really special about this state. Being a contestant at the Miss America Pageant was really memorable and an exciting experience.

I have also enjoyed the opportunity to speak about Alzheimer's disease, my national platform issue. My grandmother has had this disease for about 12 years now, and she is in the very late stages. When I was a little girl, Mom told me that Grandma has a disease where she forgets things. I could understand when she forgot where her jacket was or wherever she was going the next day, but it was really hard for me to understand why she didn't recognize me and she didn't know my name. So I try to explain this to kids and try to help them understand it better. This summer I went to Washington, D.C., and spoke with a head advocate for Alzheimer's disease. He told me about the latest advancements and also about a rural initiative program. This is currently in Minnesota and several rural states, they are hoping to bring it here. It is about bringing information and resources to people in rural areas, and this is especially helpful. Seventy percent of all people with Alzheimer's disease are cared for in the home, and so bringing information and conference calls and technologies like this to those people is really helpful, to help them to understand the disease and how they can take care of these people. It is sad to think of how hard my grandparents worked to provide for their children and themselves. Now their life savings is vanishing at \$6,000 a month to cover my grandmother's nursing home care. This isn't a small problem, currently there are 4 million people in the nation who have Alzheimer's disease, this is projected to be 14 million in a matter of decades. We are very hopeful that a vaccine will be achieved within about 10 years. That really depends, how soon or how late we get it, on the funding and support provided. So I just ask you to keep the victims of Alzheimer's disease and their families in your hearts when you deal with bills related to this issue.

I appreciate your time. This has truly been a great honor, and as the Norwegians would say "tusen takk," a thousand thanks.

REPORT OF STANDING COMMITTEE

SB 2052: Education Committee (Sen. Freborg, Chairman) recommends **AMENDMENTS AS FOLLOWS** and when so amended, recommends **DO PASS** (4 YEAS, 3 NAYS, 0 ABSENT AND NOT VOTING). SB 2052 was placed on the Sixth order on the calendar.

Page 1, line 1, after "A BILL" replace the remainder of the bill with "for an Act to amend and reenact section 15-40.1-09 and subsection 1 of section 15.1-06-04 of the North Dakota Century Code or in the alternative to amend and reenact section 15.1-27-35 of the North Dakota Century Code, relating to professional development days.

BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

SECTION 1. AMENDMENT. If House Bill No. 1045 does not become effective, section 15-40.1-09 of the 1999 Supplement to the North Dakota Century Code is amended and reenacted as follows:

15-40.1-09. Application for payments - Verification and determination of payments for high school students - Report of county superintendent of schools - Appeal. Immediately upon the completion of the registration of students at the beginning of each school term and in no event later than September tenth of each year, the business manager of each school district within or without this state which is claiming payments from state funds under the provisions of this chapter shall file with the county superintendent of schools a claim on a form prescribed by the superintendent of public instruction stating the number of students registered in high school and elementary grades for which payments are claimed, and such other information as may be reasonably requested by the superintendent of public instruction. Not later than December first, the superintendent of public instruction shall certify to the office of management and budget a list of the school districts and schools not operated by school districts entitled to payments from state funds, together with the amounts to which the several districts and schools are entitled. Per student aid as provided under sections 15-40.1-06, 15-40.1-07, and 15-40.1-08 must be computed on the basis of the previous year's average daily membership less the number of students attending school during the current school year in another district under the provisions of open enrollment or the current year's fall enrollment, whichever provides the greatest payment, for all current grade levels. Adjustments must be made in the subsequent year according to a comparison between the average daily membership for the year for which the adjusted payment is being made and the year preceding the year for which the adjusted payment is being made, whichever is greater, for grade levels that existed

in both years. The greater of the two preceding years' average daily membership must be used in computing any adjustment in a district's foundation aid payments. For purposes of this chapter, "average daily membership" means the total days all students in a given school are in attendance, including ~~two~~ five days ~~set aside for the North Dakota education association instructional conference, three holidays listed in subsections 2 through 10 of section 15.1-38-04.1~~ which have been selected by the school board in consultation with the teachers for holidays, continuing education activities, and school activities, and up to two full days during which parent-teacher conferences are held, divided by one hundred eighty days. School districts educating children of agricultural migratory workers or offering high school summer school programs during the months of June, July, and August shall not be restricted to payments for a one hundred eighty-day school term.

Immediately upon the termination of the school year, and in no event later than July fifteenth of each year, the business manager of each school district within or without this state which has received payments from state funds under the provisions of this chapter shall file with the county superintendent of schools a verified statement of the name, residence, and membership of elementary and high school students as provided for in this section, and number of units of high school work taken by each high school student enrolled during the previous school year. The statement shall be attested to by the county superintendent of schools. The county superintendent shall investigate the validity of the statement and shall determine the residence and other qualifications of each student named in the statement. The county superintendent shall certify to the superintendent of public instruction on or before September first of each year the number of enrolled students in each district in the county for the previous school year upon which any adjustment may be based as provided in this section. If any statement is disallowed in whole or in part, notice of the disallowance and the names of students who are disallowed shall be reported to the superintendent of public instruction and to the district filing the statement. Any district may appeal to the superintendent of public instruction from the determination of the county superintendent of schools on or before September fifteenth in the year in which the determination is made. The superintendent of public instruction may change or modify the determination of the county superintendent if the evidence submitted by the district warrants a modification. The judgment of the superintendent of public instruction shall be final.

SECTION 2. AMENDMENT. Subsection 1 of section 15.1-06-04 of the 1999 Supplement to the North Dakota Century Code is amended and reenacted as follows:

1. During each school year, a school district shall provide for a school calendar of at least one hundred eighty days, apportioned as follows:
 - a. One hundred seventy-three full days of instruction;
 - b. ~~Three holidays listed in subdivisions b through j of subsection 1 of section 15.1-06-02 and~~ Five days selected by the school board in consultation with district teachers;
 - e. ~~Two days for the attendance of teachers at the North Dakota education association instructional conference~~ for holidays, continuing education activities, and school activities; and

SECTION 3. AMENDMENT. Section 15.1-27-35 of the North Dakota Century Code as created by House Bill No. 1045, as approved by the fifty-seventh legislative assembly, is amended and reenacted as follows:

15.1-27-35. Average daily membership - Calculation. Average daily membership is calculated by adding the total number of days that each student in a given classroom, school, or school district is in attendance during a school calendar and the total number of days that each student in a given classroom, school, or school district is absent during a school calendar, and then dividing the sum by one hundred eighty. For purposes of calculating average daily membership, all students are deemed to be in attendance on:

1. The ~~three holidays listed in subdivisions b through j of subsection 1 of section 15.1-06-02 and~~ five days selected by the school board in

consultation with district teachers for holidays, continuing education activities, and school activities; and

2. ~~The two days set aside for the attendance of teachers at the North Dakota education association instructional conference; and~~
3. The two full days, or portions thereof, during which parent-teacher conferences are held or which are deemed by the board of the district to be compensatory time for parent-teacher conferences held outside regular school hours."
