21 contiguous. To be valid, the contract must be approved by the superintendent of public
22 instruction and by a majority of the qualified electors residing in the district.
- 23 —~~2.~~— In assessing the contract, the superintendent shall consider the district's enrollment,
24 its valuation, and its longevity.
- 25 —~~3.~~— If the superintendent approves the contract, the board shall submit the contract to the

13 c. Provide information identifying the property tax savings provided by the state of

15 "legislative tax relief" and identifies the dollar amount of property tax savings
16 realized by the taxpayer under chapter 15.1-27. For purposes of this subdivision,
17 legislative tax relief is determined by multiplying the taxable value for the taxable
18 year for each parcel shown on the tax statement by the number of mills of mill

27 1. A school district is entitled to a one-time supplemental assistance payment if:

29 school district in a cooperative agreement approved by the superintendent of
30 public instruction;

- 1 b. At the conclusion of the 2012-13 school year, the school district with which it
- 2 cooperated became part of a reorganized district; and
- 3 c. Students who resided in the school district and who attended school in one of the

- 6 2. The supplemental assistance payment to which a school district is entitled under this
- 7 section must be based on the number of its resident students in average daily

- 10 and that enrolled in their school district of residence for the 2013-14 school year. That
- 11 number, as determined by the superintendent of public instruction, must be multiplied

23 **SECTION 37. LEGISLATIVE MANAGEMENT STUDY - FUNDING OF EDUCATION -**
24 **ACCOUNTABILITY - COMMITTEE ESTABLISHMENT.**

- 25 1. The legislative management shall appoint a committee to examine and clarify
- 26 state-level and local-level responsibility for the equitable and adequate funding of
- 27 elementary and secondary education in this state.
- 28 2. The committee shall:
 - 29 a. Define what constitutes "education" for purposes of meeting the state's
 - 30 constitutional requirements;

- 1 b. Examine the distribution of financial and managerial responsibility for
- 2 transportation, athletics and activities, course offerings beyond those that are
- 3 statutorily required, and other nonmandatory offerings and services;
- 4 c. Examine the distribution of financial and managerial responsibility for school
- 5 construction;
- 6 d. Examine the organizational structure for educational delivery in this state, in light
- 7 of demographic changes, to ensure effectiveness and efficiency;
- 8 e. Examine the benefits and detriments of statutorily limiting school districts in their
- 9 ability to generate and expend property tax dollars; and
- 10 f. Define what constitutes "adequacy" for purposes of funding education.
- 11 3. The committee shall:
- 12 a. Examine concepts of accountability in elementary and secondary education;
- 13 b. Examine the performance of North Dakota students in state and national
- 14 assessments to determine whether recent legislative efforts have effected
- 15 measurable improvements in student achievement; and
- 16 c. Examine high school curricular requirements, content standards, and teacher
- 17 training and qualifications to determine whether North Dakota students are being
- 18 adequately prepared for the various assessments and for their first year of
- 19 enrollment in institutions of higher education.
- 20 4. The committee shall examine the effectiveness of teacher, principal, and
- 21 superintendent evaluation systems.
- 22 5. The legislative management shall report its findings and recommendations, together
- 23 with any legislation required to implement the recommendations, to the sixty-fourth
- 24 legislative assembly.

25 **SECTION 38. APPROPRIATION.** There is appropriated out of any moneys in the general
26 fund in the state treasury, not otherwise appropriated, the sum of \$100,000, or so much of the
27 sum as may be necessary, to the legislative council for the purpose of contracting with
28 consultants and other personnel necessary to complete the study of education funding and
29 accountability, for the biennium beginning July 1, 2013, and ending June 30, 2015.

30 **SECTION 39. SCHOOL CONSTRUCTION LOANS - UNCOMMITTED MONEYS -**
31 **ADDITIONAL PURPOSES.** Notwithstanding section 15.1-36-02, if as of December 31, 2014,

1 any portion of the \$150,000,000 referenced in subdivision b of subsection 1 of section
2 15.1-36-02 remains uncommitted for the purpose of providing school construction loans, the
3 state board of university and school lands may authorize up to \$50,000,000 of the uncommitted
4 amount for the purpose of providing medical facility infrastructure loans in accordance with
5 Reengrossed Senate Bill No. 2187, as enacted by the sixty-third legislative assembly.

6 **SECTION 40. AUTISM SPECTRUM DISORDER - TECHNOLOGY GRANT - TRANSFER.**

- 7 1. During the 2014-15 school year, the department of career and technical education
8 shall provide a grant to an institution implementing a certificate program that prepares
9 individuals with autism spectrum disorder for employment in the technology sector.
- 10 2. The amount of the grant must be determined by multiplying the per student payment
11 rate established in subdivision b of subsection 3 of section 15.1-27-04.1 by the
12 number of students that completed the program, up to a maximum of thirty students.
- 13 3. The grant recipient shall provide a report to the legislative management regarding
14 program graduates who found employment in the technology sector, their starting
15 salaries, and their total compensation.
- 16 4. Notwithstanding section 15.1-27-22.1, if any moneys remain in the grants - state
17 school aid line item after the superintendent of public instruction complies with all
18 statutory payment obligations imposed for the 2011-13 biennium, the superintendent
19 may transfer \$250,000, or so much of that amount as may be necessary, to the
20 department of career and technical education, to provide the autism spectrum disorder
21 grant required by this section.

22 **SECTION 41. SUSPENSION.** Sections 15.1-27-04, 15.1-27-11, 15.1-27-22.1, 15.1-27-42,
23 15.1-27-43, 15.1-27-44, 15.1-32-20, 57-15-14.4, and 57-19-04 of the North Dakota Century
24 Code are suspended through June 30, 2015.

25 **SECTION 42. SUSPENSION.** Chapter 57-64 of the North Dakota Century Code is
26 suspended for the first two taxable years beginning after December 31, 2012.

27 **SECTION 43. REPEAL.** Sections 15.1-27-07.1 and 57-19-10 of the North Dakota Century
28 Code are repealed.

29 **SECTION 44. EXPIRATION DATE.** Sections 11 through 13, 16, 18, 22, 29, and 32 through
30 35 of this Act are effective through June 30, 2015, and after that date are ineffective.

31 **SECTION 45. EFFECTIVE DATE - EXPIRATION DATE.**

- 1 1. Sections 1, 6, 7, 20, 23 through 28, 30, and 31 of this Act are effective for the first two
2 taxable years beginning after December 31, 2012, and are thereafter ineffective.
- 3 2. Section 57-15-17.1 remains effective through June 30, 2013, for the purpose of any
4 levy and bond issuance authorized by the board of a school district from January 1,
5 2013, through June 30, 2013. The amendment to section 57-15-17.1, as set forth in
6 section 30 of this Act, is effective beginning July 1, 2013, for the duration of the 2013
7 taxable year, and for the taxable year beginning after December 31, 2013.
- 8 3. Section 35 of this Act is effective for taxable years beginning after December 1, 2012,
9 in the case of ad valorem taxes and for taxable years beginning after December 31,
10 2013, in the case of mobile home taxes.

11 **SECTION 46. EMERGENCY.** Sections 22, 36, and 40 of this Act are declared to be an
12 emergency measure.
