A quorum was declared by the Speaker.

**REMARKS OF REPRESENTATIVE HAAK**

Mr. Speaker, Members of the Assembly:

Today we honor and celebrate the birthdate of the Reverend Doctor Martin Luther King, Jr, a man who was taken from us, long before his time.

As a leader within the civil rights movement, Doctor King taught our country's citizens that nonviolent civil disobedience can be used to educate and create positive change. Doctor King was instrumental in founding the Southern Christian Leadership Conference, which worked tirelessly to end segregation. He helped organize the March on Washington, where he delivered his now famous "I Have a Dream" speech. He was honored with the Nobel Peace Prize in 1964 for his work in combating racial inequality through nonviolence. Beyond racial inequality, Doctor King also advocated to end the Vietnam War and for the needs of the working poor in our country.

Colleagues, as we advance through the 63rd Legislative Assembly, let us keep in mind the words of the man that we honor today, "There is nothing new about poverty. What is new, however, is that we now have the resources to get rid of it."

**REMARKS OF MAJORITY LEADER CARLSON**

Thank you Mr. Speaker, Members of the Assembly.

It's been kind of a tradition in this chamber that we talk a little bit about Martin Luther King Jr. Day. On this day, most of the people of the United States are allowed and hopefully are taking a few minutes to reflect on what that means. Being the old history teacher, I look back in history and I say, what happened here, how did all of this get started? I guess I go back to the battle of Gettysburg and you talk about the sacrifice of American lives over one particular issue, and that was slavery. I looked it up and there were 7,058 Americans that died that day, some on both sides. All in all with the wounded and missing there were 51,000 people that were impacted by that event. Not long after that, one of the presidents that they made a recent movie about, Lincoln, had a speech about what was called the Gettysburg Address. There were a couple anecdotes about that, that I think are important for Americans to remember. The first one everyone probably memorized, at least in my age group, they memorized it when you went to school. It was four score and seven years ago our fathers brought forth on this continent a new nation, conceived in liberty, and dedicated to the proposition that all men are created equal – pretty powerful words for 1863 on November 19, on a cold day in Gettysburg. Then he went on to say at the end, what about these people who died and what did they die for? At the end, he finished his speech and said from these honored dead we take increased devotion to that cause for which they gave the last full measure of devotion – that we here highly resolve that these dead shall not have died in vain – that this nation, under God, shall have a new birth of freedom – and that government of the people, by the people, for the people, shall not perish from the earth – pretty wise words

from a man in a divided country, in a country where the South saw this as a war on aggression and the North felt that it was a war to abolish slavery. But probably the quote that is most revealing about Martin Luther King Jr., for me anyway, is one that is very true to me today and I'll finish with that. It says that "I have a dream that my four little children will one day live in a nation where they will not be judged by the color of their skin but by the content of their character." I hope that is the meaning of what this day is Mr. Speaker. Thank you.
