- 1 A BILL for an Act to provide appropriations to the North Dakota state university extension
- 2 service and to the department of human services; and to provide for a report.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4	SECTION 1. APPROPRIATION - NORTH DAKOTA STATE UNIVERSITY EXTENSION
5	SERVICE - PILOT PROJECT FOR CAREGIVER TRAINING. There is appropriated out of any
6	moneys in the general fund in the state treasury, not otherwise appropriated, the sum of
7	\$197,580, or so much of the sum as may be necessary, to the North Dakota state university
8	extension service for the purpose of establishing a pilot project to expand local training
9	programs to include family caregiver training, for the biennium beginning July 1, 2017, and
10	ending June 30, 2019. The funding provided in this section is considered a one-time funding
11	item.

SECTION 2. APPROPRIATION - DEPARTMENT OF HUMAN SERVICES - LIFESPAN RESPITE CARE PROGRAM. There is appropriated from special funds derived from federal funds and other income, the sum of \$200,000, or so much of the sum as may be necessary, to the department of human services for the purpose of administering a lifespan respite care program, including marketing and outreach efforts for the program, for the biennium beginning July 1, 2017, and ending June 30, 2019.

SECTION 3. DEPARTMENT OF HUMAN SERVICES - CAREGIVER RESOURCE

CENTER WEBSITE. The department of human services shall establish and promote a caregiver resource center website for the biennium beginning July 1, 2017, and ending June 30, 2019.
