## ENGROSSED SENATE BILL NO. 2001

Introduced by

Appropriations Committee

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the  
2 governor; ~~and~~ to amend and reenact sections 54-07-04 and 54-08-03 of the North Dakota  
3 Century Code, relating to the salaries of the governor and lieutenant governor; and to provide  
4 for a legislative management report.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
7 as may be necessary, are appropriated out of any moneys in the general fund in the state  
8 treasury, not otherwise appropriated, to the office of the governor for the purpose of defraying  
9 the expenses of the office of the governor, for the biennium beginning July 1, 2015, and ending  
10 June 30, 2017, as follows:

1       **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**

2 **SIXTY-FIFTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding  
3 items approved by the sixty-third legislative assembly for the 2013-15 biennium and the  
4 2015-17 one-time funding items included in the appropriation in section 1 of this Act:

5 <u>One-Time Funding Description</u>	<u>2013-15</u>	<u>2015-17</u>
6 Governor's transition lines	\$0	\$65,000

8 The 2015-17 one-time funding amounts are not a part of the entity's base budget for the  
9 2017-19 biennium. The office of the governor shall report to the appropriations committees of  
10 the sixty-fifth legislative assembly on the use of this one-time funding for the biennium  
11 beginning July 1, 2015, and ending June 30, 2017.

12 ~~—SECTION 3. APPROPRIATION – GOVERNOR'S OFFICE. In addition to the amounts-~~  
13 ~~appropriated to the governor's office in section 1 of this Act, there is appropriated any additional~~  
14 ~~income from federal or other funds which may become available to the agency for the biennium-~~  
15 ~~beginning July 1, 2015, and ending June 30, 2017.~~

16       **SECTION 3. APPROPRIATION - GOVERNOR'S OFFICE - LEGISLATIVE MANAGEMENT**

17 **REPORT.** In addition to the amounts appropriated to the governor's office in section 1 of this  
18 Act, there is appropriated to the governor's office, any additional income from federal or other  
19 funds which may become available to the governor's office, for the biennium beginning July 1,  
20 2015, and ending June 30, 2017. Any funds received under this section must be used for the  
21 specific purpose intended for the funds or transferred to the appropriate state agency or  
22 institution. Upon the receipt of funds under this section, the governor's office shall provide a  
23 report to the legislative management regarding the source, amount, and purpose of the funds  
24 received.

25       **SECTION 4. AMENDMENT.** Section 54-07-04 of the North Dakota Century Code is  
26 amended and reenacted as follows:

27       **54-07-04. Salary of governor.**

28       The annual salary of the governor is ~~one hundred twenty-one thousand six hundred~~  
29 ~~eighty-one dollars through June 30, 2014, and one hundred twenty-five thousand three hundred~~  
30 ~~thirty-one~~ one hundred twenty-nine thousand ninety-one dollars through June 30, 2016, and one  
31 hundred thirty-two thousand nine hundred sixty-four dollars thereafter.

1       **SECTION 5. AMENDMENT.** Section 54-08-03 of the North Dakota Century Code is  
2 amended and reenacted as follows:

3       **54-08-03. Salary of lieutenant governor.**

4       The annual salary of the lieutenant governor is ~~ninety-four thousand four hundred sixty-two~~  
5 ~~dollars through June 30, 2014, and ninety-seven thousand two hundred ninety-six~~one hundred  
6 thousand two hundred fifteen dollars through June 30, 2016, and one hundred three thousand  
7 two hundred twenty-one dollars thereafter.
