

**FIRST ENGROSSMENT
with House Amendments
ENGROSSED SENATE BILL NO. 2007**

(At the request of the Governor)

1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
2 labor and human rights; and to declare an emergency.

3 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
5 as may be necessary, are appropriated out of any moneys in the general fund in the state
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and
7 other income, to the department of labor and human rights for the purpose of defraying the
8 expenses of that agency, for the biennium beginning July 1, 2015, and ending June 30, 2017,
9 as follows:

3 The 2015-17 one-time funding amounts are not part of the entity's base budget for the 2017-19
4 biennium. The department of labor and human rights shall report to the appropriations
5 committees of the sixty-fifth legislative assembly on the use of the one-time funding for the
6 biennium beginning July 1, 2015, and ending June 30, 2017.

7 **SECTION 3. EMERGENCY.** Funding of \$10,000 for extraordinary repairs in the operating
8 expenses line item in section 1 of this Act is declared to be an emergency measure.
