#### REMARKS OF SENATOR LAFFEN

**MR. PRESIDENT:**

I am pleased to report on the confirmation hearing held January 21, 2015 regarding the Governor's appointment of James Wang to a position on the North Dakota Gaming Commission.

Mr. Wang has been on the Gaming Commission for quite some time - he didn't state the exact number of years but noted he was selected for his first three year term by Governor Schaefer.

Mr. Wang is a lifelong resident of North Dakota and the Devils Lake area and earned his Juris Doctorate from UND in 1988. He is the States Attorney for Benson County and recently reached mandatory retirement from the ND Army National Guard with the rank of Lt. Colonel.

Mr. President, during our hearing, Mr. Wang discussed the gaming commission and their role in monitoring the rules regarding gaming. He explained the roles of the Attorney General, as the accountant and the enforcer, the Advisory Board, as the non-voting representative of the industry and the Commission's role, as the buffer between these two, and their primary role - which is to implement what the legislature passes.

Mr. Wang discussed the different games of chance, the legislature's apprehension of online gaming and the proliferation of new technology - things like electronic bingo cards. Does technology push the gaming envelope farther? The industry will always keep poking at that side and new technologies are always way ahead of us legislatively.

Other points of discussion included:

The state's smoking ban had a big impact on the game of Bingo. There was apparently a strong correlation between smoking and playing this game.

Mr. Wang stated that problems generally occur in the smaller ventures in the lower populated areas. The bigger enterprises hire full time professionals and have better controls for limiting corruption.

The gaming industry is a big one - Mr. Wang states he is always surprised by how many people make their full time living - even down to blackjack dealers.

We asked if there were any chronic issues and Mr. Wang stated no.

We asked his thought on expanding the gaming limits and he correctly pointed out that is not the purview of the commission - rather that is the legislature's role. He did state that his personal opinion is that one can hurt themselves with \$5 bets just as easy as with \$10 bets - the only difference is the length of time. He also stated that he believes in the support that gaming gives to the charitable organizations.

Mr. President, your Senate Select Committee on confirmation voted to approve the appointment of Mr. James Wang for another three year term on the State's Gaming Commission. On behalf of the committee, I move that the Senate report to the Governor that we do advise upon, and hereby consent to, this appointment.

**REMARKS OF SENATOR CASPER**

**MR. PRESIDENT:**

I am pleased to report on the confirmation hearing held January 21, 2015 regarding the Governor's appointment of Wade Mann to the position of Director of the North Dakota Office of Administrative Hearings.

Mr. Mann has been serving in this capacity since January 1st of 2014. The office of Administrative hearings was created in 1991 and Mr. Mann is the second person to head the office. Mr. Mann took over as Director in January of last year to fill out the term of the former Director through June of this year.

Mr. Mann received both his undergraduate and law degrees from the University of North Dakota. He has worked in private practice with the Nilles Law Firm in Fargo and the Crowley Fleck firm in Bismarck. He's also served in the North Dakota Attorney General's office.

Mr. President, during the hearing we discussed the role of the Office of Administrative hearings. Mr. Mann indicated the primary purpose of the office was to conduct hearings for state agencies. Currently, the Office employs 3 full time Administrative Law Judges, with 9 more under contract who float between agencies adjudicating items such as Workforce Safety claims, Professional Licensing, and Human Resources Management. Ultimately, the offices Jurisdiction is laid out in Code.

Mr. President, during the hearing questions centered on where the ALJ's spend the bulk of their time. Mr. Mann told the committee the bulk of the hearings are done for Workforce Safety and Insurance and the Department of Human Services.

Mr. President, during the hearing, Mr. Mann demonstrated the experience, knowledge and ability to lead the Office of Administrative Hearings.

As such, Mr. President, your Senate Select Committee on confirmation voted unanimously to approve the appointment of Mr. Wade C. Mann to the position of Director of the Office of Administrative Hearings.

On behalf of the committee, I move that the Senate report to the Governor that we do advise upon, and hereby consent to, this appointment.

The funding provided in this section may be applied to engineering, design, and construction costs incurred on related projects as of January 1, 2015. The funding provided in this section is considered a one-time funding item."

**STATEMENT OF PURPOSE OF AMENDMENT:**

**SB 2327:** A BILL for an Act to create and enact a new section to chapter 16.1-02 of the North Dakota Century Code, relating to the reporting of incarcerated felons to the secretary of state.

Was read the first time and referred to the **Judiciary Committee**.

Sens. Luick, Dotzenrod and Reps. Amerman, Mitskog, Schreiber Beck introduced:

**SB 2328:** A BILL for an Act to amend and reenact subsections 5 and 6 of section 57-38.6-01 of the North Dakota Century Code, relating to definition of qualified business and qualified investment under the agricultural business investment tax credit; and to provide an effective date.

Was read the first time and referred to the **Finance and Taxation Committee**.

Sens. Flakoll, Burckhard, Nelson and Reps. Keiser, Thoreson, Vigesaa introduced:

**SB 2329:** A BILL for an Act to amend and reenact subsection 1 of section 40-63-03 and subsection 5 of section 40-63-07 of the North Dakota Century Code, relating to the size of a renaissance zone and renaissance zone tax exemptions; and to provide an effective date.

Was read the first time and referred to the **Political Subdivisions Committee**.

Sens. Holmberg, Dever and Reps. Beadle, Delmore introduced:

**SB 2330:** A BILL for an Act to create and enact a new section to chapter 15-10 of the North Dakota Century Code, relating to student identification cards issued by institutions of higher education under the supervision of the state board of higher education; and to amend and reenact subsection 1 of section 16.1-05-07 of the North Dakota Century Code, relating to acceptable forms of identification to be eligible to vote.

Was read the first time and referred to the **Government and Veterans Affairs Committee**.

Sens. Wanzek, Heckaman and Reps. Brandenburg, Hogan introduced:

**SB 2331:** A BILL for an Act to amend and reenact sections 28-01-25.1, 29-04-02, and 29-04-03.1 of the North Dakota Century Code, relating the statute of limitations on the prosecution of and claim for relief on actions alleging childhood sexual abuse; to repeal section 29-04-03.2 of the North Dakota Century Code, relating to statute of limitations as to the child victim; and to provide for application.

Was read the first time and referred to the **Judiciary Committee**.
