

**FIRST ENGROSSMENT  
with Conference Committee Amendments  
ENGROSSED SENATE BILL NO. 2016**

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of job service North  
2 Dakota; to provide a statement of legislative intent; to provide for a legislative management  
3 study; to provide for a study by the office of management and budget; to provide an  
4 appropriation to the office of management and budget; and to declare an emergency.

**5 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
7 as may be necessary, are appropriated out of any moneys in the general fund in the state  
8 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
9 other income, to job service North Dakota for the purpose of defraying the expenses of job  
10 service North Dakota, for the biennium beginning July 1, 2017, and ending June 30, 2019, as  
11 follows:

1       **SECTION 2. HEALTH INSURANCE INCREASES.** The salaries and wages line item in  
2 section 1 of this Act includes the sum of \$421,951, of which \$2,827 is from the general fund, for  
3 increases in employee health insurance premiums from \$1,130 to \$1,241 per month.

4       **SECTION 3. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE**  
5 **SIXTY-SIXTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding  
6 items approved by the sixty-fourth legislative assembly as adjusted for the 2015-17 biennium  
7 and the 2017-19 biennium one-time funding items included in the appropriation in section 1 of  
8 this Act:

16 The 2017-19 biennium one-time funding amounts are not a part of the entity's base budget for  
17 the 2019-21 biennium. Job service North Dakota shall report to the appropriations committees  
18 of the sixty-sixth legislative assembly on the use of this one-time funding for the biennium  
19 beginning July 1, 2017, and ending June 30, 2019.

20       **SECTION 4. APPROPRIATION - REED ACT FUNDS - UNEMPLOYMENT INSURANCE**  
21 **COMPUTER MODERNIZATION.** The estimated income line item in section 1 of this Act  
22 includes \$11,209,557 from federal Reed Act funds made available to the state by the federal  
23 Reed Act distributions made in federal fiscal years 1957, 1958, 1999, and 2002, pursuant to  
24 section 903 of the federal Social Security Act. This sum, or so much of the sum as may be  
25 necessary, is for the purpose of developing a modernized unemployment insurance computer  
26 system, for the biennium beginning July 1, 2017, and ending June 30, 2019.

27       **SECTION 5. APPROPRIATION.** All federal funds received by job service North Dakota in  
28 excess of those funds appropriated in section 1 of this Act are appropriated for the biennium  
29 beginning July 1, 2017, and ending June 30, 2019.

30       **SECTION 6. ESTIMATED INCOME - RENT REVENUE.** The estimated income line item in  
31 section 1 of this Act includes \$750,000 of estimated rent revenue as a result of job service North

1 Dakota leasing the Minot regional office and a portion of the Bismarck central office to other  
2 state agencies. Any revenue collected must be deposited in the job service North Dakota  
3 operating fund for the biennium beginning July 1, 2017, and ending June 30, 2019.

4 **SECTION 7. ONE-TIME FUNDING - BISMARCK REGIONAL OFFICE RENOVATION -**  
5 **RELOCATION COSTS.** Section 1 of this Act includes \$100,000 of one-time funding from the  
6 general fund, for defraying the expenses of job service North Dakota relocating from the  
7 Bismarck central office to the Bismarck regional office and for costs associated with renovations  
8 of the Bismarck regional office necessary for normal business operations for the biennium  
9 beginning July 1, 2017, and ending June 30, 2019.

10 **SECTION 8. NEW JOBS TRAINING.** During the biennium beginning July 1, 2017, and  
11 ending June 30, 2019, job service North Dakota may not award more than \$2,500,000 for new  
12 agreements related to the new jobs training program under chapter 52-02.1.

13 **SECTION 9. LEGISLATIVE MANAGEMENT STUDY - JOB SERVICE NORTH DAKOTA**  
14 **PROPERTIES.** During the 2017-18 interim, the legislative management shall consider studying  
15 office space cost and value of properties owned by job service North Dakota in Fargo, Rolla,  
16 Minot, and Bismarck with input from the office of management and budget. If job service North  
17 Dakota sells or leases any property identified in this section before July 1, 2017, the property  
18 may not be included in the study. The legislative management shall report its findings and  
19 recommendations, together with any legislation necessary to implement the recommendations,  
20 to the sixty-sixth legislative assembly.

21 **SECTION 10. APPROPRIATION - STUDY AND LEASE OF JOB SERVICE NORTH**  
22 **DAKOTA BISMARCK PROPERTY - JOB SERVICE NORTH DAKOTA RELOCATION -**  
23 **BUDGET SECTION REPORT.** There is appropriated out of any moneys in the general fund in  
24 the state treasury, not otherwise appropriated, the sum of \$25,000, or so much of the sum as  
25 may be necessary, to the office of management and budget for the purpose of contracting with a  
26 qualified consultant by June 30, 2017, to conduct a study of the most cost-effective use for the  
27 job service North Dakota property Parcel# 0485-010-045; Lot# N.50; of L 3, ALL 4-6, ALL L  
28 17-19; Block# 10; Addition - TIBESAR's first in the city of Bismarck, Burleigh County, North  
29 Dakota. The funding appropriated in this section is considered one-time funding. The office of  
30 management and budget, in consultation with the attorney general and job service North  
31 Dakota, shall determine the most cost-effective use of the property described in this section.

1 The term "cost-effective" means savings to the general fund, including any costs associated  
2 with relocation, rental costs related to the job service North Dakota Bismarck regional office,  
3 and remodeling of office space for job service North Dakota and the attorney general's office.  
4 The office of management and budget shall complete its study by September 30, 2017. If the  
5 office of management and budget determines it is more cost-effective for the attorney general's  
6 office to lease a portion of the property described in this section, job service North Dakota shall  
7 lease the number of square feet that is determined the most cost-effective, up to seventy-five  
8 percent of the building, to the attorney general, no later than March 31, 2018. Job service North  
9 Dakota shall continue to occupy at least twenty-five percent of the building. As a result of the  
10 study provided for in this section and upon the lease of a portion of the property described in  
11 this section, job service North Dakota may relocate a portion of its central office operations to  
12 another suitable location. The office of management and budget shall report the findings and  
13 results of its study to the budget section prior to the lease of the job service North Dakota  
14 central office building and subsequent relocation of job service North Dakota to the Bismarck  
15 regional office or other office space.

16 **SECTION 11. LEGISLATIVE INTENT.** If the attorney general's office relocates a portion of  
17 its operations to the job service North Dakota central office, it is the intent of the sixty-fifth  
18 legislative assembly any funds appropriated to lease office space it is vacating are no longer  
19 appropriated for said purpose.

20 **SECTION 12. EMERGENCY.** Section 10 of this Act is declared to be an emergency  
21 measure.
