- 4 SECTION 1. SALE OF PROPERTY BY JOB SERVICE NORTH DAKOTA. The state of

- 8 County, North Dakota. Job service North Dakota may cause this property to be sold in the
- 9 manner prescribed by sections 54-01-05.1 and 54-01-05.2. The provisions of section
- 10 54-01-05.5 do not apply to the sale and conveyance authorized by this Act. Net proceeds from
- 11 the sale must be used as authorized and directed by law.
- 12 SECTION 2. SALE OF PROPERTY BY JOB SERVICE NORTH DAKOTA. The state of
- 13 North Dakota acting through job service North Dakota may sell and convey Lots 5 & 6, Block 5,
- 14 Airport Industrial Addition to the City of Minot, Ward County, North Dakota. Job service North
- 15 Dakota may cause this property to be sold in the manner prescribed by sections 54-01-05.1 and
- 16 54-01-05.2. The provisions of section 54-01-05.5 do not apply to the sale and conveyance
- 17 authorized by this Act. Net proceeds from the sale must be used as authorized and directed by
