The House convened at 1:00 p.m., with Speaker Bellew presiding.

The prayer was offered by Pastor Russ Whitaker, Mission Evangelical Free Church, Wilton.

A quorum was declared by the Speaker.

POINT OF PERSONAL PRIVILEGE

REP. DELMORE rose on a point of personal privilege.

REMARKS OF REPRESENTATIVE DELMORE

MR. SPEAKER: I rise to the Point of Personal Privilege. Today I would like to recognize the 100th Anniversary of North Dakota Women's Right to Vote.

The North Dakota suffrage movement had strong leaders but few followers before 1912. During those "drought years" there were a few state conventions where suffragists gathered to discuss the issues. No woman suffrage bills were approved until 1917. On that date, January 23, 1917, Governor Lynn J. Frazier, a member of the Nonpartisan League, signed the women's suffrage bill giving North Dakota women the right to vote in statewide elections. Voting rights were limited. Women could vote for presidential electors and city and township officers. They could not vote for governor, members of the legislature, nor Senator or Representative to Congress.

The rest is history. Please help me to recognize this milestone in North Dakota history!!

REPORT OF STANDING COMMITTEE

HB 1151: Energy and Natural Resources Committee (Rep. Porter, Chairman) recommends **AMENDMENTS AS FOLLOWS** and when so amended, recommends **DO PASS** (11 YEAS, 2 NAYS, 1 ABSENT AND NOT VOTING). HB 1151 was placed on the Sixth order on the calendar.

Page 5, line 15, remove "The commission may not require any person controlling or operating any well, or a"

Page 5, remove lines 16 through 18

Page 5, line 19, replace "fewer barrels of fluid" with "A person controlling or operating a well, pipeline, receiving tank, storage tank, treating plant, or other receptacle or production facility associated with oil and gas, or with water production, injection, processing, or well servicing, shall report to the commission any leak, spill, or release of fluid. A report to the commission is not required if the leak, spill, or release is crude oil, produced water, or natural gas liquids in a quantity of less than ten barrels cumulative over a fifteen-day time period and remains on the facility or site and the facility or site has impermeable base material and containment."

3. Any written violation notice issued by the commission regarding the notification of a fire, leak, spill, blowout, or leak and spill cleanup must be placed in the well file or facility file and the files must be available for review by the surface owner"

REPORT OF STANDING COMMITTEE
