Presentation of background information, testimony, and committee discussion relating to House Bill No. 1220, which directs a study, in coordination with the Secretary of State, of how the state's central indexing system can be used to provide notification to a secured lender when a super priority lien is filed on the collateral of a secured lender; House Bill No. 1467, which directs a study of agricultural issues in the state, including studying grain buyers, roving grain buyers, grain brokers, and grain handling facilities under North Dakota Century Code Title 60; and issues related to prepayment for fertilizer, soil amendments, seed, and fuel in situations of insolvency; Section 2 of Senate Bill No. 2061, which directs a study of current methods, using the electric vehicle infrastructure coalition, led by the Department of Transportation, to collaborate with the North Dakota utility industry, and North Dakota electric vehicle stakeholder groups, to design a jointly owned public and private network of electric vehicle infrastructure to support both commercial and noncommercial vehicles and make recommendations regarding electric vehicle charging infrastructure; and Section 2 of Senate Bill No. 2176, which directs a study of the feasibility and desirability of creating a road train pilot program; the receipt of reports; and other committee matters
