1 A BILL for an Act to provide an appropriation for defraying the expenses of the agriculture
2 commissioner; to provide for transfers; to create and enact a new section to chapter 60-01, a
3 new section to chapter 60-02, and a new section to chapter 60-02.1 of the North Dakota
4 Century Code, relating to the definition of agriculture commissioner and records confidentiality
5 for warehousemen and grain buyers; to amend and reenact sections 4.1-01-02 and 49-02-01,
6 subsection 1 of section 60-02-01, sections 60-02-02, 60-02-03, 60-02-04, 60-02-05.1, 60-02-07,
7 60-02-07.2, 60-02-09, 60-02-09.1, 60-02-10.1, 60-02-11, 60-02-14, 60-02-17, 60-02-24,
8 60-02-27, 60-02-35.1, 60-02-38, 60-02-40, 60-02-41, 60-02-42, 60-02.1-01, 60-02.1-02,
9 60-02.1-03, 60-02.1-04, 60-02.1-06, 60-02.1-07, 60-02.1-07.1, 60-02.1-08, 60-02.1-09,

16 60-10-12, 60-10-14, and 60-10-15 of the North Dakota Century Code, relating to the salary of
17 the agriculture commissioner and moving the authority over grain, grain buyers, warehousing,
18 deposits, and warehousemen from the public service commission to the agriculture
19 commissioner; to provide for a report to the legislative assembly; to provide a penalty; and to
20 provide a continuing appropriation.

21 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

22 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
23 as may be necessary, are appropriated out of any moneys in the general fund in the state
24 treasury, not otherwise appropriated, and from special funds derived from federal funds and

21 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**

22 **SIXTY-SEVENTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time
23 funding items approved by the sixty-fifth legislative assembly for the 2017-19 biennium and the
24 one-time funding items included in the appropriation in section 1 of this Act:

3 The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget
4 for the 2021-23 biennium. The agriculture commissioner shall report to the appropriations
5 committees of the sixty-seventh legislative assembly on the use of this one-time funding for the
6 biennium beginning July 1, 2019, and ending June 30, 2021.

7 **SECTION 3. TRANSFER - ENVIRONMENT AND RANGELAND PROTECTION FUND -**

8 **MINOR USE PESTICIDE FUND.** The agriculture commissioner shall transfer \$325,000 from
9 the environment and rangeland protection fund to the minor use pesticide fund during the
10 biennium beginning July 1, 2019, and ending June 30, 2021.

11 **SECTION 4. ESTIMATED INCOME - ENVIRONMENT AND RANGELAND PROTECTION**

12 **FUND.** The estimated income line item in section 1 of this Act includes the sum of \$6,725,799
13 from the environment and rangeland protection fund for the purpose of defraying the expenses
14 of various department of agriculture programs, for the biennium beginning July 1, 2019, and
15 ending June 30, 2021.

16 **SECTION 5. ESTIMATED INCOME - GAME AND FISH FUND.** The estimated income line

17 item in section 1 of this Act includes the sum of \$614,430 from the game and fish department
18 operating fund for the purpose of defraying the expenses of various department of
19 agriculture programs, for the biennium beginning July 1, 2019, and ending June 30, 2021.

20 **SECTION 6. ESTIMATED INCOME - STATE WATER COMMISSION - TRANSFER.** The

21 estimated income line item in section 1 of this Act includes the sum of \$125,000 which the state
22 water commission shall transfer to the agriculture commissioner for the wildlife services
23 program, for the biennium beginning July 1, 2019, and ending June 30, 2021.

24 **SECTION 7. WATERBANK PROGRAM - MATCHING FUNDS.** The salaries and wages line

25 item in section 1 of this Act includes \$50,000 from the general fund for matching funds for the
26 North Dakota outdoor heritage fund grant provided for the waterbank program.

27 **SECTION 8. ESTIMATED INCOME - PIPELINE RESTORATION AND RECLAMATION.**

28 The estimated income line item in section 1 of this Act includes the sum of \$200,000 from the
29 abandoned oil and gas well plugging and site reclamation fund for the purpose of defraying the
30 expenses of the pipeline restoration and reclamation program, for the biennium beginning
31 July 1, 2019, and ending June 30, 2021.

1 **SECTION 9. TRANSFER - BANK OF NORTH DAKOTA PROFITS - AGRICULTURAL**
2 **PRODUCTS UTILIZATION COMMISSION.** The Bank of North Dakota shall transfer the sum of
3 \$2,000,000, or so much of the sum as may be necessary, from the Bank's current earnings and
4 undivided profits to the agriculture commissioner for deposit in the agricultural products
5 utilization commission fund during the biennium beginning July 1, 2019, and ending June 30,
6 2021. This funding is considered a one-time funding item.

7 **SECTION 10. AMENDMENT.** Section 4.1-01-02 of the North Dakota Century Code is
8 amended and reenacted as follows:

9 **4.1-01-02. Salary of agriculture commissioner.**

10 The annual salary of the agriculture commissioner is one hundred ~~five~~sixteen thousand ~~four~~
11 ~~hundred ninety-one~~eight hundred thirty-six dollars through June 30, ~~2016~~2020, and one
12 hundred ~~eight~~nineteen thousand ~~six~~seven hundred ~~fifty-six~~fifty-seven dollars after that date.

13 **SECTION 11. APPROPRIATION - GRAIN INSOLVENCY LITIGATION - ONE-TIME**
14 **FUNDING - APPLICATION.** There is appropriated out of any moneys in the general fund in the
15 state treasury, not otherwise appropriated, the sum of \$100,000, or so much of the sum as may
16 be necessary, to the agriculture commissioner for the purpose of paying the public service
17 commission to continue providing services related to grain insolvency litigation that began prior
18 to July 1, 2019, for the biennium beginning July 1, 2019, and ending June 30, 2021. This
19 funding is considered a one-time funding item. Sections 60-02.1-38 and 60-04-10 do not apply
20 to any expenses paid from the appropriation provided in this section.

21 **SECTION 12. AMENDMENT.** Section 49-02-01 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **49-02-01. General jurisdiction of the public service commission over public utilities.**

24 The general jurisdiction of the commission shall extend to and include:

- 25 1. Contract and common carriers engaged in the transportation of persons and property,
26 excluding air carriers.
- 27 2. Telecommunications companies engaged in the furnishing of telecommunications
28 services as provided for in chapter 49-21.
- 29 3. Pipeline utilities engaged in the transportation of gas, oil, coal, and water.
- 30 4. Electric utilities engaged in the generation and distribution of light, heat, or power.
- 31 5. Gas utilities engaged in the distribution of natural, synthetic, or artificial gas.

1 6. All heating utilities engaged in the distribution of heat.

2 7. ~~Warehouse companies engaged in the marketing, storage, or handling of agricultural~~
3 ~~products.~~

4 8. All other public utilities engaged in business in this state or in any county, city,
5 township, or other political subdivision of the state.

6 **SECTION 13.** A new section to chapter 60-01 of the North Dakota Century Code is created
7 and enacted as follows:

8 **Definition.**

9 For purposes of this title, "commissioner" means the agriculture commissioner.

10 **SECTION 14. AMENDMENT.** Subsection 1 of section 60-02-01 of the North Dakota
11 Century Code is amended and reenacted as follows:

12 1. ~~"Commissioner"~~ Commissioner means the ~~public service commission~~ agriculture
13 commissioner.

14 **SECTION 15. AMENDMENT.** Section 60-02-02 of the North Dakota Century Code is
15 amended and reenacted as follows:

16 **60-02-02. Commissioner - Powers and duties.**

17 The ~~commissioner has the powers and~~ commissioner has the powers and ~~duties imposed by the provisions of~~ duties imposed by the provisions of ~~enumerated~~
18 under this chapter and the powers conferred herein devolve upon the commissioner.

19 **SECTION 16. AMENDMENT.** Section 60-02-03 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **60-02-03. Duties and powers of the commissioner.**

22 ~~The commissioner shall have the duty and power to~~ commissioner has the following powers
23 and duties:

24 1. Exercise general supervision of the public warehouses of this state, including the
25 handling, weighing, and storing of grain, and the management of public warehouses.

26 2. Investigate all complaints of fraud and injustice, unfair practices, and unfair
27 discrimination.

28 3. Examine and inspect, during ordinary business hours, any licensed warehouse,
29 including all books, documents, and records.

30 4. Require the filing of reports pertaining to the operation of the warehouse.

1 5. Make all proper rules for carrying out and enforcing any law in this state regarding
2 public warehouses.

3 **SECTION 17. AMENDMENT.** Section 60-02-04 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **60-02-04. Federal licensed inspector –~~Appointed by commission.~~**

6 The ~~commission~~commissioner may employ a federal licensed inspector whose duties are
7 ~~hereinafter prescribed and such~~enumerated under this chapter and may employ other
8 employees as ~~may be~~ necessary to carry out the provisions of this chapter.

9 **SECTION 18. AMENDMENT.** Section 60-02-05.1 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **60-02-05.1. Notice of procedures for resolving disputes over grain.**

12 A public warehouse shall post a notice containing the procedures specified in section
13 60-02-05 for resolving disputes. The ~~commission~~commissioner shall prescribe the form of the
14 notice and shall provide a copy of the notice to each public warehouse. The public
15 warehouseman shall post the notice in the grain inspection room of the warehouse. The notice
16 must specifically mention ~~that~~ the procedure for resolving disputes applies to the grade,
17 dockage, moisture content, and protein content of grain and to the quality factors of grain for
18 which inspection rules and grades have not been adopted by the secretary of agriculture of the
19 United States.

20 **SECTION 19. AMENDMENT.** Section 60-02-07 of the North Dakota Century Code is
21 amended and reenacted as follows:

22 **60-02-07. Public warehouse license - Fee - Financial statement.**

23 A license must be obtained from the ~~commission~~commissioner for each public warehouse in
24 operation in this state.

25 1. a. ~~The commission shall stagger by lot the expiration date of all licenses issued for~~
26 ~~the period beginning August 1, 2015, so that one-half of all the licenses issued~~
27 ~~expire on July 31, 2016, and one-half of all the licenses issued expire on July 31,~~
28 ~~2017. Thereafter, all~~All licenses issued under this section must be for a period of
29 two years and terminate on the thirty-first day of July in the year of expiration.

- 1 b. (1) Notwithstanding the provisions of subdivision a, the
2 ~~commission~~commissioner shall license a warehouse annually, for the first
3 six years of the warehouse's operation.
- 4 (2) An initial annual license application that becomes effective on or after June
5 first does not expire until July thirty-first of the following calendar year.
- 6 2. No license may describe more than one public warehouse nor grant permission to
7 operate any public warehouse other than the one described.
- 8 3. a. The annual license fee for a public warehouse is:
- 9 (1) ~~Three~~Four hundred dollars for a warehouse having a maximum capacity of
10 two hundred thousand bushels [7047.8 cubic meters];
- 11 (2) ~~Four~~Five hundred fifty dollars for a warehouse having a capacity of more
12 than two hundred thousand bushels [7047.8 cubic meters] but not more
13 than five hundred thousand bushels [17619.54 cubic meters]; and
- 14 (3) ~~Five~~Six hundred fifty dollars for a warehouse having a capacity of more than
15 five hundred thousand bushels [17619.54 cubic meters].
- 16 b. The biennial license fee for a public warehouse is:
- 17 (1) ~~Six~~Seven hundred dollars for a warehouse having a maximum capacity of
18 two hundred thousand bushels [7047.8 cubic meters];
- 19 (2) ~~Nine hundred~~One thousand dollars for a warehouse having a capacity of
20 more than two hundred thousand bushels [7047.8 cubic meters] but not
21 more than five hundred thousand bushels [17619.54 cubic meters]; and
- 22 (3) One thousand ~~one~~two hundred dollars for a warehouse having a capacity of
23 more than five hundred thousand bushels [17619.54 cubic meters].
- 24 c. An application for an annual license renewal that is received after July fifteenth
25 must include an additional one hundred dollar fee per warehouse. An application
26 for a biennial license renewal that is received after July fifteenth must include an
27 additional two hundred dollar fee per warehouse.
- 28 4. If a public warehouseman operates two or more warehouses in the same city or
29 siding, in conjunction with each other and with the same working force, and keeps one
30 set of books and records for all such warehouses, and issues one series of scale
31 tickets, warehouse receipts, checks, and credit-sale contracts for the grain stored and

1 purchased therein, only one license is required for the operation of all such
2 warehouses. When two or more warehouses are operated under one license, the
3 license fee is based upon the combined bushel capacity of the warehouses.

4 5. If required to obtain United States department of agriculture approval of the
5 ~~commission's~~commissioner's warehouse inspection program, the
6 ~~commission~~commissioner may require that the applicant submit a current financial
7 statement prepared in accordance with generally accepted accounting principles. A
8 financial statement furnished under this subsection is a confidential trade secret and is
9 not a public record.

10 **SECTION 20. AMENDMENT.** Section 60-02-07.2 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 **60-02-07.2. Receiving stations.**

13 A licensed public warehouseman may establish a receiving station without a separate
14 warehouse license for that facility if all of the following conditions are met:

- 15 1. The station is colocated with another licensed public warehouse, the operator of which
16 will take delivery of the grain on behalf of the warehouseman who established the
17 receiving station.
- 18 2. The storage space used by the receiving station is used solely by the receiving station
19 and is not licensed as part of the warehouse that is located at that site.
- 20 3. The grain taken in by the receiving station is not commingled with other grain at that
21 site.
- 22 4. The warehouseman establishing the station requests and receives ~~commission-~~
23 permission from the commissioner to increase licensed capacity to include the space
24 to be used at the receiving station.
- 25 5. Grain received at the receiving station is recorded on scale tickets issued by the
26 warehouseman who established the station and is covered by that warehouseman's
27 bond.
- 28 6. Warehouse-receipted grain received at the receiving station is available for redelivery
29 to the receiptholder at that location even if the station has been closed. A charge for
30 redelivery must be stated in the warehouseman's redelivery policy.

1 The storage space used by a receiving station need not be physically disconnected from the
2 facilities of the other licensed warehouse located at that site.

3 **SECTION 21. AMENDMENT.** Section 60-02-09 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **60-02-09. Bond filed by public warehouseman.**

6 Before any license is effective for any public warehouseman under this chapter, the
7 applicant for the license shall file a bond with the ~~commission~~commissioner which must:

- 8 1. Be in a sum not less than five thousand dollars for any one warehouse.
- 9 2. Be continuous, unless the corporate surety by certified mail notifies the licensee and
10 the ~~commission~~commissioner the surety bond will be canceled ninety days after
11 receipt of the notice of cancellation.
- 12 3. Run to the state of North Dakota for the benefit of all persons storing or selling grain in
13 that warehouse.
- 14 4. Be conditioned:
 - 15 a. For the faithful performance of the licensee's duties as a public warehouseman.
 - 16 b. For compliance with the provisions of law and the rules of the
17 ~~commission~~commissioner relating to the storage and purchase of grain by such
18 warehouseman.
- 19 5. Specify the location of each public warehouse intended to be covered by such bond.
- 20 6. Be for the specific purpose of:
 - 21 a. Protecting the holders of outstanding receipts.
 - 22 b. Covering the costs incurred by the ~~commission~~commissioner in the
23 administration of chapter 60-04 in the event of the licensee's insolvency.
- 24 7. Not accrue to the benefit of any person entering into a credit-sale contract with a
25 public warehouseman.
- 26 8. The aggregate liability of the surety under a bond does not accumulate for each
27 successive annual license renewal period during which the bond is in force but, for
28 losses during any annual license renewal period, is limited in the aggregate to the
29 bond amount stated or changed by appropriate endorsement or rider.

30 The ~~commission~~commissioner shall set the amount of the bond and may require an increase in
31 the amount of any bond, from time to time, as the ~~commission~~commissioner deems necessary

1 to accomplish the purposes of this section. The surety on the bond must be a corporate surety
2 company, approved by the ~~commission~~commissioner, and authorized to do business within the
3 state. The ~~commission~~commissioner may accept cash, a negotiable instrument, or a bond
4 executed by personal sureties in lieu of a surety bond ~~whenif, in its~~the commissioner's
5 judgment, the cash, negotiable instrument, or personal surety bond properly will protect the
6 holders of outstanding receipts. One bond only may be given for any line of elevators, mills, or
7 warehouses, owned, controlled, or operated by one individual, firm, corporation, or limited
8 liability company, and the bond must be construed to cover ~~such~~the elevators, mills, or
9 warehouses, as a whole and not a specific amount for each.

10 **SECTION 22. AMENDMENT.** Section 60-02-09.1 of the North Dakota Century Code is
11 amended and reenacted as follows:

12 **60-02-09.1. Bond cancellation - Release of surety.**

13 The surety on a bond is released from all future liability accruing on the bond after the
14 expiration of ninety days from the date of receipt by the ~~commission~~commissioner of notice of
15 cancellation by the surety or on a later date specified by the surety. This provision does not
16 operate to relieve, release, or discharge the surety from any liability already accrued or which
17 accrues before the expiration of the ninety-day period. Unless the warehouseman files a new
18 bond at least thirty days before liability ceases, the ~~commission~~commissioner, without hearing,
19 shall immediately suspend the warehouseman's license and the suspension may not be
20 removed until a new bond has been filed and approved by the ~~commission~~commissioner.
21 ~~Whenif~~ a license is so suspended, the warehouseman shall give notice of such suspension to
22 each receiptholder having grain stored in the warehouse. The warehouseman shall further notify
23 each receiptholder having grain stored in the warehouse that the grain must be removed from
24 the warehouse or ~~it~~the grain will be priced and redeemed in cash in accordance with section
25 60-02-41.

26 **SECTION 23. AMENDMENT.** Section 60-02-10.1 of the North Dakota Century Code is
27 amended and reenacted as follows:

28 **60-02-10.1. Revocation and suspension.**

29 The ~~commission~~commissioner may suspend or revoke the license of any warehouseman
30 for cause upon notice and hearing. Notwithstanding any other provisions of this chapter, the
31 license of a warehouseman must automatically be suspended for failure at any time to have or

1 to maintain either a bond or insurance policy in the amount and type required. During a
2 suspension of a license the warehouseman may, upon the ~~commission's~~commissioner's
3 approval, operate the warehouse and purchase or redeliver grain previously received, but may
4 not receive additional grain for purchase, storage, shipping, or processing. Grain may be sold
5 only with the prior approval of the ~~commission~~commissioner.

6 **SECTION 24. AMENDMENT.** Section 60-02-11 of the North Dakota Century Code is
7 amended and reenacted as follows:

8 **60-02-11. Scale ticket - Contents - Conversion.**

- 9 1. a. Every public warehouseman, upon receiving grain into the warehouse, shall
10 issue a uniform scale ticket for each load of grain received. The scale tickets
11 must be numbered consecutively, and one copy of each ticket must be retained
12 and remain as a permanent record. The original ticket must be delivered to the
13 person from whom the grain is received, upon receipt of each load of grain.
- 14 b. All scale tickets must be converted into cash, noncredit-sale contracts, credit-sale
15 contracts, or warehouse receipts, within forty-five days after the grain is delivered
16 to the warehouse, unless:
- 17 (1) The person to whom the scale ticket is issued signs a form waiving all rights
18 to trust benefits under section 60-04-03.1;
- 19 (2) The form identifies by number each scale ticket to which the waiver applies;
20 and
- 21 (3) The form is signed by the warehouseman.
- 22 c. The ~~commission~~commissioner shall prepare the waiver form required by
23 subdivision b and make the form available to each warehouse.
- 24 d. The warehouseman shall keep one copy of the signed waiver form with the
25 records of the warehouse, provide one copy to the person who was issued the
26 scale ticket and signed the form, and file one copy with the
27 ~~commission~~commissioner.
- 28 2. Nothing in this chapter requires a warehouseman to receive grain for storage. A
29 warehouseman shall publish and post, in a conspicuous place in the warehouse, a
30 publication identifying whether storage will be available to patrons or whether grain will
31 be accepted via cash or a credit-sale contract arrangement.

1 **SECTION 25. AMENDMENT.** Section 60-02-14 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **60-02-14. Warehouse receipts - Copy.**

4 Provision ~~shall~~must be made for a stub record or copy of each warehouse receipt issued by
5 a warehouseman, showing:

- 6 1. The serial number and date of receipt.
- 7 2. The kind and grade of grain.
- 8 3. The dockage and net weight of the grain.

9 The record or copy ~~shall~~must remain in the possession of the warehouseman for inspection by
10 the ~~commission~~commissioner and persons properly interested.

11 **SECTION 26. AMENDMENT.** Section 60-02-17 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **60-02-17. Warehouse and storage contract - Storage rates - Terminal delivery.**

14 1. A warehouse receipt must contain, either on its face or reverse side, the following
15 warehouse and storage contract:

16 This grain is received, insured, and stored subject to the laws and rules of the state of
17 North Dakota, the terms of this contract, and the charges and conditions stated herein
18 and as filed with the North Dakota ~~public service commission~~agriculture commissioner.
19 Upon surrender of this receipt and payment or tender of all applicable charges, the
20 amount, kind, and grade of grain identified in this receipt will be delivered to the
21 person named above or the person's order as rapidly as due diligence, care, and
22 prudence will permit. At the option of the holder of this receipt, the amount, kind, and

24 to the holder at any terminal point customarily shipped to, or at the place where
25 received, upon the payment of any charges for receiving, handling, storage, and
26 insurance and in case of terminal delivery, the payment in addition to the above of the
27 regular freight charges on the gross amount called for by this ticket or in lieu thereof, a
28 receipt issued by a bonded warehouse or elevator company doing business at the
29 terminal point. This receipt does not require the delivery of the identical grain specified
30 herein, but an equal amount of grain of the same kind and grade must be delivered.

1 2. A warehouseman shall publish and post, in a conspicuous place in its warehouse, the
2 fees that will be assessed for receiving, storing, processing, or redelivering grain and
3 the termination date of its warehouse receipts. This publication must be filed with the
4 ~~commission~~commissioner as a part of the warehouse license process or annual
5 renewal. The fees and termination date must be stated on the warehouse receipt
6 issued for the grain. The fees or termination date may be changed upon filing a
7 revised publication with the ~~commission~~commissioner.

8 **SECTION 27. AMENDMENT.** Section 60-02-24 of the North Dakota Century Code is

12 or grass seeds owned by or in the possession of the grain buyer which have been

- 15 6. "Grain buyer" means any person, other than a public warehouseman as defined in
16 chapter 60-02, who purchases or otherwise merchandises grain for compensation.

19 carload or truckload in which the greater portion of the load is grain grown by the
20 producer or on-farm feedlot operations in which at least fifty percent of the

23 grain only for processing and subsequent resale as seed.

30 received as a result of a credit-sale contract.

1 9. "Roving grain buyer" means a grain buyer who does not operate a facility where grain

15 redeem all receiptholder claims in full, the fund must be shown prorated in the report in the
16 manner the ~~commission~~ commissioner deems fair and equitable.

17 The court shall set a hearing and the appropriate notice for interested persons to show
18 cause why the ~~commission's~~ commissioner's report should not be approved and credit-sale
19 contract indemnity fund payments and distribution of the trust fund be made as proposed, and
20 payments from the credit-sale contracts be made as proposed. Copies of the report and notice
21 of hearing must be served by the ~~commission~~ commissioner by certified mail upon the
22 warehouseman and the surety and by ordinary mail upon all persons having claims filed with
23 the ~~commission~~ commissioner.

24 Any aggrieved person having an objection to the ~~commission's~~ commissioner's report shall
25 file the objection with the court and serve copies on the ~~commission~~ commissioner, the
26 warehouseman, and the surety at least twenty days before the hearing. Failure to file and serve
27 objections in the time set is a waiver of the objection.

28 Following hearing, the court shall approve or modify the report and issue an order directing
29 payment of the necessary bond proceeds, distribution of the trust fund, payments from the
30 credit-sale contract indemnity fund, and discharge of the ~~commission~~ commissioner from ~~its~~ the
31 commissioner's trust.

1 **SECTION 73. AMENDMENT.** Section 60-04-10 of the North Dakota Century Code is
2 amended and reenacted as follows:

3 **60-04-10. Filing fees and court costs - Expenses.**

4 In any action in a state court in this state, the ~~commission shall~~commissioner may not be
5 required to pay any filing fee or other court costs or disbursements if the fees accrue to the
6 county or to the state. The attorney general may employ outside legal services to assist the
7 ~~commission~~commissioner in the prosecution of such action as in the attorney general's
8 judgment may be necessary and the ~~commission~~commissioner shall deduct the expenses of
9 the same from the trust fund and the credit-sale contract indemnity fund as appropriate. All
10 other necessary expenses incurred by the ~~commission~~commissioner in carrying out the
11 provisions of this chapter, including adequate insurance to protect the ~~commission,~~
12 ~~its~~commissioner, the commissioner's employees, and others engaged in carrying out the
13 provisions of this chapter, must be reimbursed to the ~~commission~~commissioner from the trust
14 fund and credit-sale indemnity funds as appropriate.

15 **SECTION 74. AMENDMENT.** Section 60-05-01 of the North Dakota Century Code is
16 amended and reenacted as follows:

17 **60-05-01. Public elevators and warehouses - ~~Commission~~Commissioner may require**
18 **uniform accounting system.**

19 The ~~public service commission~~commissioner may require every association, copartnership,
20 corporation, or limited liability company conducting a public elevator or warehouse in this state
21 to adopt a uniform accounting system established by ~~such commission~~the commissioner.

22 **SECTION 75. AMENDMENT.** Section 60-05-02 of the North Dakota Century Code is
23 amended and reenacted as follows:

24 **60-05-02. Examination of financial accounts of elevator or warehouse by competent**
25 **examiner - Request by percentage of stockholders.**

26 The ~~commission~~commissioner may install, and ~~whenever~~if requested by not less than
27 fifteen percent of the partners, stockholders, or members of any association, copartnership,
28 corporation, or limited liability company conducting such public elevator or warehouse, shall
29 install, the uniform system of accounting mentioned in section 60-05-01. The
30 ~~commission~~commissioner on ~~its~~the commissioner's own motion may, or on request of the
31 required percentage of partners, stockholders, or members, the ~~commission~~commissioner shall,

1 send a competent examiner to examine the books and financial accounts of such ~~the~~ elevator or
2 warehouse. ~~Whenever~~ If a request for the examination of the accounts of any association,
3 copartnership, corporation, or limited liability company has been made to the
4 ~~commission~~ commissioner, as provided for in this section, ~~an examination thereafter~~
5 ~~shall~~ subsequent examinations must be made at least once every year until the ~~commission~~
6 ~~shall be~~ commissioner is requested to discontinue such examination by resolution adopted by
7 the partners, stockholders, or members at any annual meeting. ~~When~~ If such examination has
8 been made, the examiner shall report immediately the results ~~thereof~~ of the examination to the
9 president and the secretary of such association, copartnership, corporation, or limited liability
10 company and to the ~~commission~~ commissioner.

11 **SECTION 76. AMENDMENT.** Section 60-05-03 of the North Dakota Century Code is
12 amended and reenacted as follows:

13 **60-05-03. Certificate issued by ~~commission~~ commissioner after its examination of**
14 **accounts.**

15 If the ~~commission~~ commissioner is satisfied from ~~its~~ the commissioner's examination that the
16 person, association, copartnership, corporation, or limited liability company examined is solvent
17 and ~~its~~ the method of doing business is such as is likely to be beneficial to all of its members or
18 persons interested therein, the ~~commission~~ commissioner shall issue a certificate, countersigned
19 by the examiner, to the agent or manager. Such certificate ~~shall~~ must be kept posted
20 conspicuously in the warehouse or elevator of such person, association, copartnership,
21 corporation, or limited liability company and ~~shall~~ must state:

- 22 1. That said methods of doing business are sound.
- 23 2. That such person, association, copartnership, corporation, or limited liability company
24 is solvent.
- 25 3. That its books and accounts are kept properly.

26 If the affairs and methods of doing business of such person, association, copartnership,
27 corporation, or limited liability company ~~shall~~ do not seem sound or satisfactory to the
28 ~~commission,~~ it commissioner, the commissioner shall issue a certificate or statement,
29 countersigned by the person who made the examination, stating in what particular and in what
30 respect the business methods practiced or methods of keeping books and accounts of such
31 person, association, copartnership, corporation, or limited liability company are not deemed

1 safe. The ~~commissioner~~commissioner shall mail a copy of said~~the~~ statement or certificate to each
2 of such shareholders or stockholders as may have requested the ~~commissioner~~commissioner to
3 make such examination. The ~~commissioner~~commissioner also shall send a copy thereof to the
4 president and the secretary of such association, copartnership, corporation, or limited liability
5 company.

6 **SECTION 77. AMENDMENT.** Section 60-05-04 of the North Dakota Century Code is
7 amended and reenacted as follows:

8 **60-05-04. Fees of examiner for installing and examining accounting system.**

9 For making installation of a uniform accounting system and examining the financial
10 accounts of an elevator or public warehouse, an association, copartnership, corporation, or
11 limited liability company shall pay the examiner a reasonable fee, as determined by the
12 ~~commissioner~~commissioner. In case any such association, copartnership, corporation, or limited
13 liability company shall wrongfully refuse or neglect to pay such fees, then the
14 ~~commissioner~~commissioner may cancel the license to do business. All such fees shallmust be
15 paid into the state treasury. The expenses incurred by the examiner under the provisions of this
16 chapter shall be paid out of the appropriations made by the legislative assembly for this purpose
17 and such expenses shallmust be audited and paid in the same manner as other expenses are
18 audited and paid.

19 **SECTION 78. AMENDMENT.** Section 60-06-05 of the North Dakota Century Code is
20 amended and reenacted as follows:

21 **60-06-05. Sidetracks to be provided by ~~railroad company on its land.~~**

22 Every railroad company or corporation organized under the laws of this state or doing
23 business ~~therein~~in this state, upon application in writing, shall provide reasonable sidetrack
24 facilities and running connections between its main track and elevators and warehouses upon
25 or contiguous to its right of way at such stations. Every such railroad corporation shall permit
26 connections to be made and maintained in a reasonable manner with its sidetracks to and from
27 any warehouse or elevator without reference to its size, cost, or capacity, ~~whereif~~where grain or
28 potatoes are or may be stored. The railroad company is not required to construct or furnish any
29 sidetracks except upon its own land or right of way. Such elevators and warehouses may not be
30 constructed within one hundred feet [30.48 meters] of any existing structure and must be at safe
31 fire distance from the station buildings so as not to conflict essentially with the safe and

1 convenient operation of the road. ~~Where~~if stations are ten miles [16.09 kilometers] or more
2 apart the railroad company, ~~when~~if required so to do by the ~~public-service-~~
3 ~~commission~~commissioner, shall construct and maintain a sidetrack for the use of shippers
4 between such stations.

5 **SECTION 79. AMENDMENT.** Section 60-06-06.1 of the North Dakota Century Code is
6 amended and reenacted as follows:

7 **60-06-06.1. Determination - ~~Appropriation~~Expenses.**

8 Any party may petition the ~~public-service-commission~~commissioner to determine rights
9 governed under this chapter. The ~~commission~~commissioner shall determine the matter in
10 accordance with chapter 28-32 and the parties' rights of appeal are as limited by chapter 28-32.
11 The value of a leaseholder's improvements may not be considered in determining a reasonable
12 lease rate or selling price. The parties to such a proceeding shall pay the expenses of the
13 proceeding, as determined by the ~~commission~~commissioner, directly to the entities owed. The
14 ~~commission~~commissioner may adopt rules to carry out this section.

15 **SECTION 80. AMENDMENT.** Section 60-10-01 of the North Dakota Century Code is
16 amended and reenacted as follows:

17 **60-10-01. Credit-sale contracts - Assessment on grain - Submission of assessment.**

18 An assessment at the rate of two-tenths of one percent is placed on the value of all grain
19 sold in this state under a credit-sale contract, as provided for in sections 60-02-19.1 and
20 60-02.1-14. The licensee purchasing the grain shall note the assessment on the contract
21 required under sections 60-02-19.1 and 60-02.1-14 and shall deduct the assessment from the
22 purchase price payable to the seller. The licensee shall submit any assessment collected under
23 this section to the ~~public-service-commission~~commissioner no later than thirty days after each
24 calendar quarter. The ~~commission~~commissioner shall deposit the assessments received under
25 this section in the credit-sale contract indemnity fund.

26 **SECTION 81. AMENDMENT.** Section 60-10-02 of the North Dakota Century Code is
27 amended and reenacted as follows:

28 **60-10-02. Credit-sale contract indemnity fund - Creation - Continuing appropriation.**

29 There is created in the state treasury the credit-sale contract indemnity fund. The state
30 treasurer shall invest available moneys in the fund in accordance with section 21-10-07 and in
31 cooperation with the ~~public-service-commission~~commissioner and shall deposit any income

1 earned through the investments into the fund. The fund and earnings of the fund are
2 appropriated to the ~~public service commission~~commissioner on a continuing basis to be used
3 exclusively to carry out the intent and purpose of this chapter.

4 **SECTION 82. AMENDMENT.** Section 60-10-03 of the North Dakota Century Code is
5 amended and reenacted as follows:

6 **60-10-03. Credit-sale contract indemnity fund - Suspension of assessment.**

7 At the end of the calendar quarter in which the credit-sale contract indemnity fund reaches a
8 level of six million dollars, the ~~public service commission~~commissioner shall suspend collection
9 of the assessment required by this chapter. If after suspension of collection the balance in the
10 fund is less than three million dollars, the ~~public service commission~~commissioner shall require
11 collection of the assessment.

12 **SECTION 83. AMENDMENT.** Section 60-10-05 of the North Dakota Century Code is
13 amended and reenacted as follows:

14 **60-10-05. Credit-sale contract indemnity fund - Availability of money.**

15 Upon the insolvency of a licensed warehouse or a grain buyer and a declaration that the
16 ~~public service commission~~commissioner serve as the trustee, the ~~public service-~~
17 ~~commission~~commissioner shall make the proceeds of the credit-sale contract indemnity fund
18 available for use in meeting the licensee's obligations with respect to the reimbursement of any
19 person who sold grain to the licensee under a credit-sale contract and who was not fully
20 compensated in accordance with the contract.

21 **SECTION 84. AMENDMENT.** Section 60-10-07 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **60-10-07. Credit-sale contract indemnity fund - Prorated claims.**

24 If claims for indemnity payments from the credit-sale contract indemnity fund exceed the
25 amount in the fund, the ~~public service commission~~commissioner shall prorate the claims and
26 pay the prorated amounts. As future assessments are collected, the ~~public service-~~
27 ~~commission~~commissioner shall continue to forward indemnity payments to each eligible person
28 until the person receives the maximum amount payable in accordance with this chapter.

29 **SECTION 85. AMENDMENT.** Section 60-10-08 of the North Dakota Century Code is
30 amended and reenacted as follows:

1 **60-10-08. Reimbursement for later insolvencies.**

2 The ~~public service commission~~commissioner shall ensure that all persons eligible for
3 payment from the indemnity fund as a result of an insolvency are fully compensated to the
4 extent permitted by this chapter before any payments from the indemnity fund are initiated as a
5 result of a later insolvency. The chronological order of insolvencies is determined by the date
6 the ~~public service commission~~commissioner is appointed trustee under section 60-02.1-29 or
7 60-04-03.

8 **SECTION 86. AMENDMENT.** Section 60-10-09 of the North Dakota Century Code is
9 amended and reenacted as follows:

10 **60-10-09. Credit-sale contract indemnity fund - Reimbursement for administrative**
11 **expenses.**

12 Any expense incurred by the ~~public service commission~~commissioner in administering the
13 credit-sale contract indemnity must be reimbursed from the fund before any other claim for
14 indemnity is paid.

15 **SECTION 87. AMENDMENT.** Section 60-10-10 of the North Dakota Century Code is
16 amended and reenacted as follows:

17 **60-10-10. Credit-sale contract indemnity fund assessment - Failure to collect**
18 **assessment - Penalty.**

19 Any person who knowingly or intentionally refuses or fails to collect the assessment
20 required under this chapter from producers or to submit any assessment collected from
21 producers to the ~~public service commission~~commissioner for deposit in the credit-sale contract
22 indemnity fund is guilty of a class A misdemeanor.

23 **SECTION 88. AMENDMENT.** Section 60-10-11 of the North Dakota Century Code is
24 amended and reenacted as follows:

25 **60-10-11. Revocation and suspension.**

26 The ~~commission~~commissioner may suspend or revoke the license of any licensee for cause
27 upon notice and hearing for violation of this chapter.

28 **SECTION 89. AMENDMENT.** Section 60-10-12 of the North Dakota Century Code is
29 amended and reenacted as follows:

1 **60-10-12. Cease and desist.**

2 If a person engages in an activity or practice that is contrary to this chapter or rules adopted
3 by the ~~commission~~commissioner, the ~~commission~~commissioner, upon ~~its~~the commissioner's
4 own motion without complaint and with or without a hearing, may order the person to cease and
5 desist from the activity until further order of the ~~commission~~commissioner. The order may
6 include any corrective action up to and including license suspension. A cease and desist order
7 must be accompanied by a notice of opportunity to be heard on the order within fifteen days of
8 the issuance of the order.

9 **SECTION 90. AMENDMENT.** Section 60-10-14 of the North Dakota Century Code is
10 amended and reenacted as follows:

11 **60-10-14. Subrogation.**

12 Money paid from the credit-sale contract indemnity fund in satisfaction of a valid claim
13 constitutes a debt obligation of the person against whom the claim was made. The
14 ~~commission~~commissioner may take action on behalf of the fund against a person to recover the
15 amount of payment made, plus costs and attorney's fees. Any recovery for reimbursement to
16 the fund must include interest computed at the weight average prime rate charged by the Bank
17 of North Dakota. Upon payment of a claim from the credit-sale contract indemnity fund, the
18 claimant shall subrogate ~~its~~the interest of the claimant, if any, to the ~~commission~~commissioner
19 in a cause of action against all parties, to the amount of the loss that the claimant was
20 reimbursed by the fund.

21 **SECTION 91. AMENDMENT.** Section 60-10-15 of the North Dakota Century Code is
22 amended and reenacted as follows:

23 **60-10-15. Unlicensed facility-based grain buyer.**

24 This chapter also applies to a facility-based grain buyer, as defined in section 60-02.1-01,
25 which is licensed under the United States Warehouse Act but which does not possess a state
26 grain buyer license. The ~~commission~~commissioner has the duty and power to examine and
27 inspect, during regular business hours, all books, documents, and records related to collections
28 and remittances pertaining to the credit-sale contract indemnity fund. In the case of insolvency,
29 credit-sale contract payments to valid claimants must be reduced by an amount equal to the
30 credit-sale contract indemnity payments received from payments administered by the United
31 States department of agriculture.
