

**FIRST ENGROSSMENT
with House Amendments
ENGROSSED SENATE BILL NO. 2016**

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the office of the
2 adjutant general; to provide an appropriation to the state treasurer; to amend and reenact
3 sections 37-07.1-03 and 37-07.2-01 and subsection 6 of section 57-51.1-07.5 of the North
4 Dakota Century Code, relating to the national guard tuition waiver, national guard tuition grants,
5 and the state share of oil and gas taxes deposited in the state disaster relief fund; to provide for
6 a transfer; to provide for a report; to provide a statement of legislative intent; to provide an
7 exemption; to provide an effective date; and to declare an emergency.

8 BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:

9 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
10 as may be necessary, are appropriated out of any moneys in the general fund in the state
11 treasury, not otherwise appropriated, and from special funds derived from federal funds and
12 other income, to the office of the adjutant general for the purpose of defraying the expenses of
13 the office of the adjutant general, for the biennium beginning July 1, 2019, and ending June 30,
14 2021, as follows:

16 The 2019-21 biennium one-time funding amounts are not a part of the entity's base budget
17 for the 2021-23 biennium. The adjutant general shall report to the appropriations committees of
18 the sixty-seventh legislative assembly on the use of this one-time funding for the biennium
19 beginning July 1, 2019, and ending June 30, 2021.

20 **SECTION 3. VETERANS' CEMETERY MAINTENANCE FUND - APPROPRIATION.** In
21 addition to the amount appropriated to the adjutant general in the veterans' cemetery line item
22 in subdivision 1 of section 1 of this Act, there is appropriated any additional funds that are
23 received and deposited in the veterans' cemetery maintenance fund pursuant to sections
24 37-03-14 and 39-04-10.10 for the operation of the North Dakota veterans' cemetery for the
25 biennium beginning July 1, 2019, and ending June 30, 2021.

26 **SECTION 4. APPROPRIATION - 2017-19 BIENNIUM - STATE DISASTER RELIEF FUND**
27 **- STATE TREASURER - DISTRIBUTIONS TO NON-OIL-PRODUCING COUNTIES.** Due to
28 extraordinary snowfall in 2019 in the eastern part of the state and due to the excessive cost of
29 road maintenance in the western part of the state, there is appropriated out of any moneys in
30 the state disaster relief fund in the state treasury, not otherwise appropriated, the sum of
31 \$8,100,000, or so much of the sum as may be necessary, to the state treasurer for the purpose

1 of providing distributions to non-oil-producing counties for the benefit of the organized and
2 unorganized townships within each non-oil-producing county, for the period beginning with the
3 effective date of this Act, and ending June 30, 2019. In June 2019, the state treasurer shall
4 distribute \$8,100,000, or so much of the sum as may be necessary, to non-oil-producing
5 counties for the benefit of the organized and unorganized townships within each
6 non-oil-producing county. The distribution to each non-oil-producing county must provide for an
7 allocation of \$5,000 to each organized and unorganized township within the county. The amount
8 allocated to organized townships under this section must be paid by the county treasurer to
9 each organized township. The amount allocated to unorganized townships under this section
10 must be credited by the county treasurer to a special fund for unorganized township roads. The
11 distributions under this section must be used for the maintenance and improvement of township
12 paved and unpaved roads and bridges. A township is not eligible for an allocation of funds
13 under this section if the township does not maintain any township roads. For the purposes of
14 this section, a "non-oil-producing county" means a county that has received no allocation of
15 funding or a total allocation of funding under subsection 2 of section 57-51-15 of less than
16 \$5,000,000 for the period beginning September 1, 2017, and ending August 31, 2018.

17 **SECTION 5. ESTIMATED INCOME - STRATEGIC INVESTMENT AND IMPROVEMENTS**

18 **FUND.** The estimated income line item in subdivision 1 of section 1 of this Act includes
19 \$600,000 of one-time funding from the strategic investment and improvements fund for the
20 camp Grafton expansion. The estimated income line item in subdivision 2 of section 1 of this Act
21 includes \$1,902,253 of one-time funding from the strategic investment and improvements fund
22 for computer-aided dispatch equipment, message switch system upgrades, and 911 dispatching
23 service operations due to a revenue shortfall.

24 **SECTION 6. CAMP GRAFTON EXPANSION - LEGISLATIVE INTENT.** It is the intent of the
25 sixty-sixth legislative assembly that:

26 1. The adjutant general purchase options during the period beginning with the effective
27 date of this Act and ending June 30, 2021, for the purchase or long-term lease of land
28 for the camp Grafton expansion, including the purchase of no more than one thousand
29 six hundred acres and the long-term lease of the remainder, not to exceed six
30 thousand acres in total.

1 2. If the adjutant general secures options to purchase or lease all necessary land for the
2 camp Grafton expansion, the sixty-seventh legislative assembly provide funding and
3 authority for the purchase or long-term lease of land for the camp Grafton expansion
4 during the biennium beginning July 1, 2021, and ending June 30, 2023.

5 3. The adjutant general not use eminent domain for the expansion of camp Grafton.

6 **SECTION 7. AMENDMENT.** Section 37-07.1-03 of the North Dakota Century Code is
7 amended and reenacted as follows:

8 **37-07.1-03. Tuition waiver - Terms.**

9 A qualifying member of the national guard who enrolls in any state-controlled school,
10 subject to rules adopted by the adjutant general, is entitled to receive a ~~twenty-five~~thirty-five
11 percent waiver of the tuition from the state-controlled school, conditioned on the adjutant
12 general having sufficient appropriations for tuition reimbursement under section 37-07.1-06.2.
13 The tuition waiver is valid only so long as the member of the national guard maintains
14 satisfactory performance with the guard, meets the qualification requirements of rules adopted
15 by the adjutant general, and pursues a course of study in a manner that satisfies the normal
16 requirements of the school.

17 **SECTION 8. AMENDMENT.** Section 37-07.2-01 of the North Dakota Century Code is
18 amended and reenacted as follows:

19 **37-07.2-01. National guard ~~tuition~~member grants and tuition waivers - Terms of**
20 **grants.**

21 Any

22 1. ~~Subject to legislative appropriation and rules adopted by the adjutant general, a~~
23 qualifying member of the national guard who enrolls in an accredited postsecondary
24 institution in North Dakota which is not controlled by the state ~~may, subject to the~~
25 ~~limitations of available appropriated funds and subject to national guard rules adopted~~
26 ~~by the adjutant general,~~ receive a grant in an amount not to exceed the cost of tuition
27 and fees for similar courses and credit hours for ~~each~~a qualifying member of the
28 national guard who is enrolled ~~at~~in the North Dakota university system
29 ~~school~~institution with the highest tuition and fee rate.

30 2. Any accredited postsecondary institution that ~~agrees to participate in such~~ is not
31 ~~controlled by the state and which participates in the national guard member grant~~

1 program ~~must~~shall waive twenty-five percent of the tuition ~~for that otherwise would be~~
2 charged to each enrolled, qualifying member of the national guardsmenguard. These
3 ~~grants must be distributed according to rules promulgated by the adjutant general and~~
4 ~~are available only so~~

5 3. The adjutant general shall adopt rules for distributing grants under this section and
6 establishing qualification requirements for grant recipients.

7 4. A member of the national guard may receive a grant under this section only as long as
8 the member maintains satisfactory performance with the national guard, meets the
9 qualification requirements of the rules adopted under this section, and pursues a
10 course of study ~~which satisfiessatisfying~~ the normal requirements of the
11 ~~school~~postsecondary institution in which the member is enrolled.

12 5. For purposes of calculating the grant amount under subsection 1, the "cost of tuition
13 and fees for similar courses and credit hours for a qualifying member of the national
14 guard who is enrolled in the North Dakota university system institution with the highest
15 tuition and fee rate" may not be reduced by more than twenty-five percent pursuant to
16 section 37-07.1-03.

17 **SECTION 9. AMENDMENT.** Subsection 6 of section 57-51.1-07.5 of the North Dakota
18 Century Code is amended and reenacted as follows:

19 6. The next ~~twenty~~fifteen million dollars into the state disaster relief fund, but not in an
20 amount that would bring the unobligated balance in the fund to more than
21 ~~twenty~~fifteen million dollars; and

22 **SECTION 10. MAINTENANCE AND REPAIRS - TRANSFERS.** The director of the office of
23 management and budget may transfer up to \$500,000 of appropriation authority to the
24 operating expenses and capital assets line items contained in section 1 of this Act from the
25 various other line items contained in section 1 of this Act, as requested by the adjutant general
26 to provide for the maintenance and repair of state-owned armories in this state during the
27 biennium beginning July 1, 2019, and ending June 30, 2021. The adjutant general shall notify
28 the legislative council of any transfers made pursuant to this section.

29 **SECTION 11. EXEMPTION.** Any amounts carried over in the radio communications line
30 item for the state radio tower package, in section 7 of chapter 15 of the 2017 Session Laws is
31 not subject to section 54-44.1-11 and any unexpended funds are available for completing these

1 projects or for technology upgrade costs required to implement the statewide interoperable
2 radio network during the biennium beginning July 1, 2019, and ending June 30, 2021.

3 **SECTION 12. EXEMPTION.** The amount appropriated in the tuition, recruiting, and
4 retention line item in subdivision 1 of section 1 of chapter 15 of the 2017 Session Laws is not
5 subject to section 54-44.1-11, and any unexpended funds from this appropriation may be used
6 to provide tuition assistance, recruiting, and retention incentives to eligible members of the
7 North Dakota national guard during the biennium beginning July 1, 2019, and ending June 30,
8 2021.

9 **SECTION 13. EXEMPTION.** Any amounts carried over pursuant to section 11 of chapter 15
10 of the 2017 Session Laws which are unexpended as of June 30, 2019, are not subject to
11 section 54-44.1-11 and are available for payment of adjusted compensation to veterans. Any
12 unexpended funds from this appropriation must be transferred to the veterans' cemetery trust
13 fund during the biennium beginning July 1, 2019, and ending June 30, 2021.

14 **SECTION 14. EXEMPTION.** The amount of \$300,000 from the strategic investment and
15 improvements fund appropriated in the operating expenses line item in subdivision 2 of
16 section 1 of chapter 15 of the 2017 Session Laws for mobile repeaters and programming radios
17 is not subject to section 54-44.1-11 and any unexpended funds from this appropriation may be
18 used to complete this project during the biennium beginning July 1, 2019, and ending June 30,
19 2021.

20 **SECTION 15. EFFECTIVE DATE.** Section 9 of this Act is effective for taxable events
21 occurring after June 30, 2019.

22 **SECTION 16. EMERGENCY.** Sections 4, 5, and 6 and the camp Grafton expansion and
23 tuition, recruiting, and retention line items in subdivision 1 of section 1 of this Act are declared to
24 be an emergency measure.
