## ENGROSSED HOUSE BILL NO. 1012

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of  
2 human services; to provide an appropriation to the state department of health; to provide an  
3 appropriation to the legislative council; to provide an appropriation to the office of management  
4 and budget; to create and enact a new section to chapter 1-02, two new ~~section~~sections to  
5 chapter 50-06, and a new section to chapter 50-24.1 of the North Dakota Century Code, relating  
6 to person-first language, substance use disorder treatment voucher system grants, a behavioral  
7 health bed management system, and medical assistance coverage of interpreter services; to  
8 create and enact a new paragraph to subdivision I of subsection 1 of section 50-11.1-22 of the  
9 North Dakota Century Code as created by section 8 of House Bill No. 1416, as approved by the  
10 sixty-seventh legislative assembly, relating to the North Dakota early childhood council  
11 membership; to amend and reenact sections 50-06-42, 50-11.1-14, 50-24.1-02.7, 50-24.1-31,  
12 and 50-24.1-37 of the North Dakota Century Code, relating to the substance use disorder  
13 voucher program, early childhood workforce development fees, Medicaid coverage for workers  
14 with disability coverage and families of children with disabilities, and the Medicaid expansion  
15 program; to repeal section 50-24.1-18.1 of the North Dakota Century Code, relating to  
16 consumer-directed health maintenance services; to provide an exemption; to provide a  
17 statement of legislative intent; to provide for a report; to provide for a study; to provide for a  
18 transfer; to provide for the conveyance of land; to provide an application; to provide for  
19 retroactive application; to provide an effective date; to provide an expiration date; and to declare  
20 an emergency.

21 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

22 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
23 as may be necessary, are appropriated out of any moneys in the general fund in the state  
24 treasury, not otherwise appropriated, and from special funds derived from federal funds and

1 other income, to the department of human services for the purpose of defraying the expenses of  
2 its various divisions, for the biennium beginning July 1, 2021, and ending June 30, 2023, as  
3 follows:

23       The 2021-23 biennium one-time funding amounts are not a part of the entity's base budget  
 24 for the 2023-25 biennium. The department of human services shall report to the appropriations  
 25 committees of the sixty-eighth legislative assembly on the use of this one-time funding for the  
 26 biennium beginning July 1, 2021, and ending June 30, 2023.

27       **SECTION 3. APPROPRIATION - 2019-21 BIENNIUM - DEPARTMENT OF HUMAN**  
 28 **SERVICES - FIRE PROTECTION AGREEMENTS - EXEMPTION.** There is appropriated out of  
 29 any moneys in the department of human services operating fund in the state treasury, not  
 30 otherwise appropriated, the sum of \$333,333, or so much of the sum as may be necessary, to  
 31 the department of human services for the purpose of providing a grant to a ~~political subdivision~~

1 ~~for the state share of costs relating to the purchase of a fire truck~~city located in a county of  
2 ~~fewer than 25,000 individuals and provides prevention and extinguishment of fires at the North~~  
3 ~~Dakota state hospital~~, for the period beginning with the effective date of this Act and ending  
4 June 30, 2021. The funding appropriated in this section is a one-time funding item. The  
5 requirements of chapter 54-44.4 do not apply to the selection of a grant recipient, the grant  
6 award, or payments made under this section. The department of human services ~~shall~~  
7 ~~discontinue any agreement with a political subdivision for fire protection services and~~ may not  
8 enter any future agreement with a political subdivision for fire protection services.

9 **SECTION 4. APPROPRIATION - STATE DEPARTMENT OF HEALTH.** There is  
10 appropriated out of any moneys in the general fund in the state treasury, not otherwise  
11 appropriated, the sum of \$281,715, or so much of the sum as may be necessary, and the sum  
12 of \$281,715 from special funds derived from grants, donations, and other income, to the state  
13 department of health for the purpose of providing a grant to the task force on the prevention of  
14 sexual abuse of children for staff and programming materials focused on primary prevention  
15 activities, for the biennium beginning July 1, 2021, and ending June 30, 2023.

16 **SECTION 5. APPROPRIATION - LEGISLATIVE MANAGEMENT STUDY - STATEWIDE**  
17 **ACUTE PSYCHIATRIC AND RESIDENTIAL CARE NEEDS.**

- 18 1. During the 2021-22 interim, the legislative management shall study the acute  
19 psychiatric hospitalization and related step down residential treatment and support  
20 needs of individuals with mental illness. The legislative management shall create an  
21 acute psychiatric treatment committee consisting of eight members to conduct the  
22 study. The legislative management chairman shall designate the committee chairman  
23 and vice chairman and the legislative council shall provide staff services for the  
24 committee. The committee must complete the study by October 1, 2022.
- 25 2. As part of the study, the committee shall gather input from stakeholders and other  
26 groups, including private hospitals, the department of human services, and mental  
27 health advocates.
- 28 3. The study must review options for a long-term plan for acute psychiatric hospitalization  
29 and related step down residential treatment and support needs in the state and short-  
30 term options during the next two bienniums to contract with private provider acute  
31 psychiatric care facilities to provide treatment services in four or more cities in the

1 state, workforce needs of such specific locations, and options to replace the existing  
2 state hospital facility with one or more treatment facilities focused on forensic  
3 psychiatric evaluation and treatment.

- 4 4. The committee, with the approval of the legislative management, may obtain  
5 consulting services to determine the total number of acute care beds needed in the  
6 state and to develop recommendations for private provider contracts, treatment  
7 requirements and outcome measures, locations in the state, including private and  
8 public facilities, the future use of facilities at the state hospital campus including the  
9 LaHaug building, and other items identified in subsection 3. The consulting services  
10 may also develop conceptual drawings for recommendations for a new state hospital.
- 11 5. The department of human services shall provide to the consultants and the committee  
12 a complete description of other outpatient and inpatient private and public behavioral  
13 health services, including substance use disorder facilities, existing in the state to  
14 prevent acute behavioral health hospitalization and to support patients following  
15 discharge from psychiatric hospitalization and related residential care.
- 16 6. The department of human services shall seek Medicaid plan amendments or Medicaid  
17 waivers to allow federal funding reimbursement for services provided in institutions for  
18 mental diseases to Medicaid beneficiaries between the ages of twenty-one and  
19 sixty-four.
- 20 7. The legislative management shall report its findings and recommendations, together  
21 with any legislation required to implement the recommendations, to the sixty-eighth  
22 legislative assembly.
- 23 8. There is appropriated out of any moneys in the general fund in the state treasury, not  
24 otherwise appropriated, the sum of \$500,000, or so much of the sum as may be  
25 necessary, to the legislative council for consulting services for the study identified in  
26 this section, for the period beginning with the effective date of this section, and ending  
27 June 30, 2023. The funding appropriated in the section is considered a one-time  
28 funding item.

29 **SECTION 6. APPROPRIATION - OFFICE OF MANAGEMENT AND BUDGET - CAPITOL**  
30 **BUILDING FUND.** There is appropriated out of any moneys in the capitol building fund in the  
31 state treasury, not otherwise appropriated, the sum of \$25,000, or so much of the sum as may

1 be necessary, to the office of management and budget for the purpose of utilizing a consultant  
2 to determine the compliance of the capitol building with 2010 Americans with Disabilities Act  
3 standards, for the biennium beginning July 1, 2021, and ending June 30, 2023. The funding  
4 appropriated in this section is considered a one-time funding item.

5 **SECTION 7. SPENDING RESTRICTION - 2021-23 BIENNIUM - FEDERAL MEDICAL**  
6 **ASSISTANCE PERCENTAGE.** The department of human services may not spend any general  
7 fund savings resulting from federal enhancements or adjustments that cause the federal  
8 medical assistance percentage to exceed the rates used by the sixty-seventh legislative  
9 assembly for budgeting purposes for the biennium beginning July 1, 2021, and ending June 30,  
10 2023.

11 **SECTION 8. FUNDING TRANSFERS - EXEMPTION - AUTHORIZATION - REPORT.**  
12 Notwithstanding section 54-16-04, the director of the office of management and budget shall  
13 transfer appropriation authority between line items within subdivisions 1, 2, and 3 of section 1 of  
14 this Act for the biennium beginning July 1, 2021, and ending June 30, 2023, as requested by the  
15 department of human services. The department of human services shall notify the legislative  
16 council of any transfer made pursuant to this section. The department shall report to the budget  
17 section after June 30, 2022, any transfer made in excess of \$50,000 and to the appropriations  
18 committees of the sixty-eighth legislative assembly regarding any transfers made pursuant to  
19 this section.

20 **SECTION 9. FUNDING TRANSFERS - EXEMPTION - AUTHORIZATION - REPORT.**  
21 Notwithstanding section 54-16-04, the director of the office of management and budget shall  
22 transfer appropriation authority from line items within subdivisions 1, 2, and 3 of section 1 of this  
23 Act to subdivision 4 of section 1 of this Act for the biennium beginning July 1, 2021, and ending  
24 June 30, 2023, as requested by the department of human services. The department of human  
25 services shall notify the legislative council of any transfer made pursuant to this section. The  
26 department shall report to the budget section after June 30, 2022, any transfer made in excess  
27 of \$50,000 and to the appropriations committees of the sixty-eighth legislative assembly  
28 regarding any transfers made pursuant to this section.

29 **SECTION 10. FULL-TIME EQUIVALENT POSITION - AGING SERVICES - LEGISLATIVE**  
30 **INTENT.** Section 1 of this Act includes one full-time equivalent position for the administration of  
31 services resulting from a federal department of justice lawsuit settlement. This position is



1 authorized only for the biennium beginning July 1, 2021, and ending June 30, 2023, and may  
2 not be included in the department's base budget for the biennium beginning July 1, 2023, and  
3 ending June 30, 2025. It is the intent of the sixty-seventh legislative assembly that future  
4 legislative assemblies retain and exercise unfettered discretion to appropriate funds as they  
5 deem appropriate without regard to the federal department of justice lawsuit settlement.

6 **SECTION 11. TRANSFER OF APPROPRIATION AUTHORITY.** Section 1 of this Act  
7 includes appropriation authority for the department of human services for the biennium  
8 beginning July 1, 2021, and ending June 30, 2023. On September 1, 2022, in accordance with  
9 provisions of House Bill No. 1247, as approved by the sixty-seventh legislative assembly, the  
10 office of management and budget shall transfer remaining appropriation authority contained in  
11 section 1 of this Act, and any remaining appropriation authority for the department of human  
12 services in other bills approved by the sixty-seventh legislative assembly, to the department of  
13 health and human services. The appropriation authority in section 1 of this Act and appropriation  
14 authority for the department of human services from any other bill that is transferred to the  
15 department of health and human services must be maintained and reported separately from  
16 other appropriation authority transferred to the department of health and human services.

17 **SECTION 12. ESTIMATED INCOME - FEDERAL CORONAVIRUS RELIEF FUND.** The  
18 estimated income line item in subdivision 2 of section 1 of this Act includes the sum of  
19 \$2,457,638 from the federal coronavirus relief fund for senior nutrition services and the sum of  
20 \$1,750,000 from the federal coronavirus relief fund for the community behavioral health  
21 program.

22 **SECTION 13. ESTIMATED INCOME - HUMAN SERVICE FINANCE FUND.** The estimated  
23 income line item in subdivision 4 of section 1 of this Act includes the sum of  
24 ~~\$187,385,888~~\$187,223,092 from the human service finance fund for state-paid economic  
25 assistance and social and human services.

26 **SECTION 14. ESTIMATED INCOME - COMMUNITY HEALTH TRUST FUND.** The  
27 estimated income line item in subdivision 2 of section 1 of this Act includes the sum of  
28 ~~\$24,000,000~~\$31,500,000 from the community health trust fund for defraying expenses in the  
29 medical services division.

30 **SECTION 15. ESTIMATED INCOME - HEALTH CARE TRUST FUND.** The estimated  
31 income line item in subdivision 2 of section 1 of this Act includes the sum of \$1,000,000 from

1 the health care trust fund and \$1,150,538 from federal funds for nursing facility operating  
2 margin adjustments.

3 **SECTION 16. CAPITAL PAYMENTS.** During the biennium beginning July 1, 2021, and  
4 ending June 30, 2023, the department of human services is authorized to expend funds for the  
5 payment of special assessments at the state hospital and life skills and transition center.

6 **SECTION 17. CAPITAL PROJECTS - ~~STATE HOSPITAL~~ - EMERGENCY COMMISSION**

7 **APPROVAL.** During the biennium beginning July 1, 2021, and ending June 30, 2023, the  
8 department of human services is authorized to proceed with the demolition of the chapel,

9 [administrative building](#), and employee building and associated tunnels at the state hospital.

10 Pursuant to section [48](#) of this Act, the director of the office of management and budget may  
11 transfer appropriation authority between line items within subdivisions 1, 2, and 3 of section 1 of  
12 this Act. The department may transfer funds for the demolition of the identified buildings and  
13 associated tunnels and for emergency capital projects. Notwithstanding section 54-27-12, the  
14 department of human services may spend up to \$5,000,000 for emergency projects under this  
15 section and may seek emergency commission approval to spend more than \$5,000,000 under  
16 this section.

17 **SECTION 18. PERMANENT SUPPORTIVE HOUSING GRANTS.** Subdivision 2 of  
18 section 1 of this Act includes the sum of \$4,672,536 from the general fund for permanent  
19 supportive housing grants. The department of human services shall develop a funding  
20 methodology to distribute the funding to qualified entities that utilize best practices for  
21 permanent supportive housing, provide recovery-oriented and person-centered services, submit  
22 process and outcome measures to the department, and authorize the department to conduct  
23 onsite visits to review program operations.

24 **SECTION 19. EMERGENCY STABILIZATION GRANTS - DEVELOPMENTAL**  
25 **DISABILITIES WAIVER.**

26 1. Subdivision 2 of subsection 1 of this Act includes the sum of \$125,000 from the  
27 general fund for the purpose of providing emergency stabilization grants to  
28 developmental disability in-home support providers to support the sustainability of  
29 newly licensed providers within the developmental disability provider network. To be  
30 eligible to receive an emergency stabilization grant, a licensed developmental  
31 disability in-home support provider must be in operation as of October 1, 2020, with an

1 initial license date of October 15, 2015, or later, and comply with grant requirements  
2 established by the department of human services. The requirements of chapter  
3 54-44.4 do not apply to the selection of a grantee, the grant award, or payments made  
4 under this section.

- 5 2. The department of human services shall include in-home support providers in future  
6 appendix K applications, to allow eligibility for retainer payments in a manner  
7 equivalent to day support services.

8 **SECTION 20. REFUGEE RESETTLEMENT SERVICES - LEGISLATIVE MANAGEMENT**

9 **REPORT.** Subdivision 2 of section 1 of this Act includes the sum of \$6,069,408 of federal funds  
10 for the refugee resettlement program. The department of human services shall collaborate with  
11 applicable federal and private placement agencies to develop a plan to resettle refugees in at  
12 least five geographically diverse communities in the state outside of the existing resettlement  
13 communities with a goal of resettling twenty-five percent of new refugees outside of existing  
14 resettlement communities. During the 2021-22 interim, the department of human services shall  
15 provide a report to the legislative management regarding refugee resettlement services.

16 **SECTION 21. EXPENDITURES MAY NOT EXCEED APPROPRIATION - MEDICAL**  
17 **ASSISTANCE EXPANSION PROGRAM - APPLICATION.**

- 18 1. Subdivision 2 of section 1 of this Act includes the sum of \$703,317,464, of which  
19 \$80,934,488 is from the general fund, for the medical assistance expansion program  
20 for the biennium beginning July 1, 2021, and ending June 30, 2023. The expenditures  
21 for individuals eligible for the medical assistance expansion program may not exceed  
22 this amount. For purposes of this section:

4 to the provisions of section 54-44.1-11. Any unexpended funds from this appropriation are  
5 available for the completion of the grant to an entity to develop a hyperbaric oxygen therapy  
6 pilot program during the biennium beginning July 1, 2021, and ending June 30, 2023.

7       **SECTION 51. EXEMPTION.** The sum of \$572,000 from the strategic investment and  
8 improvements fund appropriated to the department of human services for the purpose of a roof  
9 replacement project at the state hospital in chapter 37 of the 2019 Session Laws is not subject  
10 to the provisions of section 54-44.1-11. Any unexpended funds from this appropriation are  
11 available for the completion of the roof replacement project at the state hospital during the

13       **SECTION 52. EXEMPTION.** The amount appropriated for the development of the electronic

21       **SECTION 58. LEGISLATIVE INTENT - PROVIDER RATE INCREASE.** Section 1 of this Act  
22 includes funding for human service provider inflation increases of two percent the first year and  
23 one-quarter of one percent the second year of the biennium beginning July 1, 2021, and ending  
24 June 30, 2023. It is the intent of the sixty-seventh legislative assembly that future special  
25 sessions of the sixty-seventh legislative assembly consider an additional second year  
26 inflationary increase during the 2021-23 biennium based on any extensions of the enhanced  
27 federal Medicaid assistance percentage and a review of budget needs of all areas of the  
28 department of human services.

29       **SECTION 59. REPORT TO LEGISLATIVE MANAGEMENT - EARLY AND PERIODIC**  
30 **SCREENING, DIAGNOSTIC, AND TREATMENT PROGRAM.** During the 2021-22 interim, the  
31 department of human services shall conduct a study of the early and periodic screening,

1 diagnostic, and treatment program and prepare a report. The department of human services  
2 may contract with a consultant to assist in the study and the preparation of the report. The  
3 report shall include data on the number, ages, and geographic locations of children receiving  
4 screening, diagnostic, and treatment services; the capacity of the program to ensure all children  
5 who require screening, diagnostic, and treatment services are identified and receive services;  
6 data on the disposition of referrals of children who are screened and eligible for diagnostic and  
7 treatment services, including how many receive services and how many do not receive those  
8 services by county; an assessment of the program's efforts to provide comprehensive screening  
9 and treatment for children as required by federal law; an assessment of the deficits of the  
10 program's efforts to provide comprehensive screening and treatment as required by federal law;  
11 recommendations to ensure or expand services so that all eligible children are adequately

15 **SECTION 60. REPORT TO LEGISLATIVE MANAGEMENT - REVISED PAYMENT**

16 **METHODOLOGY FOR BASIC CARE FACILITIES.** The department of human services, in  
17 collaboration with basic care providers and other representatives of the basic care industry,  
18 shall develop a report for payment methodology revisions for basic care facilities that must  
19 include recommendations for:

- 20 1. Methods of reimbursement for basic care facility cost categories, including direct care,  
21 indirect care, room and board, and property; and
- 22 2. The feasibility of standardizing payments for basic care facilities in the same peer  
23 group.

24 Before October 1, 2022, the department shall present the report to the legislative management  
25 regarding the revised payment methodology. The estimated costs related to the implementation

30 shall provide reports to the legislative management regarding the status of four-year old

1 program approvals, the North Dakota early childhood council, and the early childhood grant for  
2 best in class four-year old experiences.

3 **SECTION 62. SUBSTANCE USE DISORDER TREATMENT VOUCHERS - REPORT TO**  
4 **BUDGET SECTION.** During the 2021-22 interim, the department of human services behavioral  
5 health division shall submit quarterly reports to the budget section on the status of the  
6 substance use disorder treatment voucher system program, including data on the utilization of  
7 the program, data on program expenditures, and an estimate of the number of months of  
8 funding remaining in the program.

9 **SECTION 63. TRANSFER OF EMPLOYEES.** The department of human services may use  
10 the identified twenty-seven full-time equivalent child care licensing positions of the human  
11 service zone transferred to the department pursuant to chapter 391 of the 2019 Session Laws  
12 for child care licensing, quality control, and early childhood administration.

13 **SECTION 64. RETROACTIVE APPLICATION.** Section 25 of this Act applies retroactively to  
14 July 1, 2020.
