1 A BILL for an Act to create and enact a new subdivision to subsection 2 of section 12-60-24, a  
2 new section to chapter 16.1-01, sections 16.1-07-13.1 and 16.1-12-10, and a new section to  
3 chapter 54-09 of the North Dakota Century Code, relating to election administration; to amend  
4 and reenact subsection 1 of section 16.1-01-01, sections 16.1-01-03, 16.1-01-05.1, 16.1-01-06,  
5 16.1-01-07, and 16.1-01-08, subsection 5 of section 16.1-01-09, subsection 7 of section  
6 16.1-01-09.1, sections 16.1-01-12, 16.1-01-16, and 16.1-01-17, the new section to chapter  
7 16.1-01 of the North Dakota Century Code as created by section 1 of House Bill No. 1256, as  
8 approved by the sixty-seventh legislative assembly, sections 16.1-02-01, 16.1-02-02,  
9 16.1-02-05, 16.1-02-06, 16.1-02-07, 16.1-02-10, 16.1-02-11, and 16.1-02-13, subsection 2 of

23 16.1-16-04, 16.1-16-05, and 16.1-16-07 of the North Dakota Century Code, relating to election  
24 administration; to repeal sections 16.1-06-10.1, 16.1-07-11, 16.1-07-13, and 16.1-13-24 of the

1 North Dakota Century Code, relating to election administration and the removal of obsolete  
2 language; and to provide a penalty.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1.** A new subdivision to subsection 2 of section 12-60-24 of the North Dakota  
5 Century Code is created and enacted as follows:

6 The secretary of state for employees with access to personally identifying  
7 information of residents or businesses of the state or with access to elections  
8 systems that are critical infrastructure under section 44-04-24.

9 **SECTION 2.** A new section to chapter 16.1-01 of the North Dakota Century Code is created  
10 and enacted as follows:

11 **Definitions.**

12 For purposes of this title, unless the context otherwise requires, "candidate" means:

- 13 1. An individual holding public office;
- 14 2. An individual who publicly has declared that individual's candidacy for nomination for  
15 election or election to public office or has filed or accepted a nomination for public  
16 office;
- 17 3. An individual who has formed a campaign or other committee for that individual's  
18 candidacy for public office;
- 19 4. An individual who has circulated a nominating petition to have that individual's name  
20 placed on the ballot; and
- 21 5. An individual who, in any manner, has solicited or received a contribution for that  
22 individual's candidacy for public office, whether before or after the election for that  
23 office.

24 **SECTION 3. AMENDMENT.** Subsection 1 of section 16.1-01-01 of the North Dakota  
25 Century Code is amended and reenacted as follows:

- 26 1. The secretary of state ~~must be~~ is, ex officio, supervisor of elections and may employ  
27 additional personnel to administer this title. The secretary of state shall supervise the  
28 conduct of elections and in that supervisory capacity has, in addition to other powers  
29 conferred by law, the power to examine upon the secretary of state's request or the  
30 request of any election official, any election ballot or other material, ~~electronic~~ voting

1 system ~~or counting machine~~ authorized by chapter 16.1-06, or device used in  
2 connection with any election, for the purpose of determining sufficient compliance with  
3 the law and established criteria and standards adopted by the secretary of state  
4 according to section 16.1-06-26. The secretary of state, upon determining ~~that any~~  
5 ballot or other material, ~~electronic voting system or counting machine~~, or device is not  
6 in sufficient compliance with the law or established criteria and standards, shall direct  
7 the proper changes to be made, and in the case of ~~electronic voting systems and~~  
8 ~~counting machines~~, may decertify the electronic voting systems ~~and counting~~  
9 ~~machines~~ according to the rules adopted under section 16.1-06-26.

10 **SECTION 4. AMENDMENT.** Section 16.1-01-03 of the North Dakota Century Code is  
11 amended and reenacted as follows:

12 **16.1-01-03. Opening and closing of the polls.**

13 The polls at all primary, general, and special elections must be opened at nine a.m. or  
14 earlier, but not earlier than seven a.m., as designated for any precinct by resolution of the  
15 governing body of the city or county in which the precinct is located. The polls must remain  
16 open continuously until seven p.m. or ~~such~~ later hour, not later than nine p.m., as may be  
17 designated for a precinct by resolution of the governing body of the city or county in which the  
18 precinct is located. All electors standing in line to vote at the time the polls are set to close must  
19 be allowed to vote, but electors arriving after closing time may not be allowed to vote. A voter  
20 may take up to thirty minutes to mark and cast the ballot after receiving the ballot from the  
21 election judge. After the polls close, the election board shall generate the report of the vote  
22 totals not later than thirty minutes after the last elector in line at the closing time received a  
23 ballot. An elector remaining in the polling place after the thirty minutes have expired who has  
24 not completed marking the ballot must be offered the choice of casting the ballot as marked or  
25 continuing to mark the ballot. If the elector chooses to continue marking the ballot, the ballot  
26 selections must be excluded from the report of the vote totals generated by the election board  
27 but must be forwarded by the election board to the canvassing board and added to the final  
28 tally. The secretary of state shall develop uniform, mandatory procedures for election boards to  
29 ensure the secrecy of each elector's ballot. The election officers present are responsible for  
30 determining who arrived in time to vote, and the election officers shall establish appropriate  
31 procedures for making that determination. All determinations required to be made pursuant to

1 this section relating to polling hours must be made, and the county auditor notified of ~~them~~the  
2 determinations, no later than thirty days ~~prior to~~before an election.

3 **SECTION 5. AMENDMENT.** Section 16.1-01-05.1 of the North Dakota Century Code is  
4 amended and reenacted as follows:

5 **16.1-01-05.1. Voter lists - Addition or transfer of names.**

6 Through the use of the central voter file provided for in chapter 16.1-02, the secretary of  
7 state shall establish a procedure by which a county auditor may transfer ~~a person's~~an  
8 individual's name from the voter list of one precinct to the voter list of another precinct in the  
9 state if ~~that person~~the individual establishes a new residence, and by which ~~a person~~an  
10 individual who establishes residence in the state may have ~~that person's~~the individual's name  
11 placed on the voter list in the appropriate precinct. The procedure provided for in this section  
12 may not be used to require the registration of electors.

13 **SECTION 6. AMENDMENT.** Section 16.1-01-06 of the North Dakota Century Code is  
14 amended and reenacted as follows:

15 **16.1-01-06. Highest number of votes elects.**

16 Unless otherwise expressly provided by the laws of this state, in all elections for the choice  
17 of any officer, the ~~person~~individual receiving the highest number of votes for any office ~~must~~  
18 be deemed ~~to have been~~ elected to that office.

19 **SECTION 7. AMENDMENT.** Section 16.1-01-07 of the North Dakota Century Code is  
20 amended and reenacted as follows:

21 **16.1-01-07. Constitutional amendments and other questions to be advertised -**  
22 **Notification by secretary of state - Manner of publishing.**

23 ~~Whenever~~If a proposed constitutional amendment or other question is to be submitted to  
24 the people of the state for popular vote, the secretary of state shall, ~~not less than fifty-five days~~  
25 ~~before the election,~~ certify the amendment or other question to each county auditor not less  
26 than fifty-five days before the election, and each auditor shall cause notice ~~thereof~~of the  
27 question to be included in the notice required by section 16.1-13-05. Questions to be submitted  
28 to the people of a particular county must be advertised in the same manner.

29 ~~The~~At the same time the secretary of state certifies notice to the county auditors of the  
30 submission of a constitutional amendment or other question, the secretary of state shall, ~~at the~~  
31 ~~same time the secretary of state certifies notice to the county auditors of the submission of a~~

1 constitutional amendment or other question, certify the ballot form for such ~~the~~ questions. The  
2 ballot form must conform to the provisions of section 16.1-06-09 and must be used by all county  
3 auditors in ~~preparing to prepare~~ prepare ballots for submission to the electorate of each county and in  
4 ~~the preparation of to prepare~~ sample ballots. ~~Any requirements in this title that a sample ballot~~  
5 ~~be published will be met by the~~ The publication of either the paper ballot or the ballot as it will  
6 appear to ~~persons~~ individuals using an ~~electronic~~ a voting system device, depending  
7 ~~upon~~ whichever corresponds to the method of voting used in the area involved, will satisfy any  
8 requirement in this title for a sample ballot to be published. Absentee voter ballots may not be  
9 considered in determining which method of voting is used in an area. If both paper ballots and  
10 electronic voting system ballots are used in an area, both forms must be published as sample  
11 ballots to meet publication and notice requirements. For two consecutive weeks before the  
12 sample ballot is published, an analysis of any constitutional amendment, initiated measure, or  
13 referred measure, written by the secretary of state after consultation with the attorney general,  
14 must be published in columns to enable the electors to become familiar with the effect of the  
15 proposed constitutional amendment or initiated or referred measure.

16 **SECTION 8. AMENDMENT.** Section 16.1-01-08 of the North Dakota Century Code is  
17 amended and reenacted as follows:

18 **16.1-01-08. Correcting errors on ballots - Requiring performance of duty - Correcting**  
19 **or prosecuting wrongful performance.**

20 1. The secretary of state shall ~~thoroughly~~ thoroughly investigate thoroughly, when the matter comes  
21 to the secretary of state's attention, any of the following:

22 1. a. Any error or omission ~~which~~ that has occurred or is about to occur in the placing  
23 of any name on an official election ballot; however a factual dispute regarding a  
24 candidate's residency may be resolved only by a court order.

25 2. b. Any error ~~which~~ that has been or is about to be committed in printing the ballot.

26 3. c. Any wrongful act ~~which~~ that has been or is about to be done by any judge or  
27 election clerk, county auditor, canvassing board, a canvassing board member, or  
28 any other ~~person~~ individual charged with any duty concerning the election.

29 4. d. Any neglect of duty which has occurred or is about to occur.

30 2. If required, the secretary of state shall order the officer or ~~person~~ individual charged  
31 with ~~such~~ the error, wrong, or neglect to correct the error, desist from the wrongful act,

1 or perform any required duty. The secretary of state may call upon any county auditor  
2 for aid in ~~investigation and correction of~~investigating and correcting the problem. The  
3 secretary of state shall cause any ~~person~~individual who violates the secretary of  
4 state's order to be prosecuted; if the violation constitutes an offense pursuant to this  
5 chapter. If the administrative remedies fail to correct the problem, or if the secretary of  
6 state refuses to act, any ~~person~~individual may petition the supreme court, or the  
7 district court of the relevant county ~~where~~if the election of a county officer is involved,  
8 for an order compelling the correction of the error, wrong, neglect, or act.

9 **SECTION 9. AMENDMENT.** Subsection 5 of section 16.1-01-09 of the North Dakota  
10 Century Code is amended and reenacted as follows:

11 5. When signed petitions are delivered to the secretary of state, the chairperson of the  
12 sponsoring committee shall submit to the secretary of state an affidavit stating that to  
13 the best of that individual's knowledge, the petitions contain at least the required  
14 number of signatures. The chairperson also shall submit a complete list of petition  
15 circulators which must include each circulator's full name and residential address. The  
16 residential address must be in this state and identify the circulator's street address,  
17 city, and zip code. Upon submission of the petitions to the secretary of state, the  
18 petitions are considered filed and may not be returned to the sponsoring committee for  
19 the purpose of continuing the circulation process or resubmitting the petitions at a later  
20 time. An elector's name may not be removed by the elector from a petition that has  
21 been submitted to and received by the secretary of state.

22 **SECTION 10. AMENDMENT.** Subsection 7 of section 16.1-01-09.1 of the North Dakota  
23 Century Code is amended and reenacted as follows:

24 7. When recall petitions are delivered to the secretary of state or other filing officer with  
25 whom a petition for nomination to the office in question is filed, the chairman of the  
26 sponsoring committee shall submit to the secretary of state or other filing officer an  
27 affidavit stating that to the best of that individual's knowledge, the petitions contain at  
28 least the required number of signatures. The chairperson also shall submit a complete  
29 list of petition circulators which must include each circulator's full name and residential  
30 address. The residential address must be in this state and identify the circulator's  
31 street address, city, and zip code. Upon submission of the petitions to the appropriate

1 filing officer, the petitions are considered filed and may not be returned to the chairman  
2 of the sponsoring committee for the purpose of continuing the circulation process or  
3 resubmitting the petitions at a later time. An elector's name may not be removed by  
4 the elector from a recall petition that has been submitted to and received by the  
5 appropriate filing officer.

6 **SECTION 11. AMENDMENT.** Section 16.1-01-12 of the North Dakota Century Code is  
7 amended and reenacted as follows:

8 **16.1-01-12. Election offenses - Penalty.**

- 9 1. It is unlawful for an individual, measure committee as described in section  
10 16.1-08.1-01, or other organization to:
- 11 a. Fraudulently alter another individual's ballot or substitute one ballot for another,  
12 or to otherwise defraud a voter of that voter's vote.
  - 13 b. Obstruct a qualified elector on the way to a polling place.
  - 14 c. Vote more than once in any election.
  - 15 d. Knowingly vote in the wrong election precinct or district.
  - 16 e. Disobey the lawful command of an election officer as defined in chapter 16.1-05.
  - 17 f. Knowingly exclude a qualified elector from voting or knowingly allow an  
18 unqualified ~~person~~individual to vote.
  - 19 g. Knowingly vote when not qualified to do so.
  - 20 h. Sign an initiative, referendum, recall, or any other election petition when not  
21 qualified to do so.
  - 22 i. Circulate an initiative, referendum, recall, or any other election petition not in its  
23 entirety or circulate such a petition when unqualified to do so.
  - 24 j. Pay or offer to pay any individual, measure committee, or other organization, or  
25 receive payment or agree to receive payment, on a basis related to the number  
26 of signatures obtained for circulating an initiative, referendum, or recall petition.  
27 This subsection does not prohibit the payment of salary and expenses for  
28 circulation of the petition on a basis not related to the number of signatures  
29 obtained, as long as the circulators file ~~their~~the intent to remunerate ~~prior~~  
30 ~~to~~before submitting the petitions and, in the case of initiative and referendum  
31 petitions, fully disclose all contributions received pursuant to chapter 16.1-08.1 to

1 the secretary of state upon submission of the petitions. The disclosure of  
2 contributions received under this section does not affect the requirement to file a  
3 pre-election report by individuals or organizations soliciting or accepting  
4 contributions for the purpose of aiding or opposing the circulation or passage of a  
5 statewide initiative or referendum petition or measure placed upon a statewide  
6 ballot by action of the legislative assembly under chapter 16.1-08.1. Any  
7 signature obtained in violation of this subdivision is void and may not be counted.

8 k. Willfully fail to perform any duty of an election officer after having accepted the  
9 responsibility of being an election officer by taking the oath as prescribed in this  
10 title.

11 l. Willfully violate any rule adopted by the secretary of state pursuant to this title.

12 m. Willfully make any false canvass of votes, or make, sign, publish, or deliver any  
13 false return of an election, knowing the ~~same~~ canvass or return to be false; or  
14 willfully deface, destroy, or conceal any statement or certificate entrusted to the  
15 individual's or organization's care.

16 n. Destroy ballots, ballot boxes, election lists, or other election supplies except as  
17 provided by law, or negatively impact the confidentiality, integrity, or availability of  
18 any system used for voting.

19 o. Sign a name other than that individual's own name to an initiative, referendum,  
20 recall, or any other election petition.

21 2. a. A violation of subdivisions b, e, f, or h through l of subsection 1 is a class A  
22 misdemeanor.

23 b. A violation of subdivisions a, c, d, g, or m of subsection 1 is a class C felony.

24 c. A violation of subdivision n of subsection 1 ~~occurring after an election but before~~  
25 ~~the final canvass, or during an election,~~ is a class C felony, ~~and in other cases is~~  
26 ~~a class A misdemeanor.~~

27 d. A violation of subdivision o of subsection 1 is a class A misdemeanor if an  
28 individual signs one or two names other than the individual's own name to a  
29 petition and is a class C felony if an individual signs more than two names other  
30 than the individual's own name to a petition.



1 e. An organization, as defined in section 12.1-03-04, that violates this section is  
2 subject to the organizational fines in section 12.1-32-01.1. The court in which the  
3 conviction is entered shall notify the secretary of state of the conviction and shall  
4 order the secretary of state to revoke the certificate of authority of any convicted  
5 organization or limited liability company. The organization may not reapply to the  
6 secretary of state for authorization to do business under any name for one year  
7 upon conviction of a class A misdemeanor and for five years upon conviction of a  
8 class C felony under this section.

9 f. An individual who is a member of an organization may be convicted of a violation  
10 as an accomplice under section 12.1-03-01.

11 3. Every act ~~which by this chapter is made~~this chapter makes criminal when committed  
12 with reference to the election of a candidate is equally criminal when committed with  
13 reference to the determination of a question submitted to qualified electors to be  
14 decided by votes cast at an election.

15 **SECTION 12. AMENDMENT.** Section 16.1-01-16 of the North Dakota Century Code is  
16 amended and reenacted as follows:

17 **16.1-01-16. Secretary of state to establish a uniform state-based administrative**  
18 **complaint procedure.**

19 The secretary of state shall establish a uniform state-based administrative complaint  
20 procedure to remedy grievances according to section 402 of the Help America Vote Act of 2002  
21 [Pub. L. 107-252; 116 Stat. 1666; 42 U.S.C. 15512]. The complaint procedure must be uniform  
22 and nondiscriminatory and address complaints of violations of any provision of title III of the  
23 Help America Vote Act of 2002, including a violation that has occurred, is occurring, or is about  
24 to occur. A complaint filed under the complaint procedure must be in writing; and notarized, and  
25 be signed and sworn by the ~~person~~individual filing the complaint. The secretary of state is-  
26 ~~authorized to~~may consolidate complaints. At the request of a complainant, the secretary of state  
27 shall establish a procedure for providing a review on the record. If the secretary of state  
28 determines there is a violation of a provision of title III of the Help America Vote Act of 2002  
29 [Pub. L. 107-252; 116 Stat. 1666; 42 U.S.C. 15481-15502], the secretary of state shall  
30 determine and provide an appropriate remedy. If the secretary of state determines ~~that~~ a  
31 violation of title III of the Help America Vote Act of 2002 has not occurred, the secretary of state

1 shall dismiss the complaint and publish the results of the review. The secretary of state shall  
2 make a final determination with respect to a complaint within ninety days of the date the  
3 complaint is filed with the secretary of state, unless the complainant consents to a longer period  
4 of time for the secretary of state to make a determination. If the secretary of state fails to meet  
5 the ninety-day deadline for determining a complaint, the complaint must be resolved within sixty  
6 days under an alternative dispute resolution procedure.

7 **SECTION 13. AMENDMENT.** Section 16.1-01-17 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9 **16.1-01-17. Estimated fiscal impact of an initiated or referred measure.**

10 ~~At least ninety days before a statewide election at which~~As soon as practicable after the  
11 secretary of state approves an initiated or referred measure ~~will be voted upon~~for the ballot, the  
12 legislative council shall coordinate the determination of the estimated fiscal impact of the  
13 initiated or referred measure. Upon notification from the secretary of state that signed petitions  
14 have been submitted for placement of an initiated or referred measure on the ballot, the  
15 legislative management shall hold hearings, receive public testimony, and gather information on  
16 the estimated fiscal impact of the measure. Each agency, institution, or department shall provide  
17 information requested in the format and time frame prescribed by the legislative council for  
18 identifying the estimated fiscal impact of the measure. At least thirty days before the public vote  
19 on the measure, the legislative council shall submit a statement of the estimated fiscal impact of  
20 the measure to the secretary of state. Upon receipt, the secretary of state shall include a notice  
21 within the analysis required by section 16.1-01-07 specifying where copies of the statement of  
22 the estimated fiscal impact can be obtained. Within thirty days of the close of the first complete  
23 fiscal year after the effective date of an initiated or referred measure approved by the voters, the  
24 agencies, institutions, or departments that provided the estimates of the fiscal impact of the  
25 measure to the legislative council under this section shall submit a report to the legislative  
26 council on the actual fiscal impact for the first complete fiscal year resulting from provisions of  
27 the initiated or referred measure and a comparison to the estimates provided to the legislative  
28 council under this section, and the legislative council shall issue a report of the actual fiscal  
29 impact of the initiated or referred measure.

30 **SECTION 14. AMENDMENT.** Section 1 of House Bill No. 1256, as approved by the sixty-  
31 seventh legislative assembly, is amended and reenacted as follows:

1                   **SECTION 1.** A new section to chapter 16.1-01 of the North Dakota Century Code  
2 is created and enacted as follows:

3                   **Use of nonpublic funds prohibited - Penalty.**

4                   1. The state and political subdivisions may not solicit, accept, or use any grants  
5 or donations from private persons for elections operations or administration  
6 except:

7                   a. The use of privately owned facilities for polling places;

8                   b. Food for poll workers; and

9                   c. Other nonmonetary donations that are not used to prepare, process, mark,  
10 collect, or tabulate ballots or votes.

11                   2. An individual who knowingly violates subsection 1 is guilty of a class A  
12 misdemeanor.

13                   **SECTION 15. AMENDMENT.** Section 16.1-02-01 of the North Dakota Century Code is  
14 amended and reenacted as follows:

15                   **16.1-02-01. Permanent central voter file.**

16                   A permanent, centralized electronic database of voters, to be known as the central voter  
17 file, is established with the offices of the secretary of state and county auditors linked together  
18 by a centralized statewide system. The county auditor is chief custodian of the central voter file  
19 records in each county. The secretary of state shall maintain the central voter file and provide  
20 training and documentation that users who have been granted access to the system shall  
21 follow. The central voter file must be accessible by the secretary of state and all county auditors  
22 for purposes of preventing and determining voter fraud, making changes and updates, and  
23 generating information, including pollbooks, reports, inquiries, forms, and voter lists.

24                   **SECTION 16. AMENDMENT.** Section 16.1-02-02 of the North Dakota Century Code is  
25 amended and reenacted as follows:

26                   **16.1-02-02. Costs of creating and maintaining a central voter file.**

27                   ~~The creation of the central voter file and its maintenance through June 30, 2011, must be~~  
28 ~~paid for with funds from the state's election fund, provided the election fund contains adequate~~  
29 ~~funding to create and maintain the central voter file. The creation of the central voter file and its~~  
30 ~~maintenance through June 30, 2011, may not be paid for from funds in the secretary of state's~~

4 file mean costs of annual software licenses, ~~hosting costs for the software in the state data-~~  
5 ~~center~~ hosting, costs of necessary enhancements to the software, database updates, and the  
6 costs for implementing the duties and responsibilities of the secretary of state's office relating to  
7 the central voter file.

8 **SECTION 17. AMENDMENT.** Section 16.1-02-05 of the North Dakota Century Code is  
9 amended and reenacted as follows:

10 **16.1-02-05. Entry of new voters into the central voter file - Query of the central voter**

14 required information of each individual who voted at the last election who is not  
15 already contained in the central voter file and update any required information  
16 requested and obtained at the last election for any individual contained in the central

- 18 2. The secretary of state, with the assistance of the county auditors, ~~within eighty-five~~  
19 ~~days following an election~~ before the meeting of the state canvassing board, shall  
20 query the central voter file to determine if any individual voted more than once during  
21 the preceding election. The secretary of state shall immediately notify the county  
22 auditor and state's attorney in each affected county for further investigation.
- 23 3. Upon return of any nonforwardable mail from an election official, the county auditor  
24 shall ascertain the name and address of that individual. If the individual is no longer at  
25 the address recorded in the central voter file, the county auditor shall transfer the voter  
26 to the correct precinct in the central voter file or notify the county of the voter's new  
27 residence so the voter record can be transferred to the correct county. If a notice  
28 mailed at least sixty days after the return of the first nonforwardable mail is also  
29 returned by the postal service, the county auditor shall designate the individual as  
30 "inactive" in the central voter file.

1       **SECTION 18. AMENDMENT.** Section 16.1-02-06 of the North Dakota Century Code is  
2 amended and reenacted as follows:

8 this state since the last report. Within thirty days after receiving a report, the secretary  
9 of state shall designate each individual included in the report as "deceased" in the  
10 central voter file. ~~The secretary of state shall prepare and distribute a list of individuals~~  
11 ~~designated as "deceased" to each county auditor.~~
- 12       2. The state health officer shall provide for the regular reporting to the secretary of state  
13 the name, address, date of birth, and county of residence, if available, of each  
14 individual eighteen years of age or older whose name was changed by marriage since  
15 the last report. ~~The secretary of state shall prepare and distribute a list of those~~  
16 ~~individuals to each county auditor.~~
- 17       3. After receiving notice of death of an individual who has died outside the county, the  
18 county auditor shall designate that individual as "deceased" in the central voter file.  
19 Notice must be in the form of a printed obituary or a written statement signed by an  
20 individual having knowledge of the death of the individual.

21       **SECTION 19. AMENDMENT.** Section 16.1-02-07 of the North Dakota Century Code is  
22 amended and reenacted as follows:

23       **16.1-02-07. Reporting changes of names - Changes to records in the central voter file.**

24       The state court administrator shall provide for the regular reporting to the secretary of state  
25 the name, address, date of birth, and county of residence, if available, of each individual  
26 eighteen years of age or older whose name was changed by divorce or any order or decree of  
27 the court since the last report. ~~The secretary of state shall prepare and distribute a list of those~~  
28 ~~individuals to each county auditor.~~ Any individual who has obtained a protection order under  
29 section 14-07.1-03 or who is protected by a disorderly conduct restraining order under section  
30 12.1-31.2-01 must be listed in the central voter file with a "secured active" designation. A  
31 "secured active" designation means a record maintained as an active voter for pollbook

1 purposes, but otherwise is an exempt record. The state court administrator or the bureau of  
2 criminal investigation shall make available upon request of the secretary of state the name of  
3 each individual who has obtained such an order.

4 **SECTION 20. AMENDMENT.** Section 16.1-02-10 of the North Dakota Century Code is

12 ~~The secretary of state shall prepare a report to each county auditor which contains the name of~~  
13 ~~each individual who has been designated as "inactive" in the central voter file.~~ Although not  
14 counted in an election, a late absentee ballot from an individual may not be used to designate  
15 an individual as "inactive" in the central voter file.

16 **SECTION 21. AMENDMENT.** Section 16.1-02-11 of the North Dakota Century Code is

20 The secretary of state ~~shall~~may adopt rules and procedures according to subsection 3 of

- 23 1. Provide for the establishment and maintenance of a central voter file.
- 24 2. Provide for the generation and assignment of a unique identifier to each individual  
25 contained in the central voter file.
- 26 3. Provide procedures for entering data into the central voter file.
- 27 4. Provide for any additional information to be requested of and obtained from an  
28 individual which is to be maintained in the central voter file, not already provided by  
29 law, but necessary for the proper administration of the central voter file.

- 1           5.    Provide for the exchange of records maintained by the appropriate state and county
- 2                    agencies and officials for receiving regular reports regarding individuals and records of
- 3                    individuals contained in the central voter file.
- 4           6.    Allow each county auditor and the secretary of state to add, modify, and delete
- 5                    information from the central voter file to ensure accurate and up-to-date records.
- 6           7.    Allow each county auditor and the secretary of state to have access to the central
- 7                    voter file for review, search, and inquiry capabilities.
- 8           8.    Provide security and protection of all information contained in the central voter file and
- 9                    to ensure that unauthorized access and entry is prohibited.
- 10          9.    Provide a system for each county to identify the precinct to which an individual should
- 11                    be assigned for voting purposes.

12           **SECTION 22. AMENDMENT.** Section 16.1-02-13 of the North Dakota Century Code is

14           **16.1-02-13. Information contained in pollbooks generated from the central voter file.**

15           The county auditor shall generate a pollbook for each precinct in the county from the central

18 issued by the department of transportation, which are exempt records, the precinct pollbooks  
19 are open records under section 44-04-18. When providing access to or a copy of a pollbook, the  
20 election official administering the election shall redact from the pollbook any voter records  
21 designated as secured active along with the voter's date of birth and identification numbers  
22 listed on the paper pollbook used in an election. If an electronic pollbook is used, the election  
23 official, upon request for a copy of the pollbook, shall generate a list including the allowable  
24 information detailed in this section for the individuals who voted in the election. The list provided  
25 from an electronic pollbook may be requested by precinct or county. The secretary of state shall  
26 prescribe procedures for generating pollbooks and for transporting the pollbooks to the election  
27 ~~judges~~poll clerks for use on election day. ~~Pollbooks~~Electronic pollbooks may have a secure  
28 connection from the polling place to the data maintained in the central voter file to ensure the  
29 integrity of the election. Each pollbook generated from the central voter file must contain the  
30 following information for each individual contained ~~therein~~in the pollbook:

- 31           1.    The complete legal name of the individual.

- 1           2.    The complete residential address of the individual.
- 2           3.    The complete mailing address of the individual, if different from the individual's
- 3                residential address.
- 4           4.    The unique identifier generated and assigned to the individual.
- 5           5.    The county, legislative district, city or township, school district, county commissioner
- 6                district, if applicable, precinct name, and precinct number in which the individual
- 7                resides. A ballot-style code identifying this information may be used in place of the
- 8                information required by this subsection.
- 9           6.    Any other information requested of and obtained from the individual deemed
- 10                necessary by the secretary of state for the proper administration of the pollbook.

11           **SECTION 23. AMENDMENT.** Subsection 2 of section 16.1-05-01 of the North Dakota  
12 Century Code is amended and reenacted as follows:

- 13           2.    The election judges must be appointed in the following manner:
  - 14           a.    Except as provided in subdivision b:
    - 15               (1)   The election judges for each polling place must be appointed in writing by

5           **SECTION 24. AMENDMENT.** Section 16.1-06-02 of the North Dakota Century Code is  
6 amended and reenacted as follows:

7           **16.1-06-02. Ballots prepared by county auditor or local official - Penalty.**

8           For a local election, the ballots must be printed and distributed under the direction of the  
9 auditor or clerk of the local subdivision. For all other elections, ballots must be printed and  
10 distributed under the direction of the county auditor, subject to the supervision and approval of  
11 the secretary of state as to the legal sufficiency of the form, style, wording, and contents of the  
12 ballots. If an auditor or clerk of a local subdivision, a county auditor, or the secretary of state  
13 causes or approves the printing of a ballot listing an individual as a candidate when the official  
14 knows or should know the individual does not meet the qualifications, or has not satisfied the  
15 requirements to be a candidate, the official is guilty of an infraction.

16           **SECTION 25. AMENDMENT.** Section 16.1-06-04 of the North Dakota Century Code is  
17 amended and reenacted as follows:

18           **16.1-06-04. Form and quality of ballots generally.**

- 19           1. All official ballots prepared under this title must:
- 20           1. a. Be printed on uniform quality and color of paper in an ink color suitable to make  
21           the ballot clearly legible and compatible with the electronic voting system  
22           requirements necessary to tabulate the votes.
- 23           2. b. Be of sufficient length to contain the names of all candidates to be voted for at

- 25           3. c. Have the language "Vote for no more than \_\_\_\_\_ name (or names)" placed  
26           immediately under the name of each office.

30           blank line provided and write that person's name on the blank line."

4       ~~circulated a petition for signatures to be included on the ballot."~~

5       ~~f.~~ Leave sufficient space for each office to write a name, or names, as the case  
6       may be, in lieu of those printed on the ballot.

7       6. ~~g.f.~~ ~~Immediately~~Have an oval printed preceding and on the same line as the name of  
8       each candidate ~~must be printed an oval in which the voter is to darken to mark~~  
9       ~~the voter's choice by darkening the oval next to the name of the candidate~~  
10      ~~chosen.~~

11      7. ~~h.g.~~ Provide text boxes at the bottom of the first side of the ballot. The text box at the  
12      bottom of the first column is to contain the words "Official Ballot, the name of the  
13      county, the name or number of the precinct, and the date of the election". The  
14      text box is to contain the words "All ballots, other than those used to vote  
15      absentee, must first be initialed by appropriate election officials in order to be  
16      counted". The text box at the bottom of the third column is to contain the word  
17      "initials" preceded by a blank line where the judge or inspector shall initial the  
18      ballot.

19      ~~Any precinct that uses an electronic counting machine may require the use of a particular~~  
20      ~~writing instrument to mark the ballot so the ballots may be properly counted.~~

21      2. The ballot must contain the names of all candidates, the contents of measures as  
22      required by section 16.1-06-09, and the statements of questions to be submitted to the  
23      voters. The ballot must be arranged in a manner and form approximating as far as  
24      possible the requirements of this section.

25      **SECTION 26. AMENDMENT.** Section 16.1-06-11 of the North Dakota Century Code is  
26      amended and reenacted as follows:

27      **16.1-06-11. ~~Electronic voting~~Voting systems authorized.**

28      ~~The use of electronic voting~~Voting systems may be used in accordance with the provisions  
29      of this chapter ~~is hereby authorized in any election precinct upon finding and declaration by~~  
30      ~~resolution of the city governing body, and also of the board of county commissioners of the~~  
31      ~~county in which such election precinct is located, that such use is advisable or necessary in that~~

18 tabulating paper ballot, recorded by optical scan reader, containing the names of  
19 offices and candidates and the questions to be voted on, which is used in conjunction  
20 with the marking device and on which votes may be recorded. For direct recording  
21 electronic voting systems, ballot means the ballot display provided by electro-optical  
22 devices showing the names and candidates and the questions to be voted on that  
23 allows a voter to directly enter choices into electronic storage with the use of a  
24 touchscreen or other data entry device. The term includes the digital image of a  
25 marked ballot captured by a voting system.
- 26 2. "Ballot marking device" means a device for marking ballots with ink or other  
27 substance, or any other method for recording votes on ballots such that the votes may  
28 be tabulated and counted by tabulation.
- 29 3. ~~"Counting center" means the~~ a ~~location or locations~~ designated by the county auditor  
30 for the ~~automatic tabulating and counting of ballots and tabulation of votes from the~~  
31 ballots.

- 1           4. ~~"Direct recording electronic voting system~~Digital scan" means a voting system that  
2           records votes by means of a ballot display provided by electro-optical devices that  
3           ~~allows a voter to directly enter choices into electronic storage with the use of a~~  
4           ~~touchscreen or other data entry device. An alphabetic keyboard may be employed as~~  
5           ~~an entry device to facilitate voting for write-in candidates. A voter's choices are stored~~  
6           ~~in the direct recording electronic voting system's internal memory devices and added~~  
7           ~~to the choices of all other voters~~procedure in which votes cast on a paper ballot are  
8           tabulated by examining marks made in voting response locations on the ballot and an  
9           image of the ballot is captured and retained.
- 10          5. ~~"Electronic voting~~Voting system" means ~~a~~the system, or the combination of electronic  
11          voting systems and devices authorized under this chapter, that may employ a marking  
12          device in conjunction with ballots or the use of a touchscreen or other data entry  
13          device and automatic tabulating equipment for the recording, tabulating, and counting  
14          of votes in an election.
- 15          6. "Electronic voting system device" means a single unit of an electronic voting system.
- 16          7. "Marking device" means a device for marking ballots with ink or other substance, or  
17          any other method for recording votes on ballots in a manner that the votes may be  
18          tabulated and counted by automatic tabulating equipment.
- 19          8. "Optical scan" means a procedure in which votes cast on a paper ballot are tabulated  
20          by means of examining marks made in voting response locations on the ballot with an  
21          optical reader and devices authorized under this chapter which may employ a ballot  
22          marking device with use of a touchscreen or other data entry device to record and  
23          count votes in an election.

24           **SECTION 28. AMENDMENT.** Section 16.1-06-14 of the North Dakota Century Code is  
25 amended and reenacted as follows:

26           **16.1-06-14. Requirements for electronic voting systems.**

27           Any electronic voting system used in an election in this state must:

- 28           1. Provide facilities for voting for nominated candidates, for persons not in nomination,  
29           and upon questions or measures submitted to the voters.
- 30           2. Permit each voter to vote for as many persons for any office as the voter is entitled to  
31           vote for, and must allow each voter to vote in primary elections for candidates for

- 1 nomination by the political party of the voter's choice, but ~~the system~~ must preclude  
2 each voter from voting for more persons for any office than the voter is entitled to vote  
3 for, from voting more than once for the same candidate or upon the same measure or  
4 question submitted to the voters, or voting the ballot of more than one political party in  
5 any primary election.
- 6 3. Permit each voter, insofar as is possible, by the replacement of spoiled ballots, to  
7 change the voter's vote for any candidate, or upon any measure or question submitted  
8 to the voters, up to the time the voter begins the final operation to register the voter's  
9 vote.
- 10 4. Permit and require ~~voting in absolute secrecy~~ while voting, and ~~must be so-~~  
11 ~~constructed and controlled that~~ so no person other individual can see or know for whom  
12 ~~any other an~~ elector has voted or is voting, except a ~~voter whom the person has-~~  
13 ~~assisted or is an individual~~ assisting in voting, marking the ballot at the request of the  
14 elector as prescribed by law, and ~~that no person may~~ individual is able to see or know  
15 the number of votes registered for any candidate ~~or tamper with any mechanism~~ while  
16 the polls are open.
- 17 5. Be provided with a procedure by the use of which, immediately after the polls are  
18 closed, all voting is ~~absolutely~~ prevented.
- 19 6. Be so constructed that when properly operated ~~the system~~ shall register or record  
20 correctly and accurately every vote cast.
- 21 7. Be so constructed that a voter may readily learn the method of operating ~~the system~~.
- 22 8. Permit voting by ballot or by entering directly into a computer or other electronic device  
23 by means of a touchscreen or other data entry device.
- 24 9. Permit voting for presidential electors by making only one mark.
- 25 10. Permit write-in voting and absentee voting.
- 26 11. Permit the rotation of names of candidates on ballots as required by this title.
- 27 12. ~~In the case of electronic systems procured after August 1, 2003, be capable of~~  
28 ~~notifying a voter that the voter has overvoted, undervoted, and in the case of a primary~~  
29 ~~election, cross-party voted before the voter casts a ballot.~~
- 30 13. ~~In the case of direct recording electronic voting systems, be capable of preventing a~~  
31 ~~voter from overvoting and cross-party voting before the voter casts a ballot.~~

- 1       14. ~~In the case of direct-recording electronic voting systems, be capable of producing in-~~  
2           ~~random order a paper copy of each ballot cast on the system.~~
- 3       15. ~~Ensure that any direct-recording electronic voting system procured or used in the state-~~  
4           ~~may not transmit uncounted votes or ballots through the internet.~~
- 5       16. Fulfill the criteria and standards established by the secretary of state according to  
6           section 16.1-06-26.

7       **SECTION 29. AMENDMENT.** Section 16.1-06-17 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9       **16.1-06-17. County auditor to provide ballots and other electronic voting system**  
10 **supplies.**

11       At the same time as other election supplies are provided and distributed, the county auditor  
12 shall provide ~~to each precinct in the county using an electronic voting system:~~

- 13       1. A sufficient number of ~~electronic~~ voting system devices and ballots ~~if the electronic-~~  
14           ~~voting system employs ballots.~~
- 15       2. One facsimile diagram of the entire face of the ~~electronic~~ voting system ~~device~~devices  
16           as ~~it~~the devices will appear ~~on election day~~while the polls are open.
- 17       3. Appropriate instruction material for the use of the ~~electronic~~ voting system devices.
- 18       4. All other materials required to carry out the election process through the use of  
19           ~~electronic~~the voting system~~system.~~

20       **SECTION 30. AMENDMENT.** Section 16.1-06-18 of the North Dakota Century Code is  
21 amended and reenacted as follows:

22       **16.1-06-18. Delivery of ballots.**

23       County auditors shall deliver, or cause to be delivered, by ~~mail or other~~ reliable method, to  
24 the inspector of elections in each ~~precinct~~polling place the official ballots, ~~if available.~~ The  
25 ballots must be delivered in sealed packages marked plainly with the name of the precinct ~~for-~~  
26 ~~which the ballots are intended.~~ The county auditor also shall deliver or cause to be delivered a  
27 suitable seal for ~~the purpose of sealing~~ the wrapper containing the ballots as provided in section  
28 16.1-15-08.

29       **SECTION 31. AMENDMENT.** Section 16.1-06-19 of the North Dakota Century Code is  
30 amended and reenacted as follows:

1           **16.1-06-19. Instructions, advertisements, maps, and ballots posted in polling places.**

2           Each county auditor shall have posters printed, in large type, containing full instructions to  
3 electors on obtaining and voting ballots and a copy of section 16.1-01-12, any federal laws  
4 regarding prohibitions on acts of fraud and misrepresentations, and general information on  
5 voting rights under applicable federal and state laws, including instructions on how to contact  
6 the appropriate officials if these rights are alleged to have been violated. The county auditor  
7 shall furnish at least one such poster to the election inspector in each election polling place  
8 who, before the opening of the polls, shall conspicuously post at least one poster in the polling  
9 place. The county auditor, at the time of delivering the ballots to the inspector of elections in  
10 each polling place, shall deliver at least five copies of the newspaper publication or other copy  
11 of the complete text of any constitutional amendment or initiated or referred measure to ~~such~~the  
12 inspector of elections. One of the newspaper publications or copies must be posted  
13 conspicuously in the polling place on the morning of the election. Each county auditor shall  
14 furnish the election inspector in each polling place with four copies of a map showing the  
15 election ~~precinct's~~precinct boundaries and information regarding the date of the election and the  
16 hours during which polling places will be open. ~~The inspector shall, before~~Before the opening of  
17 the polls, the inspector shall post the maps and information regarding the date of the election  
18 and the hours during which polling places will be open at the entry to and in other conspicuous  
19 places around the polling place.

20           **SECTION 32. AMENDMENT.** Section 16.1-06-25 of the North Dakota Century Code is

14       **SECTION 35. AMENDMENT.** Section 16.1-07-06 of the North Dakota Century Code is  
15 amended and reenacted as follows:

16       **16.1-07-06. Application form.**

17       1. Application for an absent voter's or mail ballot must be made on a form, prescribed by  
18 the secretary of state, to be furnished by the proper officer of the county, city, or school  
19 district in which the applicant is an elector, ~~or~~ any form, approved by the secretary  
20 of state, ~~or any blank~~ containing the following:  
21       a. The applicant's name.  
22       b. The applicant's current or most recent North Dakota residential address.  
23       c. The applicant's mailing address.  
24       d. The applicant's current contact telephone number, if available.  
25       e. The election for which the ballot is being requested.  
26       f. The date of the request.  
27       g. An affirmation that the applicant has resided, or will reside, in the precinct for at

1           5.    An incomplete application must be returned to the applicant for completion and  
2           resubmission.

3           6.    Except for the applicant's date of birth, identification card number, and any  
4           supplemental documentation provided under section 16.1-01-04.1, the application is  
5           an open record under section 44-04-18.

6           **SECTION 36. AMENDMENT.** Section 16.1-07-07 of the North Dakota Century Code is  
7           amended and reenacted as follows:

8           **16.1-07-07. Delivering application form for ballot.**

9           The officers specified in section 16.1-07-05, upon request, shall ~~mail~~provide an application  
10          form for an absent voter's ballot to the voter or may deliver the application form to the voter  
11          upon a personal application made at the officer's office. The officers may also make available or  
12          distribute the applications, prescribed by the secretary of state, to the public without any specific  
13          request being made for the applications.

14          **SECTION 37. AMENDMENT.** Section 16.1-07-08 of the North Dakota Century Code is  
15          amended and reenacted as follows:

16          **16.1-07-08. Delivering ballots - Envelopes accompanying - Affidavit on envelope -**  
17          **Challenging electors voting by absentee ballot - Inability of elector to sign name.**

18          1.    Upon receipt of an application for an official ballot properly filled out and duly signed,  
19          or as soon ~~thereafter~~after receipt of the application as the official ballot for the precinct  
20          in which the applicant resides has been prepared, the county auditor, city auditor, or  
21          business manager of the school district, as the case may be, shall send to the absent  
22          voter by mail or secure electronic delivery, if the secretary of state determines the  
23          necessary technology is available and according to the choice made by the voter on  
24          the application for the ballot, at the expense of the political subdivision conducting the  
25          election, one official ballot, or personally deliver the ballot to the applicant or the  
26          applicant's agent, which agent may not, at that time, be a candidate for any office to  
27          be voted upon by the absent voter. The agent shall sign the agent's name before  
28          receiving the ballot and deposit with the auditor or business manager of the school  
29          district, as the case may be, authorization in writing from the applicant to receive the  
30          ballot or according to requirements set forth for signature by mark. The auditor or  
31          business manager of the school district, as the case may be, may not provide an

1 absent voter's ballot to ~~a person~~an individual acting as an agent who cannot provide a  
2 signed, written authorization from an applicant. ~~No~~A person may not receive  
3 compensation, including money, goods, or services, for acting as an agent for an  
4 elector, ~~nor~~and a person may ~~a person~~not act as an agent for more than four electors  
5 in any one election. A voter voting by absentee ballot may not require the political  
6 subdivision providing the ballot to bear the expense of the return postage for an  
7 absentee ballot.

8 2. With the exception provided in section 16.1-07-24 for secure remote electronic casting  
9 of a ballot granted to a covered voter, the absent voter marking the ballot by electronic  
10 means shall return the instrument containing the vote selections made by the voter to  
11 the assigned polling place where, after being recorded in the pollbook by a poll clerk,  
12 the choices listed in the instrument will be converted into the official ballot. Upon  
13 confirmation by the voter the vote selections marked by the ballot marking device are  
14 correct, the voter shall cast the ballot in the tabulation device.

15 3. ~~Any voter who is blind, visually impaired, or print disabled~~qualified elector living with a  
16 disability that prevents the elector from reading or marking the ballot without  
17 assistance and who wishes to cast an absentee ballot may mark the electronic ballot  
18 by electronic means. The voter then shall deposit the ballot electronically on the  
19 secure server that is used by covered voters as defined in section 16.1-07-18. Upon  
20 system notification that a ballot has been left by a qualified voter, an election official  
21 shall print the ballot, place the ballot in a secrecy envelope, attach the absent voter's  
22 application for the ballot, and securely store the enveloped ballot and the application  
23 with all the other absentee ballots. When the absentee ballot election board meets to  
24 process and count absentee ballots, the ballot from the covered voter must be  
25 transferred onto a paper ballot and tabulated with all the other valid absent voters'  
26 ballots.

27 4. If there is more than one ballot to be voted by an elector of the precinct and the voting  
28 system will be unable to tabulate one or more of the ballots, one of each kind must be  
29 included and a secrecy envelope and a return envelope must be enclosed with the  
30 ballot or ballots. The front of the return envelope must bear the official title and

1 post-office address of the officer supplying the voter with the ballot and upon the other  
2 side a printed voter's affidavit in substantially the following form:

16 5. If the absent voter is unable to sign the voter's name on the affidavit required under  
17 this section, the voter shall mark (X) or use the applicant's signature stamp on the  
18 affidavit in the presence of a disinterested individual. The disinterested individual shall  
19 print the name of the individual marking the X or using the signature stamp below the  
20 X or signature stamp and shall sign the disinterested individual's own name following  
21 the printed name together with the notation "witness to the mark".

22 ~~3-6.~~ Each individual requesting an absent voter's ballot under this chapter must be  
23 provided a set of instructions, prescribed by the secretary of state, sufficient to  
24 describe the process of voting by absent voter's ballot. The voting instructions must  
25 contain a statement informing the individual that the individual is entitled to complete  
26 the absent voter's ballot in secrecy.

27 ~~4-7.~~ Each individual requesting an absent voter's ballot by mail under this chapter who  
28 cannot read the English language or ~~who because of blindness or other lives with a~~

30 ~~upon request~~, may receive, upon request, the assistance of any individual of the  
31 voter's choice, other than the voter's employer, an officer or agent of the voter's union,

1 a candidate running in that election, or a relative of a candidate as described in  
2 subsection 2 of section 16.1-05-02, in marking the voter's ballot.

3 8. An election official shall deliver an absentee ballot to a qualified elector only upon  
4 receipt of an application meeting the requirements of section 16.1-07-06 from the  
5 elector.

6 **SECTION 38. AMENDMENT.** Section 16.1-07-09 of the North Dakota Century Code is  
7 amended and reenacted as follows:

8 **16.1-07-09. Canvassing of mailed absent voter's ballots received late.**

9 In ~~the case of~~ congressional, state, county, city, or school district elections, if an envelope  
10 postmarked or otherwise officially marked by the United States postal service or other mail  
11 delivery system before the date of election and containing an absent voter's ballot is received by  
12 the officer ~~too late to be forwarded to a polling place of the proper voting precinct in time to be~~  
13 ~~tabulated~~after election day, the ballot must be tallied by the canvassing board of the county, the  
14 governing body of the city, or the school board of the school district, as the case may be, at the  
15 time the returns are canvassed. Any envelope without a postmark or other official marking by  
16 the United States postal service or other mail delivery system or with an illegible postmark or  
17 other official marking and containing an absentee voter's ballot must be received by mail by the  
18 proper officer prior to the meeting of the canvassing board. An absent voter may personally  
19 deliver the absent voter's ballot to the appropriate officer's office at any time before five p.m. on  
20 the day before the election. Any envelope containing an absent voter's ballot with a postmark or  
21 official date stamp on the day of election or thereafter may not be tallied with the ballots timely  
22 submitted for the election. Before forwarding any ballot to a canvassing board pursuant to this  
23 section, the officer forwarding the ballot shall print the date of receipt on the envelope. Upon  
24 receipt, the canvassing board shall determine that the elector was qualified to vote in that  
25 precinct, that the elector did not previously vote in that precinct on the date of the election, and  
26 that the signatures on the absentee ballot application and the voter's affidavit were signed by  
27 the same ~~person~~individual before allowing the ballot to be tallied.

28 **SECTION 39. AMENDMENT.** Section 16.1-07-10 of the North Dakota Century Code is  
29 amended and reenacted as follows:

1           **16.1-07-10. Care and custody of ballot - Submitted ballot may not be returned.**

2           Upon receipt of an envelope containing the absent voter's ballot, the proper officer  
3 immediately shall attach the application of the absent voter and file the ballot with other  
4 absentee ballots from the same precinct. If the election official has reason to suspect the  
5 signature on the application was made by a different individual than the individual who signed  
6 the affidavit on the return ballot envelope, the election official shall attempt to contact the absent  
7 voter as soon as practicable to provide an opportunity to validate the signatures. Contact shall  
8 first be attempted by phone if the absent voter provided a phone number on the submitted  
9 application. If the election official is unable to speak with the absent voter, the election official  
10 shall mail a notice informing the absent voter the absentee ballot has been identified as having  
11 a signature mismatch and will be rejected if not verified. After submission to the appropriate  
12 election officer, a marked absent voter's ballot may not be returned to the voter for any reason  
13 other than to complete any missing information required on the affidavit on the back of the  
14 return envelope. Before delivering the absentee ballots to ~~a polling place of the proper~~the  
15 absentee ballot precinct, the proper officer shall package the ballots in a manner so the ballots  
16 are sealed securely. The package must be endorsed with the name of the proper voting  
17 precinct, the name and official title of the officer, and the words "This package contains an  
18 absent voter's ballot and must be opened only according to the processing provisions of section  
19 16.1-07-12." The officer shall keep the package safely in the officer's office until ~~it~~the package is  
20 delivered by the officer as provided in this chapter.

21           **SECTION 40. AMENDMENT.** Subsection 1 of section 16.1-07-12.1 of the North Dakota  
22 Century Code is amended and reenacted as follows:

23           1. For any primary, general, or special statewide, district, or county election, the board of  
24 county commissioners ~~may~~shall create a special precinct, known as an absentee  
25 ballot precinct, ~~for the purpose of counting~~to count all absentee ballots cast in an  
26 election in that county. The election board of the absentee ballot precinct must be  
27 known as the absentee ballot counting board. The county auditor shall supply the  
28 board with all necessary election supplies as provided in chapter 16.1-06.

29           **SECTION 41.** Section 16.1-07-13.1 of the North Dakota Century Code is created and  
30 enacted as follows:

1        **16.1-07-13.1. Signature mismatch - Verification of signatures.**

2        1. If an election official, absentee ballot precinct election board, or the canvassing board  
3        has reason to suspect the absent voter's signatures on the application and the affidavit  
4        on the returned ballot envelope do not match, the election official shall notify the  
5        absent voter the signatures do not appear to match. The notification must include  
6        instructions by which the absent voter may confirm the validity of the signatures, a  
7        statement that verification is required before the ballot can be counted, the date and  
8        time of the canvassing board meeting, and a statement that verification must be  
9        completed by the absent voter before close of the meeting of the canvassing board  
10       occurring six days after the election.

11       2. The absent voter may confirm the validity of the signatures by written communication  
12       or personal visit to the office of the election official administering the election. If the  
13       voter confirms by written communication, the written communication must include a  
14       copy of the identification used when applying for the ballot. If the voter confirms  
15       through a personal visit to the election official, the voter must show the identification  
16       used when applying for the ballot. The election official shall make a copy of the  
17       identification shown, and the copy must be included with the application and ballot  
18       when provided to the election board or canvassing board, whichever would be  
19       appropriate based on when the voter verified the signatures. The canvassing board  
20       shall include in the final tally the ballot from an absent voter who has completed the  
21       verification process and was eligible to vote the returned ballot.

22       3. An individual contacted regarding the mismatch of signatures may deny making the  
23       application or returning the ballot. The election official receiving the denial shall turn  
24       the application and uncounted ballot over to the county state's attorney for  
25       investigation of attempted voter fraud.

26       4. The election official shall record in the minutes of the county canvassing board the  
27       manner and number of attempts made to contact an absent voter for signature  
28       verification, the number of ballots included in the tally because the signatures were  
29       verified, and the number of ballots ultimately rejected by the canvassing board along  
30       with the reasons for the rejections.



- 1        5. After the meeting of the canvassing board, the election official shall send a written  
2                    notice to each absent voter whose ballot was rejected and not counted because of  
3                    signature mismatch.

4        **SECTION 42. AMENDMENT.** Section 16.1-07-15 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6        **16.1-07-15. Early voting precinct - Election board appointment - Closing and**  
7 **canvassing.**

- 8        1. For any primary, general, or special statewide, district, or county election, the board of  
9 county commissioners may, before the sixty-fourth day before the day of the election,  
10 create a special precinct, known as an early voting precinct, to facilitate the conduct of  
11 early voting in that county according to ~~chapters 16.1-13 and 16.1-15~~this title. At the  
12 determination of the county auditor, more than one polling place may be utilized for the  
13 purposes of operating the early voting precinct. The election board of the early voting  
14 precinct must be known as the early voting precinct election board. The county auditor  
15 shall supply the board with all necessary election supplies as provided in chapter  
16 16.1-06.
- 17        2. If the board of county commissioners establishes an early voting precinct according to  
18 this section, the following provisions apply:
- 19            a. Early voting must be authorized during the fifteen days immediately before the  
20 day of the election. The county auditor shall designate the business days and  
21 times during which the early voting election precinct will be open and publish  
22 notice of the early voting center locations, dates, and times in the official county  
23 newspaper once each week for three consecutive weeks immediately before the  
24 day of the election.
- 25            b. The county auditor shall appoint the early voting precinct election board for each  
26 early voting polling place that consists of one independent representative to act  
27 as the inspector and an equal number of representatives from each political party  
28 represented on an election board in the county, as set out in section 16.1-05-01,  
29 to act as judges. Each official of the board shall take the oath required by section  
30 16.1-05-02 and must be compensated as provided in section 16.1-05-05.

- 1           c. The county auditor, with the consent of the board of county commissioners, shall  
2           designate each early voting polling place in a public facility, accessible to the  
3           elderly and the physically disabled as provided in section 16.1-04-02. With  
4           respect to polling places at early voting precincts, "election day" as used in  
5           sections 16.1-10-03 and 16.1-10-06.2 includes any time an early voting precinct  
6           polling place is open.
- 7           d. At the close of each day of early voting, the inspector, along with a judge from  
8           each political party represented on the board, shall secure all election-related  
9           materials, including:
- 10           (1) The pollbooks and access to any electronically maintained pollbooks.  
11           (2) The ballot boxes containing voted ballots.  
12           (3) Any void, spoiled, and unvoted ballots.
- 13           e. Ballot boxes containing ballots cast at an early voting polling place may not be  
14           opened until the day of the election except as may be necessary to clear a ballot  
15           jam or to move voted ballots to a separate locked ballot box in order to make  
16           room for additional ballots.
- 17           f. Each early voting polling place may be closed, as provided in chapter 16.1-15, at  
18           the end of the last day designated for early voting in the county. Results from the  
19           early voting precinct may be counted, canvassed, or released under chapter  
20           16.1-15 as soon as any precinct within the county, city, or legislative district  
21           closes its polls on the day of the election. The county auditor shall designate a  
22           location for the closing, counting, and canvassing process under chapter 16.1-15,  
23           which location must be open to any person for the purpose of observing.
- 24           g. The early voting precinct election board shall comply with the requirements of  
25           chapters 16.1-05, 16.1-06, 16.1-11, 16.1-11.1, 16.1-13, and 16.1-15, as  
26           applicable.

27           **SECTION 43. AMENDMENT.** Section 16.1-08.1-01 of the North Dakota Century Code is  
28           amended and reenacted as follows:

29           **16.1-08.1-01. Definitions.**

30           As used in this chapter, unless the context otherwise requires:

- 1           1. "Affiliate" means an organization that controls, is controlled by, or is under common  
2           control with another organization. For purposes of this definition, control means the  
3           possession, direct or indirect, of the power to direct or cause the direction of the  
4           management and policies of an organization, whether through the ownership of voting  
5           securities, by contract other than a commercial contract for goods or nonmanagement  
6           services, or otherwise. Control is presumed to exist if an organization, directly or  
7           indirectly, owns, controls, holds with the power to vote, or holds proxies representing  
8           fifty percent or more of the voting securities of any other organization.
- 9           2. "Association" means any club, association, union, brotherhood, fraternity, organization,  
10          or group of any kind of two or more persons, including labor unions, trade  
11          associations, professional associations, or governmental associations, which is united  
12          for any purpose, business, or object and which assesses any dues, membership fees,  
13          or license fees in any amount, or which maintains a treasury fund in any amount. The  
14          term does not include corporations, cooperative corporations, limited liability  
15          companies, political committees, or political parties.
- 16          3. ~~"Candidate" means an individual who seeks nomination for election or election to~~  
17          ~~public office, and includes:~~
- 18             a. ~~An individual holding public office;~~
- 19             b. ~~An individual who has publicly declared that individual's candidacy for nomination~~  
20             ~~for election or election to public office or has filed or accepted a nomination for~~  
21             ~~public office;~~
- 22             c. ~~An individual who has formed a campaign or other committee for that individual's~~  
23             ~~candidacy for public office;~~
- 24             d. ~~An individual who has circulated a nominating petition to have that individual's~~  
25             ~~name placed on the ballot; and~~
- 26             e. ~~An individual who has, in any manner, solicited or received a contribution for that~~  
27             ~~individual's candidacy for public office, whether before or after the election for~~  
28             ~~that office.~~
- 29          4. "Conduit" means a person that is not a political party, political committee, or candidate  
30          and which receives a contribution of money and transfers the contribution to a  
31          candidate, political party, or political committee when the contribution is designated

1 specifically for the candidate, political party, or political committee and the person has  
2 no discretion as to the recipient and the amount transferred. The term includes a  
3 transactional intermediary, including a credit card company or a money transfer  
4 service that pays or transfers money to a candidate on behalf of another person.

5 5-4. "Contribution" means a gift, transfer, conveyance, provision, receipt, subscription,  
6 loan, advance, deposit of money, or anything of value, made for the purpose of  
7 influencing the nomination for election, or election, of any person to public office or  
8 aiding or opposing the circulation or passage of a statewide initiative or referendum  
9 petition or measure. The term also means a contract, promise, or agreement, express  
10 or implied, whether or not legally enforceable, to make a contribution for any of the  
11 above purposes. The term includes funds received by a candidate for public office or a  
12 political party or committee which are transferred or signed over to that candidate,  
13 party, or committee from another candidate, party, or political committee or other  
14 source including a conduit. The term "anything of value" includes any good or service  
15 of more than a nominal value. The term "nominal value" means the cost, price, or  
16 worth of the good or service is trivial, token, or of no appreciable value. The term  
17 "contribution" does not include:

- 18 a. A loan of money from a bank or other lending institution made in the regular  
19 course of business.
- 20 b. Time spent by volunteer campaign or political party workers.
- 21 c. Money or anything of value received for commercial transactions, including rents,  
22 advertising, or sponsorships made as a part of a fair market value bargained-for  
23 exchange.
- 24 d. Money or anything of value received for anything other than a political purpose.
- 25 e. Products or services for which the actual cost or fair market value are reimbursed  
26 by a payment of money.
- 27 f. An independent expenditure.
- 28 g. The value of advertising paid by a political party, multicandidate political  
29 committee, or caucus which is in support of a candidate.
- 30 h. In-kind contributions from a candidate to the candidate's campaign.

1     ~~6-5.~~ "Cooperative corporations", "corporations", and "limited liability companies" are as  
2            defined in this code, and for purposes of this chapter "corporations" includes nonprofit  
3            corporations. However, if a political committee, the only purpose of which is accepting  
4            contributions and making expenditures for a political purpose, incorporates for liability  
5            purposes only, the committee is not considered a corporation for the purposes of this  
6            chapter.

7     ~~7-6.~~ "Expenditure" means:

- 8            a. A gift, transfer, conveyance, provision, loan, advance, payment, distribution,  
9            disbursement, outlay, or deposit of money or anything of value, except a loan of  
10           money from a bank or other lending institution made in the regular course of  
11           business, made for a political purpose or for the purpose of influencing the  
12           passage or defeat of a measure.
- 13           b. A contract, promise, or agreement, express or implied, whether or not legally  
14           enforceable, to make any expenditure.
- 15           c. The transfer of funds by a political committee to another political committee.
- 16           d. An independent expenditure.

17     ~~8-7.~~ "Expenditure categories" means the categories into which expenditures must be  
18           grouped for reports under this chapter. The expenditure categories are:

- 19           a. Advertising;
- 20           b. Campaign loan repayment;

11          or legislative district office. The word 'endorsed' in this context means the candidate  
12          was endorsed by the political party indicated. The word 'petition' in this context means  
13          the candidate circulated a petition for signatures to be included on the ballot."

4 | 11. The political party or principle which cast the largest vote for governor at the most  
5 | recent primary election at which the office of governor was voted upon must have the  
6 | first section, and the political party or principle casting the next largest vote must have  
7 | the second section, and so on.

8 | ~~The judges and the inspector of elections shall inform each elector at the primary, before voting,~~

1 ~~The certificate as prescribed in this section must be delivered by the secretary or president of~~  
2 ~~the convention by registered or certified mail or in person, without charge, to the secretary of~~  
3 ~~state or the county auditor, as the case may be.~~

4 **SECTION 78. AMENDMENT.** Section 16.1-13-18 of the North Dakota Century Code is  
5 amended and reenacted as follows:

6 **16.1-13-18. Two or more organizations filing certificates representing same party -**  
7 **Secretary of state to determine authorized organization - Review of determination.**

8 If two or more organizations claiming or purporting to represent the same political party  
9 shall file certificates of nomination under the same party designation, or if the certificates  
10 indicate that the nominations were made by any ~~person~~individual or organization representing  
11 the same political party, the secretary of state, within the time prescribed by law for certifying  
12 state nominations to the county auditor, shall determine from the best available sources of  
13 information which organization filing the certificates is the legally authorized representative of  
14 the party. The decision of the secretary of state in determining which organization is the legally  
15 authorized representative of the party is subject to review by the district court in a proper action  
16 instituted for such purpose.

17 **SECTION 79. AMENDMENT.** Section 16.1-13-19 of the North Dakota Century Code is

23 **SECTION 80. AMENDMENT.** Section 16.1-13-23 of the North Dakota Century Code is

2 ~~if~~the ballot is concealed and so the ~~endorsement~~initials of the inspector or election judge may  
3 be seen. The elector then shall deposit the ballot in the optical scanning device and wait to  
4 determine if the ballot is deposited into the ballot box or if the optical scanning device has  
5 indicated a possibility for a second-chance voting condition. If a second-chance voting condition  
6 is indicated, a voter may spoil and receive up to two additional ballots. The voter's third ballot  
7 must be cast as is and may not be returned to the voter even if errors exist causing certain  
8 votes not to be counted.

9 **SECTION 81. AMENDMENT.** Section 16.1-13-25 of the North Dakota Century Code is  
10 amended and reenacted as follows:

11 **16.1-13-25. Elector may write name on ballot - Counting.**

12 The provisions of this title do not prevent any elector from writing on the paper ballot; or in  
13 ~~the case of direct recording electronic voting system devices,~~ entering by touchscreen or other  
14 data entry device, the name of any ~~person~~individual for whom the elector desires to vote, and  
15 ~~such~~the vote must be counted according to the provisions for the counting of write-in votes

17 **SECTION 82. AMENDMENT.** Section 16.1-13-27 of the North Dakota Century Code is

30 places must be accessible to individuals living with physical disabilities and the elderly and the

**16.1-13-31. Removal of ballot from polling place before closing of polls - Prohibited.**

~~No person~~An individual may not take or remove any ballot from the polling place before the close of the polls.

7 2. A write-in vote for a candidate whose name is printed on the ballot will be tallied as a  
8 vote for the candidate if the voter has not voted for more candidates than allowed for  
9 the contest or voted for the same candidate more than once in that contest.

10 3. A write-in vote that does not need to be canvassed individually based on the  
11 requirements of subsection 1 must be listed on the official canvass report as  
12 "scattered write-ins".

13 **SECTION 89. AMENDMENT.** Section 16.1-15-02 of the North Dakota Century Code is  
14 amended and reenacted as follows:

15 **16.1-15-02. Board of election to generate canvass reports - Location - Public may**  
16 **attend.**

17 After the polls are closed, the inspector of elections and the judges immediately shall  
18 ~~immediately~~ generate the canvass report from the electronic voting system. The ballots counted

25 election records to another location for canvass, ~~the other location must be in the same precinct~~  
26 ~~and the removal must be approved by the election board. In no case may the ballots be~~  
27 ~~removed to another location prior to generating the canvass report after the ballot boxes have~~  
28 ~~been opened.~~ Upon approval of a change of location by the election board as provided in this  
29 section, the approximate time and location of the canvass must be prominently posted on the  
30 main entrance to the polling place, the ballots and records must be moved in the presence of

1 the election board, and the canvass as provided in this chapter must proceed immediately upon  
2 arrival at the alternate location.

3 **SECTION 90. AMENDMENT.** Section 16.1-15-08 of the North Dakota Century Code is

17 precincts served by the polling places, and the date on which the election was held.  
18 The wrappers must be sealed securely in a manner prescribed by the county auditor  
19 so the wrappers cannot be opened without an obvious and permanent breaking of the  
20 seal. The ballots, together with those found void or spoiled, and the opened envelopes  
21 from voted absentee ballots and the unopened envelopes of absentee ballots rejected  
22 as defective, must be returned in person to the county recorder. At the meeting of the

30 provide a valid form of identification when appearing to vote in the election must be  
31 delivered to the election official responsible for the administration of the election so the

1       **SECTION 95. AMENDMENT.** Section 16.1-15-19 of the North Dakota Century Code is

18 ~~that~~which were not considered or counted by the absentee ballot precinct election boardsboard  
19 and to make a final determination of eligibility for all ballots ~~which~~that were rejected at the  
20 ~~various precincts in the county~~ for the reasons provided in sections ~~16.1-07-11~~16.1-07-10 and  
21 16.1-07-12.

22       **SECTION 96. AMENDMENT.** Section 16.1-15-20 of the North Dakota Century Code is  
23 amended and reenacted as follows:

24       **16.1-15-20. County canvassing board may subpoena members of election board to**  
25 **correct errors - Failure to obey subpoena is a contempt.**

26       When the returns of the election board officers are made to the county canvassing board, if  
27 any provision of law relative to the duties of the election board officers has not been complied  
28 with by ~~said~~the officers and the provision of law is capable of correction by the election board,  
29 the county canvassing board may issue ~~its~~ subpoenas to the election board officers of the  
30 ~~precinct where~~in polling place in which the defect occurs. The subpoenas must require the

3 provided in this section, neglects or refuses to obey the subpoena, the ~~person~~individual so

5 clerk of the district court in the county where the proceedings occur. The ~~person~~individual  
6 arrested must be brought before the county canvassing board and shall make the necessary  
7 correction. A refusal on the part of an election board officer to make a correction must be  
8 deemed a contempt of the district court.

9 **SECTION 97. AMENDMENT.** Section 16.1-15-21 of the North Dakota Century Code is

11 **16.1-15-21. Primary election statement prepared by county canvassing board -**

13 The county canvassing board, upon canvassing the returns of a primary election, shall  
14 prepare an abstract signed by the members of the board and filed in the office of the county  
15 auditor. A separate abstract of the votes cast must be transmitted to the secretary of state  
16 according to reporting instructions specified by the secretary of state. The abstract filed in the  
17 office of the county auditor must contain all of the following:

- 18 1. The names of all candidates voted for at the primary election with the number of votes  
19 received by each and for what office. The abstract must be made separately for each  
20 political party or principle.
- 21 2. The names of the ~~persons~~individuals or candidates of each political party or principle  
22 who receive the highest number of votes for the respective offices. If more than one  
23 ~~person~~individual is required to be elected to a given office at the next ensuing general  
24 election, there must be included in the abstract the names of so many of the  
25 candidates of the party receiving the next highest number of votes for that office as

17 ~~persons~~individuals with equal and the highest number of votes to appear in the office of the  
18 secretary of state at a time fixed by the secretary of state. The time fixed may not be more than  
19 five days from the date the tie is determined ~~by the county auditor.~~ On the date fixed, the  
20 ~~persons~~individuals notified to appear shall publicly decide by a drawing of names which of them  
21 must be declared elected, and the secretary of state shall prepare and deliver to the  
22 ~~person~~individual elected a certificate of election as provided in this chapter. ~~If the legislative-~~  
23 ~~district in question is within the boundaries of more than one county, the county auditor of the~~  
24 ~~county which cast the greater number of votes for the office of governor at the last election at~~  
25 ~~which a governor was elected shall proceed in accordance with this section.~~

26       **SECTION 100. AMENDMENT.** Section 16.1-15-37 of the North Dakota Century Code is  
27 amended and reenacted as follows:

1           **16.1-15-37. Examination of abstracts by state canvassing board - Messenger**

3           After the state canvassing board is formed, ~~it~~the board shall examine the certified abstracts  
4 of the county canvassing boards and verify the computed final results as provided in section  
5 16.1-15-33 ~~and if~~. If it appears that:

- 6           1. Any any material mistake has been made in the computation of votes cast for any  
7           ~~person~~individual, or  
8           2. The the county canvassing board in any county has failed to canvass the votes or any  
9           part ~~thereof~~of the votes cast in any precinct in ~~it~~the county, the board may dispatch a  
10           messenger to the county auditor of the county, at the expense of the county, with the  
11           board's requirement in writing to the county auditor to certify the fact concerning the  
12           mistake or the reason why the votes were not canvassed. The county auditor, to whom  
13           the requirement is delivered, shall make a true and full answer ~~thereto~~to the board  
14           under the county auditor's hand and official seal and shall deliver the answer with all  
15           convenient dispatch to the secretary of state.

16           **SECTION 101. AMENDMENT.** Section 16.1-15-42 of the North Dakota Century Code is  
17 amended and reenacted as follows:

18           **16.1-15-42. Certificate of result of general or special election by state canvassing**  
19 **board - Secretary of state to receive.**

20           The statements provided for in section 16.1-15-41 must be certified by the members of the  
21 state canvassing board, who shall subscribe their names to the statements. The board then

25 office receiving the highest number of votes must be duly elected to the office. ~~A person~~An  
26 individual who was entitled to have the ~~person's~~individual's name appear on the primary  
27 election ballot, but whose name was not placed on the primary election ballot, may not be  
28 elected to a no-party office as a write-in candidate unless ~~that person~~the individual receives a  
29 number of votes equal to or more than the number of signatures ~~which that~~ would have been  
30 required to have ~~that person's~~the individual's name placed on the primary election ballot.

1       **SECTION 102. AMENDMENT.** Section 16.1-15-43 of the North Dakota Century Code is

4       If a certificate of election cannot be issued for a judicial district office or a state office

7       **SECTION 103. AMENDMENT.** Section 16.1-15-45 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9       **16.1-15-45. Form of certificate of election for state officers - Signatures.**

10       A certificate of election must be prepared by the secretary of state for each ~~person~~individual  
11 elected to a state or a district office. The certificate must be signed by the governor and the  
12 secretary of state, have the great seal of the state affixed, and be attested by at least one of the  
13 other members of the state canvassing board. The certificate, in substance, must be in the  
14 following form:

23       **SECTION 104. AMENDMENT.** Section 16.1-15-47 of the North Dakota Century Code is  
24 amended and reenacted as follows:

25       **16.1-15-47. Certificate of election to member of Congress - Signing - Delivering.**

26       The certificate of election to a member of Congress must be signed by the governor with  
27 the great seal affixed and must be countersigned by the secretary of state. The governor shall  
28 cause the certificate to be delivered to the ~~person~~individual elected.

29       **SECTION 105. AMENDMENT.** Section 16.1-16-01 of the North Dakota Century Code is  
30 amended and reenacted as follows:

1       **16.1-16-01. Election recounts.**

2       A recount of any primary, special, or general election for nomination or election to a  
3 presidential, congressional, state, judicial district, multicounty district, legislative, county, or city  
4 office, or for the approval or disapproval of any measure, question, or bond issue submitted to  
5 the qualified electors of this state or one of its political subdivisions must be conducted  
6 according to guidelines established by the secretary of state and as follows:

7       1. A recount must be conducted when:

8           a. Any individual failed to be nominated by the individual's party or to a no-party  
9 office in a primary election by one percent or less of the highest vote cast for a  
10 candidate seeking nomination from the political party for the office sought or for a  
11 candidate for the no-party office sought.

12          b. Any individual failed to be elected in a general or special election by one-half of  
13 one percent or less of the highest vote cast for a candidate for that office.

14          c. A question, measure, or bond issue submitted to the qualified electors has been  
15 decided by a margin not exceeding one-fourth of one percent of the total vote  
16 cast for and against the question at any election.

17       2. A demand for a recount may be made by any of the following:

18           a. Any individual who failed to be nominated by the individual's party or to a  
19 no-party office in a primary election by more than one percent and less than two  
20 percent of the highest vote cast for a candidate seeking nomination from the  
21 political party for the office sought or for a candidate for the no-party office  
22 sought.

23          b. Any individual who failed to be elected in a general or special election by more  
24 than one-half of one percent and less than two percent of the highest vote cast  
25 for a candidate for that office.

26       3. A demand for a recount must be made within three days after the canvass of the votes  
27 by the county canvassing board in the case of county elections and city elections that  
28 are combined with the county and by the state canvassing board in the case of  
29 presidential, congressional, state, judicial district, multicounty district, or legislative  
30 elections. The demand must be in writing, must recite one of the conditions in  
31 subsection 2 as a basis for the recount, must contain a bond in an amount previously

1 established by the auditor or auditors doing the recount sufficient to pay the cost of the  
2 recount, and must be filed with:

3 a. The secretary of state when the recount is for a congressional, state, district, or  
4 legislative office.

5 b. The county auditor when the recount is for a county office or city office when a  
6 city election is combined with the county.

7 4. Within four days after the canvass of the votes by the state canvassing board in the  
8 case of presidential, congressional, state, judicial district, multicounty district, or  
9 legislative elections, the secretary of state shall notify all the county auditors to  
10 conduct recounts as required by subsection 1 and, when a timely recount demand is  
11 received and it is in proper form, as required by subsection 2. The secretary of state  
12 shall fix the date or dates of the recounts of legislative contests to be held within seven  
13 days after giving notice to the affected auditors that recounts must be conducted. The  
14 secretary of state shall fix the date or dates of the recounts of statewide races to be  
15 held within fourteen days after giving notice to the auditors that recounts must be  
16 conducted. Within four days after the canvass of votes by the county canvassing  
17 board or other political subdivision canvassing board, the county auditor or other  
18 political subdivision election official shall fix the date for recounts limited to the county,  
19 those cities within the county which combined the election with the county, or other  
20 political subdivision. The date must be within eight days after the canvass. In all  
21 recount proceedings, the county auditor or other election official, as appropriate, shall  
22 send notice of the date, place, and time of the recount to all candidates and petitioners  
23 involved by certified mail.

24 5. For recounts conducted by counties of federal, state, district, and county offices,  
25 measures, and questions, the county auditor must conduct the recount and may  
26 employ up to ten qualified electors of the county to assist in the recount. The county  
27 auditor shall review all properly cast ballots and associated records. The county  
28 auditor shall check the precinct count and the count of the county canvassing board. If  
29 the county auditor is a candidate involved in the recount, the county auditor is  
30 disqualified from acting thereon, and the county recorder shall perform the duties  
31 required of the county auditor by this section. For recounts conducted by political

1 subdivisions other than counties of local offices, measures, and questions, the election  
2 officer in a political subdivision shall administer a recount in the same manner as is  
3 required under this subsection for counties with respect to political subdivision offices,  
4 ballot measures, questions, or bond issues.

5 6. a. The individuals entitled to participate at the recount are:

6 (1) Each candidate involved in the recount, either personally or by a  
7 representative.

8 (2) A qualified elector favoring each side of a question if the recount involves a  
9 question or proposition submitted to a vote of the electorate.

10 b. The individuals allowed to participate may challenge the acceptance or exclusion  
11 of any ballot. The individual challenging a ballot must state the reason for the  
12 challenge based upon the law, and the county auditor or other political  
13 subdivision election official shall count the challenged ballot as the auditor or  
14 election official determines proper and then shall set the ballot aside with a  
15 notation that it was challenged and how it was counted.

16 7. At the conclusion of the recount, the county auditor or other election official shall  
17 submit all challenged ballots to the recount board for decision. Except for political  
18 subdivision recounts other than counties, the recount board must be composed of the  
19 state's attorney of the county, the chairman of the board of county commissioners, and  
20 the county recorder. Unless otherwise specified by law, for a political subdivision other  
21 than a county, the governing body of the political subdivision shall appoint the recount  
22 board. An individual may not serve on the recount board if the individual has anything  
23 of value bet or wagered on the result of the election, is a candidate for the office being  
24 recounted, or is the husband, wife, father, mother, father-in-law, mother-in-law, son,  
25 daughter, son-in-law, daughter-in-law, brother, or sister, whether by birth or marriage,  
26 of the whole or the half-blood, of any candidate involved in the recount. If any of the  
27 members of the recount board are disqualified or cannot serve for any other reason,  
28 the members of the board of county commissioners or other political subdivision  
29 governing body who would be qualified to serve on the board shall appoint  
30 disinterested qualified electors of the county or other political subdivision to serve as  
31 alternates. The recount board shall review all challenged ballots and on majority vote

1 shall decide how those ballots are counted. The decision of the recount board is final,  
2 subject to the right to contest the election as provided in this chapter. If during the  
3 recount a recess is called, the county auditor or other political subdivision election  
4 official shall take appropriate steps to safeguard the ballots.

5 8. The county auditor or other election official shall certify the results of the recount  
6 immediately after the recount. The recount result is the official result of the election in  
7 the county or other political subdivision. The county auditor or other election official  
8 shall prepare a corrected abstract of the votes. In a recount limited to the county, city,  
9 or other political subdivision, if the corrected abstract shows no change in the outcome  
10 of the election, no further action may be taken. If the corrected abstract changes the  
11 outcome of the election, the county auditor or other election official shall issue  
12 certificates of nomination or election accordingly and shall certify the new result of a  
13 question submitted to the qualified electors. In the case of a city election that is  
14 combined with a county election, the county auditor shall certify the new results of the  
15 election to the city auditor who is responsible for issuing new certificates of election if  
16 applicable.

17 9. In presidential, congressional, statewide, judicial district, multicounty district, or  
18 legislative recounts, the county auditor, immediately after the recount, shall submit  
19 electronically the corrected abstract to the secretary of state according to the  
20 instructions provided by the secretary of state. The secretary of state immediately shall  
21 assemble the state canvassing board, who shall canvass the corrected abstracts and  
22 certify the election results. The secretary of state shall issue certificates of election or  
23 nomination or record the approval or disapproval of a question submitted to the  
24 qualified electors accordingly.

25 10. The expenses incurred in a recount of a county election must be paid by the county on  
26 a warrant by the county auditor. The expenses incurred in a recount of a political  
27 subdivision other than a county election must be paid by that political subdivision. The  
28 expenses incurred in a recount of a city election must be paid by the city on a warrant  
29 by the city auditor. The expenses incurred in a recount of a presidential,  
30 congressional, state, judicial district, multicounty district, or legislative election must be  
31 paid by the state from the general fund upon approval by the secretary of state of a



1 statement of expenses received from the county auditors. The expenses incurred in a  
2 recount demanded under subsection 2 of section 16.1-16-01 must be paid by the  
3 secretary of state or county auditor from the bond submitted by the individual  
4 requesting the recount.

5 11. This section also applies to city elections that are not combined with the county except  
6 the city auditor, to the extent applicable, shall perform the duties of the county auditor.

7 **SECTION 106. AMENDMENT.** Section 16.1-16-02 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9 **16.1-16-02. Who may contest election.**

10 A defeated candidate or ten qualified electors may contest the nomination or election of any  
11 person or the approval or rejection of any question or proposition submitted to a vote of the  
12 electorate, pursuant to ~~chapters 16.1-04, 16.1-05, 16.1-06, 16.1-07, 16.1-08.1, 16.1-09,~~  
13 ~~16.1-10, and 16.1-11~~this title. In a county election to change the county seat or to change the  
14 boundaries of the county, the complaint must be filed against the board of county  
15 commissioners, ~~whewhich~~ shall appear and defend the contest action.

16 **SECTION 107. AMENDMENT.** Section 16.1-16-04 of the North Dakota Century Code is  
17 amended and reenacted as follows:

18 **16.1-16-04. Time for commencement of action.**

20 1. Except as provided in subsection 2, an action to contest an election must be  
21 commenced and the complaint must be filed in the district court of the contestee's  
22 county of residence within five days after final certification of a recount by the  
23 appropriate canvassing board or within fourteen days after the final certification by the  
24 appropriate canvassing board if no recount is to be conducted. ~~However, if~~

25 2. If the grounds for the action are the illegal payment of money or other valuable thing  
26 subsequent to the filing of any statement of expenses required by this title or if the  
27 contestee does not or cannot meet the qualifications to hold the office as required by  
28 law, the action may be commenced at any time. If the grounds for the action are the  
29 failure of a contestee to satisfy the requirements for having the contestee's name  
30 listed on the ballot as a candidate, the action may be commenced within thirty days of  
31 the date the contestant knows or should know of the failure.

1       3. The contestee shall serve and file an answer within fourteen days after service of the  
2           contest summons and complaint.

3       **SECTION 108. AMENDMENT.** Section 16.1-16-05 of the North Dakota Century Code is  
4 amended and reenacted as follows:

5       **16.1-16-05. Grounds for election contest.**

6       An election contest may be commenced for any of the following causes:

- 7       1. ~~If the~~The contestee does not or cannot meet the qualifications to hold the office as  
8           required by law.
- 9       2. ~~Because~~The existence of illegal votes or erroneous or fraudulent voting, count,  
10           canvass, or recount of votes.
- 11       3. The contestee was listed as a candidate on the ballot despite failing to meet the  
12           requirements to be listed on the ballot.

13       **SECTION 109. AMENDMENT.** Section 16.1-16-07 of the North Dakota Century Code is  
14 amended and reenacted as follows:

15       **16.1-16-07. Contest involving irregularity of ballots - Preservation of ballots.**

16       Either the contestant or the contestee, within the time provided by this title for the  
17 preservation of ballots, may give notice by certified mail to the county recorder of any county  
18 where the contestant or the contestee desires the ballots preserved, that an election contest is  
19 pending in a designated court. ~~Thereupon, it is the duty of~~After receipt of the notice, the county  
20 recorder ~~to shall~~ preserve all the paper ballots and ~~electronic voting system ballots and~~  
21 associated records until the contest has been finally determined or the retention period  
22 specified in section 16.1-15-13 has ended, whichever is later.

23       **SECTION 110.** A new section to chapter 54-09 of the North Dakota Century Code is created  
24 and enacted as follows:

25       **Criminal history record check.**

26       The secretary of state may require any employee who has access to personally identifying  
27 information of residents or businesses of the state, or access to election systems that are  
28 critical infrastructure under section 44-04-24, to submit to a statewide and nationwide criminal  
29 history record check. The criminal history record check must be conducted as provided by  
30 section 12-60-24.

1       **SECTION 111. REPEAL.** Sections 16.1-06-10.1, 16.1-07-11, 16.1-07-13, and 16.1-13-24 of  
2 the North Dakota Century Code are repealed.
