ENGROSSED HOUSE BILL NO. 1024

1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of
2 environmental quality; and to amend and reenact sections 23.1-10-02 and 23.1-10-05 of the
3 North Dakota Century Code, relating to the environmental quality restoration fund and revenue
4 to the fund.

5 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

6 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds
7 as may be necessary, are appropriated out of any moneys in the general fund in the state
8 treasury, not otherwise appropriated, and from special funds derived from federal funds and
9 other income, to the department of environmental quality for the purpose of defraying the
10 expenses of the department of environmental quality, for the biennium beginning July 1, 2023,
11 and ending June 30, 2025, as follows:

22 **SECTION 2. ONE-TIME FUNDING.** The following amounts reflect the one-time funding
23 items approved by the sixty-seventh legislative assembly for the 2021-23 biennium and the
24 2023-25 biennium one-time funding items included in the appropriation in section 1 of this Act:

10 The 2023-25 biennium one-time funding amounts are not a part of the entity's base budget
11 for the 2025-27 biennium. The department of environmental quality shall report to the
12 appropriations committees of the sixty-ninth legislative assembly on the use of this one-time
13 funding for the biennium beginning July 1, 2023, and ending June 30, 2025.

14 **SECTION 3. ESTIMATED INCOME - ENVIRONMENT AND RANGELAND PROTECTION**

15 **FUND.** The estimated income line item in section 1 of this Act includes the sum of \$250,000
16 from the environment and rangeland protection fund. This amount includes \$50,000 for a grant
17 to the North Dakota stockmen's association environmental services program.

18 **SECTION 4. ESTIMATED INCOME - PETROLEUM TANK RELEASE COMPENSATION**

19 **FUND.** The estimated income line item in section 1 of this Act includes the sum of \$742,080
20 from the petroleum tank release compensation fund for expenses related to the petroleum tank
21 release program.

22 **SECTION 5. AMENDMENT.** Section 23.1-10-02 of the North Dakota Century Code is
23 amended and reenacted as follows:

24 **23.1-10-02. Environmental quality restoration fund - Continuing appropriation.**

25 There is established an environmental quality restoration fund into which the funds
26 recovered in this chapter may be deposited. The fund is to be administered by the department
27 of environmental quality and may be used by the department for costs of environmental
28 assessment, removal, corrective action, or monitoring as determined on a case-by-case basis.
29 All moneys placed in the fund under this section and section 23.1-10-05 are appropriated to the
30 department on a continuing basis. If, on the first day of July in any year, the amount of
31 uncommitted or unrestricted money in the environmental quality restoration fund is more than

1 five million dollars, the amount in excess of five million dollars must be transferred to the
2 general fund.

3 **SECTION 6. AMENDMENT.** Section 23.1-10-05 of the North Dakota Century Code is
4 amended and reenacted as follows:

5 **23.1-10-05. Revenue to the fund.**

6 Revenue from the following sources must be deposited in the state treasury and credited to
7 the fund:

- 8 1. ~~If the balance of the fund is less than five million dollars, moneys~~Moneys recovered by
9 the department in an action or administrative proceeding based on violation of the
10 state's environmental statutes, including actions for administrative expense recoveries,
11 civil penalties, compensatory damages; and money paid pursuant to any agreement,
12 stipulation, or settlement. This section does not limit the department's ability to agree
13 to a supplemental environmental project as part of a settlement.
- 14 2. Moneys donated to the department for the purposes of this chapter.
- 15 3. Transfers from the abandoned oil and gas well plugging and site reclamation fund
16 under subdivision f of subsection 2 of section 38-08-04.5.
- 17 4. Moneys received from a federal agency for the purpose of this section.
- 18 5. Any other moneys as may be deposited in the fund for use in carrying out the
19 purposes of this chapter.
