## ENGROSSED HOUSE BILL NO. 1025

Introduced by

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the department of  
2 veterans' affairs; to provide an exemption; and to provide for a report.

3 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

4 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
5 as may be necessary, are appropriated out of any moneys in the general fund in the state  
6 treasury, not otherwise appropriated, and from special funds derived from federal funds and  
7 other income, to the department of veterans' affairs for the purpose of defraying the expenses of  
8 the department of veterans' affairs, for the biennium beginning July 1, 2023, and ending  
9 June 30, 2025, as follows:

22 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO**

23 **SIXTY-NINTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding

1 items approved by the sixty-seventh legislative assembly for the 2021-23 biennium and the  
2 one-time funding items included in the appropriation in section 1 of this Act:

13 The 2023-25 biennium one-time funding amounts are not a part of the entity's base budget  
14 for the 2025-27 biennium. The department of veterans' affairs shall report to the appropriations  
15 committees of the sixty-ninth legislative assembly on the use of this one-time funding for the  
16 biennium beginning July 1, 2023, and ending June 30, 2025.

17 **SECTION 3. EXEMPTION - POSTTRAUMATIC STRESS DISORDER SERVICE DOG**  
18 **PROGRAM.** The \$50,000 appropriated from the general fund for the posttraumatic stress  
19 disorder service dog program in section 1 of chapter 25 of the 2019 Session Laws and the  
20 \$50,000 appropriated from the general fund for the posttraumatic stress disorder service dog  
21 program in section 1 of chapter 53 of the 2021 Session Laws is not subject to section  
22 54-44.1-11 and any unspent funds from this program are available for the program during the  
23 biennium beginning July 1, 2023, and ending June 30, 2025.

24 **SECTION 4. EXEMPTION - FEDERAL STATE FISCAL RECOVERY FUND.** The \$647,000  
25 appropriated from the federal state fiscal recovery fund in subsections 32 and 33 of section 1 of  
26 chapter 550 of the 2021 Session Laws, of which \$500,000 was for a grant to assist in the  
27 construction of the Fisher house at the Fargo veterans' affairs medical center and \$147,000 was  
28 for improving and expanding veterans' medical transportation, is not subject to section  
29 54-44.1-11 and any unspent funds from these programs are available for the programs during  
30 the biennium beginning July 1, 2023, and ending June 30, 2025.
