**ENGROSSED SENATE BILL NO. 2005**

Appropriations Committee

1 A BILL for an Act to provide an appropriation for defraying the expenses of the state treasurer;  
2 and to amend and reenact section 54-11-13 of the North Dakota Century Code, relating to the  
3 salary of the state treasurer.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION.** The funds provided in this section, or so much of the funds  
6 as may be necessary, are appropriated out of any moneys in the general fund in the state  
7 treasury, not otherwise appropriated, to the state treasurer for the purpose of defraying the  
8 expenses of the state treasurer, for the biennium beginning July 1, 2023, and ending June 30,  
9 2025, as follows:

17 **SECTION 2. ONE-TIME FUNDING - EFFECT ON BASE BUDGET - REPORT TO THE**  
18 **SIXTY-NINTH LEGISLATIVE ASSEMBLY.** The following amounts reflect the one-time funding  
19 items approved by the sixty-seventh legislative assembly for the 2021-23 biennium and the  
20 2023-25 biennium one-time funding items included in the appropriation in section 1 of this Act:

3       The 2023-25 biennium one-time funding amounts are not a part of the entities base budget  
4 for the 2025-27 biennium. The state treasurer shall report to the appropriations committees of  
5 the sixty-ninth legislative assembly on the use of this one-time funding for the biennium  
6 beginning July 1, 2023, and ending June 30, 2025.

7       **SECTION 3. AMENDMENT.** Section 54-11-13 of the North Dakota Century Code is  
8 amended and reenacted as follows:

9       **54-11-13. Salary of state treasurer.**

10       The annual salary of the state treasurer is one hundred ~~twelve~~nineteen thousand ~~two~~  
11 ~~hundred forty-one~~sixty-five dollars through June 30, ~~2022~~2024, and one hundred  
12 ~~fourteen~~twenty-three thousand ~~four~~eight hundred ~~eighty-six~~twenty-eight dollars thereafter.
