The Senate convened at 1:00 p.m., with President Miller presiding.

The prayer was offered by Reverend Sylvia Bull, Faith Lutheran Church, Bismarck.

The roll was called and all members were present.

A quorum was declared by the President.

POINT OF PERSONAL PRIVILEGE

SEN. MEYER rose on a point of personal privilege.

REMARKS OF SENATOR MEYER

MADAM PRESIDENT: Madam President, your Senate team brought back the Capitol Classic cup today!

It was a great event, a tournament that was sponsored by the Special Olympics.

A lot of money was raised, and I don't know if the Senate has won this before, but I can tell you, we have never won it since I have been here, but we have it now.

The first round we played the House Democrats, some would call it an exhibition match because it was pretty ugly. We took care of business.

Second round we played some lobbyists and interns. I might have said that if you want a job after this, you had better lose; but we did take care of them.

The final game, the Championship match, we snatched the victory from the jaws of defeat against the House Republicans. Now we hold this trophy in the Senate for the next two years and it's great.

The most important thing though, Madam President, is that we raised twenty-one thousand dollars for the Special Olympics. Se we should be proud of that!

REMARKS OF SENATOR BURCKHARD

MADAM PRESIDENT: The Beavers are National Champions once again!

Madam President, the Minot State University Beavers are national champions once again. One goal in the second period and 19 saves by goalie Jake Anthony proved to be just enough and the No. 1 Minot State men's hockey team held on to beat No. 3 Adrian (Michigan), claiming the third ACHA Division 1 National Championship in program history.

Head coach Wyatt Waselenchuk has been part of all three Minot State National Championships, winning one as a goalie, one as an assistant coach and now a third as a head coach. He said "I could not be more proud of these young men. They earned every inch."

Josh Pederson scored the loan goal of the title game with 2 minutes, 25 seconds left in the second period, giving the Beavers (35-3-0 overall) all the offense they needed as Anthony turned aside all 19 shots by the Bulldogs, sealing the win.

Minot State marched to the title game with four straight wins, with two of the final three ending in overtime fashion.

Madam President, the Beavers claimed their third National Championship with a thrilling 1-0 victory, adding to their 2019 and 2013 National titles.

Minot State's senior captain, Davis Sheldon, was named tournament MVP.

Madam President, this proves once again that Magic Town,, Hockey Town is Title Town once again.

**REMARKS OF MACI WEHRI, 2022 NATIONAL MISS AGRICULTURE USA
MARCH 23, 2023**

Thank you, Madam President, Leaders Hogue and Hogan, and members of the Senate. I am so privileged and honored to be standing here today. As stated, my name is Maci Wehri and I am a student at Dickinson State University studying English Literature and Theatre and previously held the title of 2022 North Dakota Miss Agriculture USA before competing last June in Ohio for the title of 2022 National Miss Agriculture USA which I now hold.

I know that all of you may be looking up at me right now and are just seeing a 20 year old girl with a sparkly crown on her head and a sash across her chest, but the Miss Agriculture USA organization is much more than just a beauty pageant or a competition to see who knows the most about the agriculture in their state, although knowing about agriculture does help quite a bit. Miss Agriculture USA is a nonprofit organization which helps women with public speaking skills, growing their confidence, and overall showing the female side of a predominately male agriculture workforce.

I was first introduced to the organization in the summer of 2021 when I was casually scrolling through Instagram. After my freshman year of college, I began to miss my connection with agriculture. I had spent my whole junior high and high school years in FFA and working on the ranch, then all of a sudden was thrown into classes talking about Fitzgerald and Joyce, with no talk of agriculture in my everyday life except for the weekly phone calls with my dad. I was searching for a way to get back in touch with my roots, and found it in Miss Agriculture USA.

After a couple weeks of consistent begging with my parents, they relented, and I signed up. I never would have imagined the places it would take me. Growing up raising Gelbvieh cattle, I knew a good amount about the importance of agriculture in my life, but it wasn't until I got into college and especially into this organization that I truly understood how vital it is for everyday life.

According to a study done by North Dakota State University, agriculture represents 20-25% of the state's economy and one out of every five jobs in the state is supported by agriculture. Every single person in this room survives off the food that is put on their table because of the farmers and ranchers in the United States. I am more than happy to be able to say that I grew up in a state that was so agriculturally advanced that we are able to be number one in the country in eight categories of crops including edible beans, canola, flaxseed, honey, rye, sunflowers, and wheat. And if we aren't coming in first in the crop, we are ranked in the top ten over twenty times for other agricultural products such as sugar beets, bison, potatoes, and cattle. According to the USDA, North Dakota contributes 30 billion dollars to the United States economy.

Now that is all well and good, but what I want to accomplish as 2022 National Miss Agriculture USA is helping to make sure that we can keep those numbers going up by encouraging farm safety to not only the farmers in North Dakota, but also nationally.

In 2013 when I was ten years old, my brother Michael passed away in a farming accident. He was 19 years old. Although he was certified in everything that he could have been and loved reading the user manual for any and every piece of equipment that he stepped foot into, he made one small mistake, and it cost his life. I have spent the last 10 years trying to figure out why something like that had to happen to my big brother, to my hero, to my family, and it was only once I had the crown and sash that I figured out what God's plan was for me. I realized that if I went out into the fields, went into the school systems, talked to community members about what it meant to stay safe on a farm or ranch, maybe my brother's life wouldn't have been lost in vain.

Farmers are truly our nation's most important natural resource, and we need to advocate and protect them as much as we can. If there was one person that I had talked to that thought twice about sticking their hand over a running PTO shaft or stepping out of a cab of a sprayer after they had been struck by an overhead powerline, maybe I could make him proud. I hope with all my heart that by standing here today, shaking in my heels and wobbly knees that I have made Michael proud.

Thank you to the North Dakota state legislature for funding an Extension Farm Safety Specialist at NDSU. Angie Johnson's role is so vitally important to the farmers and ranchers in our state and nationwide. With the Large extension network throughout the state, I am confident we can make farms and ranches not only a great place to live and work, but also a safe place.

Thank you to everyone sitting here today and those of you who worked to get me here for National Ag Week. This is an experience I will never forget, and I appreciate you all immensely.

STATEMENT OF PURPOSE OF AMENDMENT

This amendment reduces the transfer from the strategic investment and improvements fund to the bulk propane storage tank revolving loan fund from \$15 million to \$5 million and makes technical corrections to the bill.

- (2)b. Transportation network company insurance maintained by a transportation network company.
- (3)c. Any combination of ~~paragraphs 1 and 2~~subdivisions a and b.
- b-2. Transportation network company insurance coverage provided under this section for uninsured motorist coverage must meet the requirements under section 26.1-40-15.2, which is primary coverage.
- e-3. Transportation network company insurance coverage provided under this section for underinsured motorist coverage must meet the requirements under section 26.1-40-15.3, which is primary coverage.
- d-4. Transportation network company insurance coverage must provide primary personal injury protection to drivers, passengers, and pedestrians under chapter 26.1-41.
- e-5. The primary insurer, in the case of insurance coverage provided under ~~subdivision a~~subsection 1, has the sole duty to defend and indemnify the insured.
- f-6. Coverage under a transportation network company insurance policy may neither be dependent on a driver's personal automobile insurance policy carrier first denying a claim nor a personal automobile insurance policy carrier being required to first deny a claim.
- g-7. If transportation network company insurance maintained by a participating driver to fulfill the insurance obligations of this section has excluded coverage according to its policy or ceased to exist, the transportation network company shall provide the coverage required by this section beginning with the first dollar of a claim.

SECTION 3. AMENDMENT. Subsection 1 of section 26.1-40.1-04 of the North Dakota Century Code is amended and reenacted as follows:

1. During the application on stage and during the engaged stage, the transportation network company insurance must include:
 - a. Motor vehicle liability coverage that is primary coverage. The coverage must include at least fifty thousand dollars per person and one hundred thousand dollars per incident for death and bodily injury and at least twenty-five thousand dollars for property damage.
 - b. Uninsured motorist coverage under section 26.1-40-15.2 which is primary coverage.
 - c. Underinsured motorist coverage under section 26.1-40-15.3 which is primary coverage.
 - d. Personal injury protection under chapter 26.1-41 which is primary coverage."
