- (2) For the development of publicly owned land adversely affected by oil and gas development including related pipelines and facilities.
- (3) For administrative expenses and cost in developing an abandoned site reclamation plan and the program.
- (4) Demonstration projects for the development of reclamation and water quality control program methods and techniques for oil and gas development, including related pipelines and facilities.
- f. For transfer by the office of management and budget, upon request of the industrial commission, to the environmental quality restoration fund for use by the department of environmental quality for the purposes provided under chapter 23.1-10, if to address environmental emergencies relating to oil and natural gas development, including the disposal of oilfield waste and oil or natural gas production and transportation by rail, road, or pipeline.
