1 A BILL for an Act to provide an appropriation to the office of the governor for salaries and
2 wages; to provide an appropriation to the adjutant general for 2021-23 snow removal grants; to
3 provide for retroactive application; and to provide an effective date.

4 **BE IT ENACTED BY THE LEGISLATIVE ASSEMBLY OF NORTH DAKOTA:**

5 **SECTION 1. APPROPRIATION - 2021-23 BIENNIUM - OFFICE OF THE GOVERNOR.**

6 There is appropriated from special funds derived from federal funds or other income, not
7 otherwise appropriated, the sum of \$6,500, or so much of the sum as may be necessary, to the
8 office of the governor for the salaries and wages line item for the period beginning May 10,
9 2023, and ending June 30, 2023.

10 **SECTION 2. APPROPRIATION - ADJUTANT GENERAL - 2021-23 SNOW REMOVAL**
11 **GRANTS - EXTENSION.**

- 12 1. There is appropriated out of any moneys in the general fund in the state treasury, not
13 otherwise appropriated, the sum of \$106,000, or so much of the sum as may be
14 necessary, to the adjutant general for the purpose of providing additional 2021-23
15 snow removal grants to tribal governments, counties, cities, and townships, for the
16 period beginning with the effective date of this Act and ending June 30, 2025.
- 17 2. A tribal government, county, township, or city that did not receive a snow removal
18 grant during the 2021-23 biennium and submitted its application and required
19 documentation for a 2021-23 snow removal grant to the department of emergency
20 services prior to October 20, 2023, is eligible for a grant under this section. The
21 department of emergency services shall provide an early season snow removal grant
22 to an eligible entity under this section for reimbursement of up to sixty percent of the
23 snow removal costs incurred by the tribal government, county, city, or township for the
24 period of October 1, 2022, through December 31, 2022, which exceeded one hundred

1 fifty percent of the average snow removal cost for the three-month period of October
2 through December for the four lowest cost years during the years 2017 through 2021;
3 and a full season emergency snow removal grant to an eligible entity under this
4 section for reimbursement of up to sixty percent of the snow removal costs incurred by
5 the tribal government, county, city, or township for the period of October 1, 2022,
6 through April 30, 2023, which exceeded one hundred fifty percent of the average snow
7 removal cost for the seven-month period of October to April for the four lowest cost
8 years for those years during the period beginning October 1, 2017, through April 30,
9 2022.

10 **SECTION 3. RETROACTIVE APPLICATION.** Section 1 of this Act and Senate Bill
11 No. 2024, as approved by the sixty-eighth legislative assembly, apply retroactively to May 10,
12 2023.

13 **SECTION 4. EFFECTIVE DATE.** This Act becomes effective immediately upon its filing with
14 the secretary of state.
