Statutory provisions that relate to this request:

Title IV, Part A of the Elementary and Secondary Education Act of 1965 (ESEA) purpose is to improve students' academic achievement by increasing the capacity of States, local educational agencies, schools, and local communities to— (1) provide all students with access to a well-rounded education; (2) improve school conditions for student learning; and (3) improve the use of technology in order to improve the academic achievement and digital literacy of all students.

The Stronger Connections Grant funds are supplemental funds for Title IV, Part A for which the SEAs must award 95% competitively to high-need local educational agencies (LEAs) to fund activities allowable under section 4108[20U.S.C. 7118] of the ESEA, specifically addressing providing students with safer and healthier learning environments.

Provide an explanation as to how the request supports state priorities, improves state efficiencies, and promotes effective state government:

The Stronger Connections Grant Funds align with the K-12 Strategic Vision and Choice Ready (accountability component for ESEA) by providing districts with the necessary funds to meet the identified long-term outcomes for North Dakota students.

The Stronger Connections Grant are supplemental funds under Title IV, Part A that focus on safe, inclusive, and supportive learning environments. These learning environments lead to improved academic achievement and emotional well-being of students, as well as reductions in disciplinary actions. Other examples of inclusive learning environments include culturally and linguistically-responsive practices where students are surrounded by adults they can trust and who are committed to building strong relationships. Environments like these also help build connections that make students less likely to bring weapons to school and more likely to report the presence of weapons in school.
