My name is James Pursley, and I am submitting written testimony on behalf of the North Dakota Travel Alliance Partnership. TAP is a coalition of travel industry stakeholders, including CVBs, state attractions, businesses and recreation providers in North Dakota's third-largest industry and major driver of North Dakota's growing economy. On behalf of the tourism industry and its partners, I am asking for your support for HB 1209.

HB 1209 is a one-time funding item that will provide a grant to an organization dedicated to the restoration of historic opera houses in North Dakota. Restoring historic structures like opera houses improves downtown areas and increases visitation to North Dakota towns and cities.
