Testimony in Support of Senate Bill 2227

Mark A. Strand

Fargo, ND

January 20, 2023

The North Dakota Health Council is a state body that informs and advises the Department of Health and Human Services (NDDHHS), and the State Health Officer, about the health concerns and priorities of the citizens of North Dakota. The members are comprised of representatives of stakeholder groups and citizen groups who understand the needs of the people of North Dakota and can provide critical input to the NDDHHS and the state health officer.

In 1999 North Dakota was the healthiest state in the nation, reported by America's Health Rankings. We have since slipped to 18th. As a proud North Dakota native, currently working every day to serve the health of the people of North Dakota, I want to see us reclaim our ranking. In order to do this, several efforts are paramount:

1. We need to improve the engagement of stakeholders and citizen groups with this challenge. During our recent COVID-19 pandemic, one of the most important lessons learned was that input from stakeholders, community leaders and frontline public health workers was lacking and that timely and transparent communication was insufficient. The redesigning of the health council as proposed in this bill and increasing the size and breadth of the membership of the North Dakota Health Council will address this problem.
2. We need to establish a strategic plan for improved population health and entrust the NDDHHS with the responsibility of monitoring progress toward this strategic plan. The new roles of the North Dakota Health Council as designed in this bill will be expanded and will be more attentive to the strategic plan and programs of the Health Division of the Department of Health and Human Services.
3. We need to establish baseline population health benchmarks, and then evaluate policies and funding toward the purpose of meeting the population health goals established upon those benchmarks. We cannot become the healthiest state in the nation by improving the clinical services that insured persons receive. We can only become the healthiest state in the nation by focusing on improving the health of everyone in the state. This is the mission of the health council.

It is my opinion that SB 2227 will revitalize the health council, will bring to the table a wider representation of stakeholders and citizen representatives, and give the health council roles that are essential for seeing North Dakota once again be the healthiest state in the nation.

Senate Bill 2227**Senator Judy Lee**

SB 2227 updates and restores the responsibilities and membership of the State Health Council. It has, in recent years, not been as engaged in the responsibilities which had long been assigned to them, such as collaborating with various health officials and providers on developing rules which would have input from diverse stakeholders to assure that rules would be effective and workable.

The advisory role has been diminished to the point that all that remained was approving the recipients of loan repayment for health professionals. That led to a discussion in the Health Council of dissolving, because they no longer had much to do.

A small group of individuals from various health professions, some of whom had been are currently on the Health Council, met legislators to discuss the future of the Health Council. The consensus was that it was worth the effort to try to restore the activities of the Health Council and provide support for the State Health Officer in moving forward with the functions necessary for the Health Division. Meetings were held to plan and prepare the recommendations which you see in the bill before you.

Section 1 states the purpose of the Health Council and changes the membership to statutory categories, rather than appointed positions. It was designed to be similar to the Medical School Advisory Council which is very engaged in communications with the dean, faculty, and staff to provide input from the citizen members and support for their programs.

You will see on page 2 the list of members representing tribal health, research universities, public health, medical and long term care facilities, recommended by groups which represent them.

Reimbursement is spelled out in #6 on page 3.

Section 2 lists the powers and duties, which have been updated to say "collaborate and support", rather than "establish and enforce". They will not have and have not had enforcement authority. They can hear matters dealing with licenses of hospitals, as well as construction. It also describes its role in advising the Governor, DHHS, legislative assembly, and citizens about important issues.

The informal group worked very collaboratively on updating this statute so that it is workable in today's world and will be a positive partner for the State Health Officer in leading the public health efforts in ND.

I support SB 2227 as an important update for an existing entity to provide support and information for the Division of Health, other public officials, and the citizens of North Dakota. I encourage your support, too.

Chairman Weisz and members of the House Human Services Committee, I am Tim Blasl, President of the North Dakota Hospital Association (NDHA). I testify in support of Senate Bill 2227 and ask that you give the bill a **Do Pass** recommendation.

This bill restores and updates the duties and membership of the State Health Council. We believe the bill will ensure the Council is a positive partner for the State Health Officer in leading public health efforts in North Dakota. The Council would collaborate with various health officials and providers to advise the state on best public health practices and respond to public health emergencies. It ensures the coordination of the Department of Health and Human Services' health division with all other health activities of the state. And the makeup of the Council would ensure there is input from diverse stakeholders, such as tribal health, research universities, public health, and medical and long-term care facilities, so that rules which are necessary for public health would be effective and workable.

The bill clarifies that the Council would "collaborate and support", rather than "establish and enforce". In other words, it would have no enforcement authority. We support the Council as a diverse and deliberative body to inform and advise the governor, department of health and human services, legislative assembly, and North Dakotans on public health issues that are important to the needs of North Dakotans, and in the event of a public health emergency. We also support the Council's role in making recommendations for, and monitoring progress on, the state public health strategic plan and advocating for evidence-based practices and policies necessary to improve the health of North Dakotans.

NDHA requests that you give the bill a **DO PASS** recommendation. Thank you.
