

## BUDGET SECTION DUTIES AND RESPONSIBILITIES FOR THE 2005-07 BIENNIUM - YEAR ENACTED AND BUDGET SECTION ACTION SINCE ENACTMENT

The following table lists 70 statutory duties and responsibilities assigned to the Budget Section for the 2005-07 biennium by North Dakota Century Code (NDCC), Session Laws, or Legislative Council directive. The duties are listed in three categories--duties that have not been acted on, duties that have been acted on, and new duties.

\* Indicates interims when the duty or responsibility was acted on by the Budget Section.
